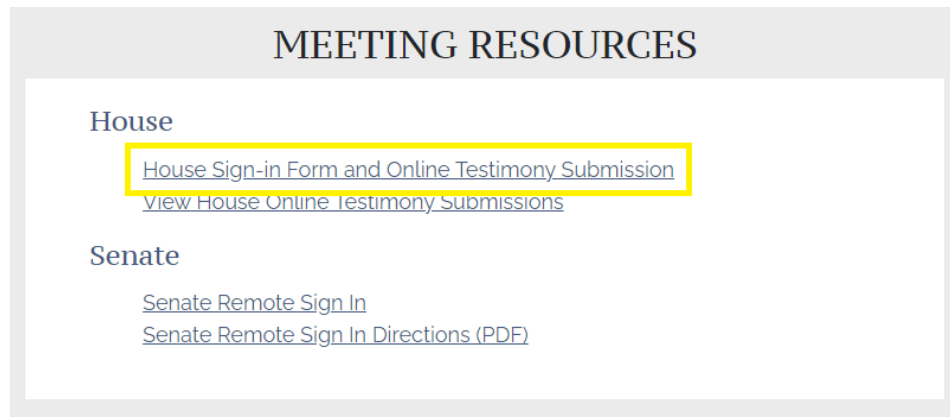

### How to register support/opposition on a bill/Submit Testimony online:

Navigate to *MEETING RESOURCES* found on the bottom right side of the home page. Then click on *House Sign-In Form and Online Testimony Submission*.



### Follow all prompts and fill in the required fields on this form:

1. Step 1 – Personal Information
2. Step 2 – Select Date of Hearing (please note, if there is no hearing scheduled, you will not be able to sign in)
3. Step 3 – Select a Bill
  - a. Select the Committee (select the committee from the drop-down menu)
  - b. Choose the Bill (select the bill from the drop-down menu)
  - c. I am (select an option from the drop-down menu)
  - d. I'm Representing (this must be filled in manually)
  - e. Indicate Your Position on this Bill (choose your position)
4. Step 4 – Upload Remote Testimony (Optional) \*files must be in PDF format
5. Step 5 – Final Review, if satisfied, hit 'Submit'
