Rep. McGuire moved that the Committee recommend to the Acting Director of the Office of Legislative Services that former rules Pos 600, Pos 700, Pos 800, Pos 900, and Pos 1600 be deemed repealed by the legislature pursuant to 2011, 224:125, IX and X.

Rep. McGuire moved that the Committee recommend to the Acting Director of the Office of Legislative Services that the expiration dates for rules Pos 1000, Pos 1100, and Pos 1200 be deemed suspended (stayed) pursuant to 2011, 224:149, III.
