### **Action Minutes**

- 1. The meeting was convened at 9:00 a.m. by Sen. Reagan as Chair.

Members present at this time, aside from Sen. Reagan, were Sen. Cataldo and Reps. Schmidt, MacKay, Ladd, Kidder, and Barry.

Sen. Reagan designated Rep. Kidder and Rep. Barry as alternates, respectively, for Rep. McGuire and Sen. Rausch, who were absent, and designated that Rep. Hatch would be an alternate for Rep. Sad when he arrives, since Rep. Sad was also absent.

2. The Committee discussed the minutes of the Committee meeting on December 5, 2013.

Rep. Schmidt moved that the minutes be approved.
