Feltes moved that the Committee conditionally approve Final Proposal 2015-165 based on the request, with the understanding that editorial comments, as well as clarity issues on p. 3 and p. 21 relative to changing "may", to "shall", by the Committee Attorney would be addressed in the conditional approval response.

The Committee discussed Final Proposal 2015-167 from the Department of Labor (Workers' Compensation Insurance Coverage).

The Department had submitted a conditional approval request in a letter dated February 17, 2016 and amended rule dated February 16, 2016.

Rep. Sad moved that the Committee conditionally approve Final Proposal 2015-167 based on the request.

 The Committee discussed Final Proposal 2015-168 from the Department of Labor (Workers' Compensation Self Insurance). Martin Jenkins testified for the Department.

The Department had submitted a conditional approval request in a letter and amended rule dated February 16, 2016.

Rep. Schmidt moved that the Committee accept the conditional approval request and conditionally approve Final Proposal 2015-168 based on the request, with the recommendation that the Department would seek legislative changes to its rulemaking authority in RSA 281-A:60 to clarify that the Department does have the authority to create rules related to RSA 281-A:5 and RSA 281-A:5-a.

Michael Somers, representing the N.H. Lodging and Restaurant Association, also testified.

It was the consensus of the Committee to postpone action on Final Proposal 2015-181 until the next Committee meeting.

Sen. Reagan moved that the Committee approve Proposed Interim Rule INT 2016-2.

The Board had submitted a conditional approval request in an amended rule dated February 3, 2016.

Sen. Feltes moved that the Committee conditionally approve Final Proposal 2015-208 based on the Request.

15. The Committee discussed again Proposed Interim Rule INT 2015-14 from the Department of Safety (Interim Certification for Additional Truck Weights Rules). David Hilts and State Police Captain William Haynes testified for the Department.

It was the consensus of the Committee that Committee staff should prepare a letter from the Committee to the Governor to acquaint her with the issue of overweight vehicles under Federal law in New Hampshire, the competitive disadvantage faced by N.H. truckers who are limited to lower weights than in Maine and Vermont, and the need for changes in Federal law.

Sen. Feltes moved that the Committee approve Proposed Interim Rule INT 2015-14.

Rep. Schmidt seconded.

Adopted. It was noted for the record that Sen. Reagan voted "no".

 The Committee briefly discussed Final Proposal 2015-206 from the Fish and Game Department (Limited Bobcat Season), which had not yet been filed.

It was the consensus of the Committee that, if the Final Proposal is filed by March 4, 2016, the deadline under RSA 541-A:12, I for filing for placement on the agenda of the regular meeting of March 18, 2016, then the Final Proposal would be heard at the continued meeting on April 1, 2016.

 The Committee adjourned by consensus at 10:06 a.m., and cancelled the continued meeting scheduled for March 4, 2016.
