Action Minutes

MAY 3, 2013

Members Present: Senators Reagan, Rausch, Cataldo, and Watters, and Representatives Schmidt, McGuire, Sad, and Kidder*. (*) Indicates alternate member.

(**) Part 1, Article 28-a of the N.H. Constitution was not an issue in the Committee's discussions or decisions in this meeting.

1. The meeting was convened at 9:03 a.m. by Sen. Reagan as Chair.

Members present at this time, aside from Sen. Reagan, were Sens. Rausch, Cataldo, and Watters, and Reps. McGuire, Kidder, and Sad.

2. The Committee discussed whether to postpone action on certain items to another meeting.

No action to postpone was made at this time.

3. The Committee discussed the minutes of the Committee meeting on April 19, 2013.

Rep. McGuire moved that the minutes be approved.

Sen. Watters seconded.

Adopted.

Sen. Reagan designated Rep. Kidder as an alternate for Rep. Ladd, who was absent.

4. The Committee discussed Final Proposal 2013-20 from the Department of Revenue Administration (Business Enterprise Tax Estimates). Kathryn Skouteris, Revenue Counsel, testified for the Department.

Rep. McGuire moved that the Committee approve Final Proposal 2013-20.

Sen. Rausch seconded.

Adopted.

Rep. Schmidt arrived at this time.

5. The Committee discussed Final Proposal 2012-148 from the Passenger Tramway Safety Board (Various Passenger Tramway Safety Rules). David Hilts of the Department of Safety testified for the Board.

Rep. McGuire moved that the Committee make a preliminary objection to Final Proposal 2012-148 on the ground as outlined in the annotations by Committee staff to Pas 305.05(c).

Rep. Schmidt seconded.

Adopted.

6. The Committee discussed Final Proposal 2012-202 from the Department of Employment Security (Employer Requirements, Quarterly Reports, Authorized Agents, Filing Requirements).

The Department had submitted a conditional approval request in a letter dated April 17, 2013 and amended rule dated April 15, 2013 and an amended conditional approval request in a letter and further amended rule dated May 2, 2013.

Sen. Rausch moved that the Committee accept the amended conditional approval request and conditionally approve Final Proposal 2012-202 based on the request.

Rep. Schmidt seconded.

Adopted.

7. The Committee discussed the following Final Proposals from the Department of Health and Human Services:

FP 2013-2 Former Division of Human Services
Aid to the Permanently and Totally Disabled (APTD) Cash Assistance Grant Criteria

FP 2013-15 Former Division of Human Services
Household Composition of Shared Custody of Children in the Food Stamp Program
(*JLCAR Deadline May 20, 2013.*)

Rep. Schmidt moved that the Committee postpone action on these Final Proposals to the regular Committee meeting on May 17, 2013.

Rep. McGuire seconded.

Adopted.
