# **JUNE 15, 2018**

- 1. The meeting was convened at 9:04 a.m. by Sen. Reagan as Chair.

Members present at this time, aside from Sen. Reagan, were Sens. Feltes, French, and Ward, and Reps. McGuire, Schmidt, Hatch, Wolf, and Matthews.

Debra McCann testified briefly about Final Proposal 2018-54 from the Office of Strategic Initiatives (Governor's Scholarship Program).

The motion was adopted.

3. The Committee discussed the minutes of the Committee meeting on May 18, 2018.

Rep. McGuire moved that the minutes be approved.

Rep. Schmidt seconded.

Adopted.

4. The Committee discussed Final Proposal 2017-163 from the Public Utilities Commission (Utility Pole Attachment Rules). David Wiesner testified for the Commission.

The Commission had submitted a conditional approval request in a letter and amended rules dated June 13, 2018.

Sen. Feltes moved that the Committee conditionally approve Final Proposal 2017-163 based on the request.

Rep. Schmidt seconded.

Susan Geiger, representing Comcast NBCU and New England Cable and Telecommunications Association, Inc., (NECTA), testified briefly and had previously submitted written testimony.

5. The Committee discussed Proposed Interim Rule INT 2018-11 from the N.H. Veterans' Home (Home). Margaret LaBrecque, Commandant, testified for the Home.

Sen. Feltes moved that the Committee approver Proposed Interim Rule INT 2018-11.

Sen. French seconded.

Adopted.

Sen. Reagan noted for the record that Rep. McGuire voted "no".

6. The Committee discussed Proposed Interim Rule INT 2018-12 from the N.H. Veterans' Home (Home). Margaret LeBrecque, Commandant, testified for the Home.

Sen. Kahn and Sen. Avard arrived during the discussion of this item. Sen. Ward therefore was no longer a voting member.

Sen. Feltes moved that the Committee approve Proposed Interim Rule INT 2018-12.

Rep. Hatch seconded.

Adopted.

Sen. Reagan noted for the record that Rep. McGuire voted "no".

7. The Committee discussed Proposed Interim Rule INT 2018-15 from the Department of Health and Human Services (Former Division of Mental Health and Developmental Services, Family Support Services). David Newton testified for the Department.

Sen. Feltes moved that the Committee approve Proposed Interim Rule INT 2018-15 with the understanding that the Department, as indicated by Mr. Newton, would address in regular rulemaking the comments in the annotations by Committee staff to the Proposed Interim Rule.

Adopted.

8. The Committee discussed Final Proposal 2017-181 from the Fish and Game Department (Agency Action Against Holders of Licenses, Registrations, and Permits). Paul Sanderson testified for the Department.

Sen Feltes moved that the Committee approve Final Proposal 2017-181.

Sen. Avard seconded.

Adopted.

9. The Committee discussed Final Proposal 2018-33 from the Fish and Game Department (Off Highway Recreation Vehicles and Snowmobiles). Paul Sanderson testified for the Department.

Hatch moved that the Committee make a preliminary objection to Final Proposal 2018-39 on the ground that the Final Proposal is contrary to the public interest because the Department had failed to consider fully all public comment pursuant to RSA 541-A:11, and recommended that the Department hold another rulemaking hearing and work with Committee staff to ensure that all public comments submitted to the Committee are considered.

Rep. Schmidt seconded.

Adopted.

11. The Committee discussed RSA 200:29 on school nurses in relation to Final Proposal 2017-53 from the Board of Education, which the Committee had conditionally approved on September 21, 2017.
