Questions were asked on excess appropriations for Pediatric Mental Health Care and whether this included the Children's Mobile Crisis project, which it did not, and excess appropriations for Children's Behavioral Health, and Community Mental Health Program Support, to which the Department responded.

The Department also responded to questions regarding the New Hampshire Designated Receiving Facility and confirmed there is one individual still there with a core group of staff providing care, which is a reduction in staffing.
