AN ACT                   relative to duplicate registrations for snowmobiles.

*Be it Enacted by the Senate and House of Representatives in General Court convened:*

1           1 New Section; Snowmobiles; Duplicate Registrations. Amend RSA 215-C by inserting after  
2 section 38 the following new section:

3           215-C:38-a Duplicate Registration. A registration certificate which is lost, stolen, mutilated, or  
4 destroyed may be replaced by a duplicate registration, upon payment of a fee of \$5 and completion of  
5 an affidavit setting forth the circumstances of the loss or destruction of the registration. The duplicate  
6 registration shall entitle the registrant to engage in all activities permitted on the original registration.  
7 All fees collected under this section for duplicate registrations shall be nonlapsing and continually  
8 appropriated to the fish and game department for the purposes described in RSA 215-C:39, IX.

9           2 Effective Date. This act shall take effect 60 days after its passage.

**House Fish and Game and Marine Resources Committee  
January 19, 2010**

Good morning Mr. Chair and members of the Committee. For the record my name is Timothy Acerno and I am the Assistant Chief of Law Enforcement for the Fish and Game Department. I am also the OHRV and Snowmobile Program Coordinator with respect to Law Enforcement and Safety Education. The Department requested this bill and the Fish and Game Commission voted to support it.

During the 2005 Legislative Session RSA Chapter 215-C was created, separating snowmobiles from OHRVs. This split was supported by the Department to better facilitate the operation of the different recreational vehicle programs. While working with the Legislature and the various organizations involved we thought the proposal was all inclusive. Recently the Department discovered that we do not have the authority to issue duplicate snowmobile registrations. This proposal will correct that matter.

Mr. Chair, thank you for the opportunity to testify before the Committee this morning and the Department urges the Committee to vote in support of this proposal.


