These property owners shall be 28 chosen from a list of 4 nominees submitted by the commissioner of the department of environmental 29 services. 30 (h) Five representatives of the protected shoreland. chosen from a list of 10 nominees submitted by the president of the senate and the speaker of the

house of representatives. In their list, the president of the senate and the speaker of the house of
representatives shall consider including nominations submitted by the New Hampshire Shorefront
Association, the New Hampshire Shoreline Coalition, the New Hampshire Shoreline and Property
Rights Guardians, and other organizations whose membership includes owners of shoreline property.
There shall be one representative for lakes greater than 1,000 acres, one representative for lakes less
than 1,000 acres, one representative for rivers designated under RSA 483, one representative for
rivers greater than 4th order, and one representative of tidal areas.

- (i) A representative of the New Hampshire Home Builders and Remodelers Association chosen from a list of 3 nominees.
- (j) A representative of the Granite State Landscape Architects chosen from a list of 3 nominees.
- (k) A representative from the department of environmental services who shall serve as a non-voting member of the council.
- (1) A representative who is a marine contractor or dock builder from a list of 2 nominees provided by the New Hampshire Marine Trades Association.
  - II. The council shall solicit information from other state agencies on an as needed basis.
  - III. The members shall serve until the repeal of the council.

- IV. Any vacancy shall be filled in the same manner as the original appointment. Members may hold office until their successors are appointed and confirmed.
- V. The representative of the department of environmental services shall call the first meeting 90 days after adoption as long as the majority of appointments have been confirmed. Nine members shall constitute a quorum. At its first meeting the council shall elect a chairperson, vice chairperson, and secretary. Subsequent meetings shall be at the call of the chair, or at the request of 5 or more council members.
  - (a) The council shall meet a minimum of 4 times per year.
- (b) The council secretary shall contact the chair of the senate energy, environment and economic development committee and the chair of the house resources, recreation and development committee to post scheduled meetings and public hearing times and places in the legislative calendars.
- VI. The council shall consult with and advise the commissioner of the department of environmental services, on a continuing basis, with respect to the policy, programs, goals, and operations of the department as they relate to the impact and implementation of the comprehensive shoreland protection act under this chapter and the regulation of shoreline structures under RSA 482-A. In order to accomplish these purposes, the council may:
  - (a) Perform field evaluation of particular situations and issues.
  - (b) Identify issues that need clarification or modification in the rules and statutes.
  - (c) Prepare written comment for the commissioner to suggest potential rules changes.

(e) Aid in the design and implementation of outreach strategies and guidance documents.

VII. The commissioner of the department of environmental services shall present all proposed rules relative to shoreline structures under RSA 482-A and protected shoreland under this chapter to the council for consideration and comment prior to filing a notice of proposed rule making under RSA 541-A:6. The council shall present any objections to proposed rules to the commissioner in writing within 30 days. The commissioner may adopt a rule to which the council has objected only after presenting a written reply to the council detailing the reasons for adopting the rule over the objections of the council.

VIII. There is hereby established in the office of the state treasurer a fund to be known as the shoreland advisory council fund which shall be kept separate and distinct from all other funds and shall be continually appropriated to the council. Such fund shall be the depository for all financial gifts, grants, or donations made to the council. Expenses incurred shall be paid from such fund and will not exceed receipts. Any moneys in such fund shall lapse into the general fund at the repeal of the council.

Rep. Nancy Stiles - Prime sponsor of the bill. This bill has a sunset date and there would need to be new legislation to continue that when reached. Language of bill drafted by department. When brought to me by a constituent, I immediately consulted with DES to see how this could help DES in its operations. There would be no cost to the state.

- Q. Rep. Tupper: What did the commissioner say? ANS: He has someone here who will speak in support.
- Q. Rep. Russell: In going through appointments, there are two reps of protected shoreline and five reps of protected shoreline appointed. Can you combine these? ANS: Perhaps. Discussed how these members are nominated and then chosen
- Q. Rep. Kappler: Need at least one state representative in the group to bring forth legislation when needed.
- Q. Rep. Renzullo: Are there eighteen members? ANS: Oh seventeen.
- Q. Rep. Hubbard: Looking at list of nominating pool and wondering about the discrepancies. ANS: Ask department.

**Paul Goodwin** - Supports the bill. We are always reactive and need to be proactive. Landowner needs to have input. Looking at B 21. Support that.

Greg Whitman for Senator Fuller-Clark. Fully support this.

- \* Peter Rice, NH Shoreline Guardians Supports the bill. Very supportive of this advisory council that gives owners opportunity to give input. Many projects are backed up because of confusion over what can be done. Appreciate opportunity to testify.
- Q. Why are there so many organizations trying to do the same thing? How do you differ? ANS: Maybe then we wouldn't need a council.
- Q. Rep. Tupper: What does your group do? ANS: Represent property owners and their rights.
- Don Lane, NH Native Supports the bill. Resides in Bow. Love the land and now own 65 acres, some near a pond and a dam. Understand our stewardship role. Putney Meadow Pond does come under shoreland protection act. That act is unfair. Think this bill is a step toward a better process. Where is the office of planning? Lack of leadership in state toward planning is appalling. Need much more input. Good place to start. Need education more than regulation. Have adopted zoning regulations that prohibit the type of planning we need. Don't forget the role of appropriate planning in a bill such as this.
- \* Jared Teutsch, President and CEO of NH Lakes Association Supports the bill. Predecessor began first shoreland protection legislation. Idea was to establish some sort of water quality standard. We have some of the most pristine waters in the country. Need to promote and protect what we have. Have continued to work over the years to refine and improve the act. Originally was idea to continue Shoreland Commission as a standing commission. Approve this concept but have problems. To run appointees through governor and council is awkward. Remove that part. Other issue is that two members come from DES and five from public. Why should DES appoint members from the public. Final issue is a fiscal note. How much DES staff time will be devoted to this council? DES always has problems because chronically understaffed.
- Q. Rep. St Cyr: Concerned with slate of nominees, too many. Do you know difference between these shoreline organizations? ANS: I can't speak to that.
- Q. Rep. Christensen: Appreciate concern about DES in from a manpower situation. What do we get from this that we couldn't get from folks just getting together? ANS: Appreciate your point. Good from a public relations standpoint. In support of idea to educate rather than legislate.
- Q. Rep. Spang: Are you saying this bill is feel good legislation? ANS: Possibly. But does give folks the feeling that their voices will be heard.
- Q. Lot of confusion about wetlands. When people have an issue, folks go to their legislator to bring forth a bill. ANS: DES probably prefers a council to facing legislation every year over shoreland act.
- Q. Rep. Kappler: Paragraph h. Front-loading council with people who have vested interests. ANS: We feel we are a good organization that represents stakeholders statewide. Hard for me to argue that this representation is fair or unfair. It is up to governor and council to choose from the list.
- Q. Rep. Bolster: Shoreland owners are the ones most directly affected. Could the language in this bill include Homeowners Association? ANS: There are 300 such Associations in the state.
- Q. That means any of these could submit a name to the Speaker? ANS: Think the three separate ones are just listed.

Misunderstanding about language on four groups shall be considered. There is no given that they will be chosen. They are just those who have been vocal and concerned about treading on property rights. Not particularly geographic.

- Q. So they each have a different guru? ANS: Well, yes.
- Q. Rep. Kappler: Asked about group in c. ANS: Those are septic system designers.
- Q. Rep. St Cyr: Why so many nominees? ANS: Patterned after other procedures. No other reason. Our role (DES) will be very limited which is why there is no fiscal note.

Gina Rotondi, NH Shorefront Association - Supports the bill. Currently has 200 private property and business owners around lakes. Active in 1980s, then dormant until recently when new bills surfaced. While we support the act, believe further improvements could be made. Council is one way regulated community could be heard.

Q. Rep. St Cyr. Do you know of any differences between your group and the others? ANS: Can't speak for them. But we all have similar concerns. Just have different leaders.

**Bruce Tuekelsen**: Representing self and another person who can't be here today. Supports the bill. I am not affected by legislation because I have a non-conforming lot. Mr. Montrone will provide a mission statement to the committee. Group was formed in response to the CSPA.

Darlene Forst, NH Department of Environmental Services, (DES) - Support the bill. Public should be heard and we are happy to serve that role.

- Q. Rep. St Cyr: Are you likely to be the DES representative? ANS: Mr Pelletier says it shall be so.
- Q. Rep. Spang: Is the CSPA worse than the wetlands when they were brought in? And wetlands does not have a group like this. ANS: This group will look at 482 A also. But only for structures. Only organization I know of that looks at a specific program.
- Q. How are you envisioning this working? Would they go directly to the Commissioner and how much will be funneled through the legislature?

  Ans. As written, this is just an advisory council. Submit written comments. As citizens any one of the members can ask someone to put in legislation. This may bring all those people together and ultimately reduce the number of bills.
- Q. How about direct access to rules and bypassing the legislature? ANS: That is through the Wetlands Council? Why couldn't these things go through them? Department's position is going to be that we have no objection to showing rules to any group.
- Q. Rep. Ahlgren: Why are there no legislators on to bridge the gap between group and legislation? ANS: This is not just a lake front bill but includes streams and other water bodies. Q. Bolster: Read from suggested amendments given by Montrone group.
- Q. Rep. Kepner: On page 3, line 11, about funds. Are there other groups that can accept money?

Pellitier: Groups wanted to have ability to do outreach, print forms. It is unique.

Comment: Rep. McClammer: Rulemaking process is already slow and cumbersome so what will be the effect of input from this group? ANS: Think we can work around this.

Q. Rep. Howard: Aren't we just trying to give homeowners a little redress for what they see as problems and perhaps getting some legislation. ANS: Described makeup of previous CSPA commission. The groups in this bill are there because they felt they were left out. Not everyone was satisfied with what came out of previous bill. If this helps them feel they are now being heard, then that is okay with me. But nothing untoward was done in initial commission.

Pelletier: Before we even go to the rulemaking process, we vet things before many groups. Explained further for Rep. McClammer how groups might have input.

Many questions asked about process of rulemaking and input from stakeholders.

Q. Rep.Kepner: DES can make variance and waivers. ANS: Have at least four or five exceptions available.

Goodwin: Department comes up with rules and wetlands group must comment in 15 days. Even if object to it, DES can still move forward. This commission can comment and will comment. Hopefully the rules will be developed from a landowner perspective.

Spang: This does not pretend to be a balanced group. It consists primarily of property owners who have found aspects of CSPA unacceptable. In terms of reducing legislation, I see more coming out of this group. Heavily weighted. Seems to me we are giving a special position to people who are opposed to the shoreland protection act. This is not balanced. I have a problem with creating in statute a special group. If composition of group more balanced, would those in favor of this still be in favor. Darlene. We won't be picking and choosing from those commenting.

Q. Rep. McClammer: How would you feel if this was balanced between conservation groups and constituencies who promote landowner rights. ANS: We are not going to object to public input.

Renee: Don't have a lot of concerns. Slanted toward property owners because that has been the significant griping group. Want folks to sit down and present their problems and concerns. Designed to give regulated community a voice.

Rep. Spang: I have to object to you saying that CSPA did not have adequate public input or education.

Q. Rep. Bolster: The intimation has been that people who own land on the lake, they are going to despoil their own land. Where I own property, the folks are fanatical about preserving the quality of the water. I assume these property owners are concerned with their property. ANS: Many people want to preserve their property but not everybody intends to stay, or thinks about their neighbors or about future times.

Tom Thomson - Support idea of council where issues can be brought up and discussed with DES. Is DES providing the meeting rooms. Would encourage the room and a clerk to take minutes and distribute them. Main concern is the makeup of the 17 members. Important for true stakeholders to be part of council. However, left out a lot of the real true stakeholders, landowners and forest owners. Change g. I want NH Timberland Owners and NH Farm Bureau included. Members of these groups represent huge amounts of land in NH. More at stake than any of the other groups. Work the land daily and protect the water quality.

Q. How are you envisioning this working? Would they go directly to the Commissioner and how much will be funneled through the legislature? Ans. As written, this is just an advisory council. Submit written comments. As citizens any one of the members can ask someone to put in legislation. This may bring all those people together and ultimately reduce the number of bills.

Q. How about direct access to rules and bypassing the legislature? Ans. That is through the Wetlands Council? Why couldn't these things go through them? Department's position is going to be that we have no objection to showing rules to any group.

Q. Ahlgren: Why are there no legislators on to bridge the gap between group and legislation?

Ans. This is not just a lake front bill but includes streams and other water bodies.

Q. Bolster: Read from suggested amendments given by Montrone group.

Q. Kepner: On page 3, line 11, about funds. Are there other groups that can accept money?

Pellitier: Groups wanted to have ability to do outreach, print forms. It is unique. Comment: McClammer: Rulemaking process is already slow and cumbersome so what will be the effect of input from this group?

Ans. Think we can work around this.

Q. Howard: Aren't we just trying to give homeowners a little redress for what they see as problems and perhaps getting some legislation.

Ans. Described makeup of previous CSPA commission. The groups in this bill are there because they felt they were left out. Not everyone was satisfied with what came out of previous bill. If this helps them feel they are now being heard, then that is okay with me. But nothing untoward was done in initial commission. Pelletier: Before we even go to the rulemaking process, we vet things before many groups. Explained further for Rep. McClammer how groups might have

Many questions asked about process of rulemaking and input from stakeholders. Q. Kepner: DES can make variance and waivers...

Ans. Have at least four or five exceptions available.

Goodwin: Department comes up with rules and wetlands group must comment in 15 days. Even if object to it, DES can still move forward. This commission can comment and will comment. Hopefully the rules will be developed from a landowner perspective.

Spang: This does not pretend to be a balanced group. It consists primarily of property owners who have found aspects of CSPA unacceptable. In terms of reducing legislation, I see more coming out of this group. Heavily weighted. Seems to me we are giving a special position to people who are opposed to the shoreland protection act. This is not balanced. I have a problem with creating in statute a special group. If composition of group more balanced, would those in favor of this still be in favor.

Darlene. We won't be picking and choosing from those commenting.

Q. McClammer: How would you feel if this was balanced between conservation groups and constituencies who promote landowner rights.

Ans. We are not going to object to public input.

Renee: Don't have a lot of concerns. Slanted toward property owners because that has been the significant griping group. Want folks to sit down and present their problems and concerns. Designed to give regulated community a voice. Spang: I have to object to you saying that CSPA did not have adequate public input or education.

Q. Bolster: The intimation has been that people who own land on the lake, they are going to despoil their own land. Where I own property, the folks are fanatical about preserving the quality of the water. I assume these property owners are concerned with their property.

Ans. Many people want to preserve their property but not everybody intends to stay, or thinks about their neighbors or about future times.

Testimony: Tom Thomson: Support idea of council where issues can be brought up and discussed with DES. Is DES providing the meeting rooms. Would encourage the room and a clerk to take minutes and distribute them. Main concern is the makeup of the 17 members. Important for true stakeholders to be part of council. However, left out a lot of the real true stakeholders, landowners and forest owners. Change g. I want NH Timberland Owners and NH Farm Bureau included. Members of these groups represent huge amounts of land in NH. More at stake than any of the other groups. Work the land daily and protect the water quality. Adjourned at 4:10 p.m.

Thank you for the opportunity to comment on HB 1462, which would establish a shoreland advisory council. The Department of Environmental Services (DES) supports the creation of an advisory council as a means to promote greater understanding and evaluation of RSA 483-B and its ongoing implementation.

As you know, effective July 1, 2009 there was a permit required to perform work on properties that were located within the 250 foot protected shoreland. As a result of this new statutory requirement and subsequent rulemaking, there was a significant amount of misunderstanding about what activities in the shoreland zone needed a DES permit. ### HB 1462, 483-B:21 establishing a Shoreland Advisory Council House Resources, Recreation & Development Committee

The New Hampshire Shoreline Coalition submits the following suggested Amendments to improve the effectiveness of HB 1462, 483-B:21 Shoreline Advisory Council.

III. The members shall serve until the repeal of the council, or for a maximum of four years.

Comment – In the event the council's life is extended, this will set term limits on members.

- VI. Duties The council shall consult with and advise the commissioner of the department of environmental services, on a continuing basis, with respect to the policy, programs, goals, and operations of the department as they relate to the impact and implementation of the comprehensive shoreland protection act under this chapter and the regulation of shoreline structures under RSA 482-A. In order to accomplish these purposes, the council may:
  - (a) Perform field evaluation of particular situations and issues.
  - (b) Identify issues that need clarification or modification in the rules and statutes.
  - (c) Prepare written comment for the commissioner to suggest potential rules changes.
  - (d) Prepare written comment for the commissioner and the chairperson of the appropriate committees of the house and senate to suggested statutory changes.
    - Comment We believe suggestions for statutory changes should be submitted to the legislature the Council is a body created by the legislature.
  - (f) Develop operation rules and procedures for carrying out its duties, including appointing other officers selected from council members and establishing committees made up of council members and others

Comment – We suggest adding this new section (f). This will make it clear that the Council is empowered to run itself as well as finance itself.

VII. The Commissioner of the department of environmental services shall present all proposed rules relative to shoreline structures under RSA 482-A and protected shoreland under this chapter to the council for consideration and comment prior to filing a notice of proposed rule making under RSA 541-A:6. The council shall present any objections to proposed rules to the commissioner in writing within 30 90 days. The commissioner may adopt a rule to which the council has objected only after presenting a written reply to the council detailing the reasons for adopting the rule over the objections of the council.

Comment – 30 days seems rather pressured since the Council is scheduled to meet regularly only four times a year, unless a special meeting is called – which itself will take time to set-up and organize. It seems like 90 days would be better.

VIII. There is hereby established in the office of the state treasurer a fund to be known as the shoreland advisory council fund which shall be kept separate and distinct from all other funds and shall be continually appropriated to the council. Such fund shall be the depository for all financial gifts, grants, or donations made to the council. Expenses incurred shall be paid from such fund and will not exceed receipts. Any moneys in such fund shall lapse into the general fund at the repeal of the council, <u>unless the Council is continued through legislation.</u>

Comment – The Council Fund is a great idea for funding. We suggest the additional language to allow funds that have been raised to carry over if the Council is continued beyond 2015.

Thank you for the opportunity to testify about House Bill 1462. On behalf of New Hampshire Lakes Association (NH LAKES), a 501(c)3 nonprofit organization representing over 26,000 lake enthusiasts, we support HB 1462 if amended and urge the Committee to vote Ought to Pass as amended.

NH LAKES has long supported water quality protection as the basic means for promoting and enhancing the quality of life along our lakes. In 1992, NH LAKES worked to help create RSA 483-B, the Comprehensive Shoreland Protection Act (CSPA) as a way to proactively promote and protect our water quality. Currently, the CSPA is the premier water quality protection statute in NH. It has had some logistical problems and the funding of staff at the NH Department of Environmental Services (DES) to promote and regulate the CSPA has been a challenge. NH LAKES recognizes this and over the years, has long supported revisions and improvements to the CSPA.

HB 1462 seeks to create a shoreland advisory council to help advise DES on the practical administration and regulation of the CSPA. However, HB 1462 is somewhat redundant in the number of members appointed by the Governor and Council. It also leaves too much political opportunity to allow the Governor and Council to pick one member from a list of three or more choices.

In addition, NH LAKES is a membership organization created in 1992 and comprised primarily of shoreland property owners. Accordingly, NH LAKES should be the nominating authority instead of DES when suggesting two representatives of the protected shoreland, especially when considering we represent over 26,000 lake enthusiasts across the state of New Hampshire.

Also, the establishment of a new Shoreland Advisory Council will require DES staff time. Given the lack of an existing effective budget to administer and regulate the CSPA, NH LAKES requests that a FN-note be added to HB 1462 clarifying the cost associated with the added staff time of a proposed Shoreland Advisory Council. If these issues are addressed through amendments, NH I AKES will support HB 1462 as amended, and urges the Committee to vote *Ought to Pass as amended*. Thank you.
