Be it Enacted by the Senate and House of Representatives in General Court convened:

Loitering. Amend RSA 179:50 to read as follows:
 179:50 Loitering; [Intexication;] Unlawful Purpose.
 I. No licensee shall allow any person to loiter on his premises who is [intexicated or]
 disorderly or who loiters for any illegal purpose.
 II. No licensee shall use, or allow to be used, such premises for any purpose contrary to law.
 Effective Date. This act shall take effect January 1, 2011.
