\* Rene Pelletier, Department of Environmental Services (DES) - In support of bill. Did have a recommendation to strike the words "in NH." Will sit down with the sponsor to get language that makes sense.

Rep. Tupper: What makes a lake Class A. ANS: Thought to be those that could be used for drinking water. Now have a good way to measure chemistry of water in large or small lakes. Pleasant meets or exceeds the standards. As time goes on, the system becomes more arcane and outdated. Now have a better way than in 1947 to determine quality.

Rep. Kappler: In current statute, Class A and Class B. Both say that within 60 day period you have to take three samples. How often does this have to be repeated? And who pays? ANS: Have a regular schedule for testing waters, usually three months in a row.

Rep. Kappler: If next biennium, you would like to make some changes, I would be glad to help you as they are outdated.

Rep. Christensen: At this point in time, are there an A list and a B list? Are there a significant number of B lakes that should be classified as A? ANS: Perhaps. Initially, based only on water quality. Could theoretically go back and make changes in all lakes.

Rep. Spaulding: How will the change from B to A interface with Shoreland Protection Act? ANS: No change.

Rep. Kepner: What does this reclassification do for Pleasant Lake? ANS: Historically what takes place is so highly regulated, should not make a big difference.

Rep. McClammer: Does it have anything to do with degradation standards? ANS: Parameters we now examine are far higher than in the past. If there was development that was going on, then the anti-degradation regs take place.

Rep. McClammer: Why are we doing this if it doesn't gain any greater protection? ANS: Can't answer that.

Rep. Gottling: Explain about tributaries being included. ANS: Classify a lake and its tributaries according to the limits of the municipalities in which it is located.

Rep. Christensen: What happens if you go out later and find Lake no longer meets the standards? Does the legislature have to take action? ANS: Seldom happens. But we might have to come back in and take action. DES does not spend a lot of time and energy on these classifications. We look at the many parameters now in use, in the chemical analysis. If we saw a lake degraded, don't know if we would make the effort to come back in and have classification changed.

Jared Teutsch, President, NH Lakes Association - Represent about 26,000 lake enthusiasts. It is a great example of encouraging a higher standard of local support. Used to be Classes A, B, C, and D. No one wanted to be a D. Dropped it. Then in 1970's dropped C. You can't have a B into an A so therefore the tributaries had to be included. They must also be Class A. Clarified the issues around the amendments.

Rep. Russell: Class A does not prohibit swimming. Why does Massabesic that supplies Manchester drinking water have swimming prohibited? ANS: It is prohibited on one side but not in Auburn.

Rep. Spaulding: Why does this matter? ANS: So that the community gets the recognition for the work they have put in to reach this standard.

Rep. Howard: Assume swimming is a municipal restriction. Are there any state regulations related to prohibiting swimming or boating? ANS: No, unless there is a health issue when beaches are closed.

Rep. Kappler: Read various standards that seemed to indicate that standards for Class B are stricter than Class A. ANS: Probably doing more testing on B because they have had a lower water quality and need to be tested for more items.

Rep. Kepner: Why isn't DES classifying lakes and making a list instead of making the legislature do this? ANS: Probably they don't have enough time to initiate this and instead these reclassifications come through local efforts.

Walter Hooker, Pleasant Lake Association - Supports the bill. Including tributaries in both Deerfield and Northwood insures a greater level of compliance. The inclusion of Deerfield was to distinguish Lake from the one with same name in New London.

Rep. McClammer: Did you approach DES with request to change label? ANS: No, someone else did. The list used to be on website but after 911 list taken down for security concerns.

Jared Teutsch, Lakes Assoc. and residents and Sen. Barnes all consulted ahead of time with DES to be sure DES was in favor.

Linda Brennan, Vice President, PLA - Supports the bill. We are very proud of our lake and work hard to keep it that way. It is expensive to keep it weed-free and we also pay for the testing of the tributaries. #### Subject: SB 426 Reclassification of Pleasant Lake

Dear Madam Chair and Members of the Committee:

Thank you for the opportunity to testify about Senate Bill 426. On behalf of New Hampshire Lakes Association (NH LAKES), a 501(c)3 nonprofit organization representing over 26,000 lake enthusiasts, we strongly support SB 426 and urge the Committee to vote Ought to Pass.

NH LAKES supports SB 426 because the reclassification of Pleasant Lake and its tributaries from a Class B to a Class A is a welcome change toward recognizing the importance of a higher standard of water quality. Traditionally, Class A water bodies are, or were at one time, used for public drinking water supply. Similarly, Pleasant Lake at one time supplied the town of Allenstown with drinking water and was listed as a Class A waterbody.

This is a wonderful opportunity to enhance public perception and encourage wise lake stewardship among the residents and recreational users of Pleasant Lake. There are clear benefits for the residents of Deerfield and Northwood to protect the water quality of Pleasant Lake including the economic importance to the region. A recent economic study commissioned by NH LAKES on behalf of the Lakes, Rivers, Streams and Ponds Partnership and published in 2007 found that if visitors to surface waters in New Hampshire perceived a decline in water clarity and purity, this would result in a statewide loss of \$51 million in sales, \$18 million in lost income and 810 lost jobs.

For these reasons, NH LAKES supports SB 426, and urges the Committee to vote *Ought to Pass*. Thank you.



#### Re: Senate Bill 426, relative to the classification of Pleasant Lake

Dear Chairman Spang:

Thank you for the opportunity to comment on SB 426, which would re-classify Pleasant Lake in Deerfield from Class B to Class A. The Department of Environmental Services (DES) supports this legislation.

For information, RSA 485-A:8 establishes two classifications of surface water: Class A and Class B. The legislature classifies and reclassifies surface waters, usually following the procedures in RSA 485-A:9 and 10 which provide for DES to hold a public hearing and make recommendation to the legislature. However, the legislature can propose bills, have hearings on bills and pass laws without following these procedures. The current classification system has been in use since 1947. All surface waters have previously been classified by the legislature. Class A is intended to have "higher" water quality than Class B, although there is little practical difference in water quality criteria or watershed protection requirements between the two classes. The Department has recently conducted a detailed review of the legislative history of surface water classifications or reclassifications to Class A have been for waters that are or were used for public water supply. There have been few reclassifications from Class B to Class A in recent years, the most recent being Spofford Lake, Chesterfield in 2005.

Based on data available to DES, Pleasant Lake water quality meets or is better than the criteria for Class A waters: water quality analyses by the DES Beach Program and the Volunteer Lake Assessment Program reveal that Pleasant Lake meets Class A bacteria standards; there are no known direct discharges of sewage or waste, and; the water is suitable for drinking water supply after adequate treatment.

We would recommend that the bill be amended to move the words in italics, so that the reclassification language reads: "Pleasant Lake *in Deerfield* and its tributaries <del>New</del> <del>Hampshire</del>..." This language would reclassify all tributaries as Class A, without regard to political boundaries, to be consistent with the revised classification of the lake.
