What the bill does: This bill names the Sagamore Bridge in Portsmouth in honor of Joseph Sawtelle.

Who supports the bill: Senator Fuller Clark, David Witham, Maryellen Burke, Rep. Paul McEachern (Rock 16)

Who opposes the bill: No one

Summary of testimony received: Senator Fuller Clark:

- Introduced the bill and stated that she wished it had been her idea. She thanked the various members of the Portsmouth community for this idea.
- She talked to the City of Portsmouth yesterday and found out that the Sagamore Bridge is owned by the city, not the state, so the legislature has no authority to name it. However, there is a bridge connecting Shapleigh Island to Goat Island that has no name (see approved amendment).
- Senator Fuller Clark spoke of Joe Sawtelle, stating that he was a true Renaissance man in the community and on a state level. She listed many life accomplishments and stated that he had a very energetic personality.
- He accomplished many things in the Portsmouth and surrounding area, and she cannot think of anything more fitting than a place to honor him in his community.
- Senator Fuller Clark recommended that this law take effect "upon passage" rather than in 60 days (see approved amendment).

Rep. Paul McEachern:

- Spoke in favor of the bill as co-sponsor. Mr. Sawtelle was his client for more than 35 years.
- He stated that he was "like a one person United Way fund." He started the first community foundation in the state. Mr. Sawtelle was a keen business person. Now community foundations are bigger collectively than the NH Charitable Foundation.
- This bridge would be a fitting way to remember him.

David Witham:

- Spoke in favor of the bill. He is a Portsmouth resident and Mr. Sawtelle was a hero of his.
- Mr. Witham stated that nobody really knows the depths to which he gave.
- One of Mr. Sawtelle's favorite sayings was "It is amazing what you can accomplish when you don't care who gets the credit."
- Mr. Witham has been involved with Crossroads Homeless Shelter, which began with a house that Mr. Sawtelle bought. It has recently been replaced by a brand new building.
- Senator Fuller Clark thanked him for instigating this.

Mary Ellen Burke:

- Spoke in favor of the bill. She works for the NH Charitable Foundation.
- She stated that Mr. Sawtelle was very important to the community. She works with his widow now regarding philanthropic efforts.
- Ms. Burke stated that people come to them to learn how to have a regional organization with local impact, like Mr. Sawtelle developed.

Funding: Not applicable.

Action: The committee went into executive session. Senator Fuller Clark moved "Ought To Pass as amended" (0156s). Senator Letourneau seconded the motion. The committee voted 4 to 0 in support of the OTP as amended motion. Senator Fuller Clark will report the bill out.

Due to an equipment malfunction, there is no recording of this public hearing. The following is created from the notes taken from the Senate Transportation Committee Secretary.

The Chair, Senator Robert J. Letourneau, opened the hearing on SB 376 and invited the prime sponsor, Senator Martha Fuller Clark, to introduce the legislation.

Senator Fuller Clark addressed the Committee and explained that the intent of this bill was to name a bridge in Portsmouth, New Hampshire, after Joseph Sawtelle, a widely-known and beloved community benefactor from Portsmouth who passed away in May of 2000. She shared that the bridge she was originally hoping to name in honor of Mr. Sawtelle, the Sagamore Bridge in Portsmouth, is actually owned by the City of Portsmouth, not the State. In light of this, she had found another bridge that is currently unnamed, and is hoping to name this bridge instead.

Senator Fuller Clark provided the Committee members with some background history about Joseph Sawtelle. She described Mr. Sawtelle as being "larger than life", both in the Portsmouth community he hailed from and throughout the entire State. He was an entrepreneur, developer, humanitarian, philanthropist, and community activist.

Mr. Sawtelle's contributions to Portsmouth began with his purchase of Atlantic Heights, which has provided low-income housing in the community for many years. He was diligent in his efforts as landlord and worked tirelessly to improve homes in the area.

Mr. Sawtelle had a zeal for learning about maritime history, and was responsible for convincing the State to close a state road for 48 hours to allow the submarine Albacore to pass down the Piscataqua River to a park that would house it, which Mr. Sawtelle was instrumental in developing.

Mr. Sawtelle was also responsible for starting the Greater Piscataqua Charitable Foundation. He also helped to found The Cross Roads House, which is a shelter in Portsmouth that houses more than 100 homeless individuals every day.

Senator Fuller Clark provided the Committee with a newspaper article from *The Portsmouth Herald* about Mr. Sawtelle's passing.

Senator Fuller Clark further provided the Committee with a map depicting the bridge she is hoping to name in honor of Mr. Sawtelle.

Please see Attachment #2- Map depicting the bridge between Shapleigh Island and Goat Island.

Senator Fuller Clark further stated that she would like to amend this bill to have the law take effect "upon passage" as opposed to "after 60 days", as it was originally written.

Next, the Committee heard from Representative Paul McEachern. Representative McEachern shared with the Committee that Mr. Sawtelle had been his client for over 35 years. He described Mr. Sawtelle as being like a "one-person United Way", for all of his efforts on behalf of the community and the State as a whole. Representative McEachern shared that Mr. Sawtelle had been responsible for founding the first community foundation in the State. He described him as a keen businessman and as having a heart of gold. Representative McEachern feels that the naming of this bridge would be a very fitting way of memorializing Mr. Sawtelle.

The Committee then heard testimony from Mr. David Witham, a resident of Portsmouth, who was speaking in favor of the bill. Mr. Witham shared that he considered Mr. Sawtelle to be his mentor and counted him as his personal hero. Mr. Witham shared that one of Mr. Sawtelle's favorite quotes, which made a big impression on him, was, "It is amazing what you can accomplish when you don't care who gets the credit." Mr. Witham got to know Mr. Sawtelle well through his involvement with Cross Roads Homeless Shelter, a shelter founded by Mr. Sawtelle.

Mary Ellen Burke addressed the Committee, and stated that she is in favor of the bill. Ms. Burke stated that she works for the New Hampshire Charitable Foundation, which was modeled after the Greater Piscataqua Charitable Foundation, which Mr. Sawtelle founded. Ms. Burke now works with Mr. Sawtelle's widow, still in philanthropic efforts.

Ms. Burke shared with the Committee that community leaders from other states come to New Hampshire to learn how to set up regional organizations that are as successful as those in New Hampshire, the first of which, Mr. Sawtelle helped to put in place. She related that Mr. Sawtelle's impact on the community is immeasurable, and that this bridge would be a very appropriate honor for him.

The Chair then closed the hearing on Senate Bill 376.

Hearing concluded at 11:35 a.m.



A man described by all as a giant in the community, Joseph Sawtelle, 71, of 110 Beach Road in New Castle died Tuesday at 10:36 a.m. after suffering cardiac arrest.

Sawtelle is survived by his wife, Jean, three daughters, Caryl, Susan and Janet, and several grandchildren. He is described as having a heart of gold, and as the man who got things done.

"I am so awfully sorry," said Mayor Evelyn Sirrell. "Joe was one of those men who comes along once in a lifetime. He did so much for all of us."

Portsmouth Regional Hospital spokeswoman Nancy Notis confirmed the death that shocked and saddened the Seacoast. She said she knew Sawtelle for many years.

"He was a leader in so many projects. This is a great loss for the community," said Notis.

Sawtelle seems to have touched the lives of people in every walk of life. Through a multitude of business dealings, to the many charitable works and the countless hours he gave to the community, there is little doubt Sawtelle's passing will leave a gaping hole that will be hard, if not impossible, to fill.

Sheldon worked with Sawtelle in the development of his many projects since 1985. He said he knows that his friend Joe will be missed.

"When it came to people, Joe never said no," said Sheldon. "He was a true visionary, in every sense of the word. Joe had the ability to see the promise in things other people saw as failure. He was such a giving man, with a long-term view of life. He saw all the possibilities, as no one else could."

Sawtelles. He expressed shock at the news.

"I am extremely saddened, he was such a great man," said Cohen. "Joe was a giant, yet he was a quiet and unassuming man. He gave so much, accomplished so much. The extent of his contributions here is truly staggering. This is a huge loss."

Rep. Jim Splaine of Portsmouth, who held Cohen's seat in the early 1980s, said Sawtelle was "a class act in politics" who despite losing a primary race for the state Senate to Splaine easily won his friendship.

"He ran for state Senate in 1982 in the Democratic primary and I was the incumbent senator at the time," said Splaine. "He ran a beautiful campaign, a clean campaign, an issue-oriented campaign. I became his friend from that and managed his next campaign for the senate."

Splaine said one of his endearing memories of Sawtelle was him riding on top of the submarine Albacore when it was brought down the Piscataqua to its new home _ a park that Sawtelle had played a critical role in developing.

There were so many areas that Sawtelle brought his generous contributions to, his reputation reached throughout the state.

Gov. Jeanne Shaheen issued a statement offering the state's sorrow at his passing.

"I was saddened to learn of the death of Joseph Sawtelle," said Shaheen. "Joe was a true visionary who was committed to preserving what is special about the Seacoast. Seacoast residents will benefit from Joe's vision for restoring the inner cities in Portsmouth and Dover for years to come. He was a kind, compassionate man, who always helped those in need. His death is a great loss to the citizens of the Seacoast and to the state of New Hampshire."

Sawtelle was interested in preserving the history of the Seacoast. Bradley Lown, president of the Portsmouth Historical Society, called Sawtelle the most philanthropic man in the city.

"He was the savior for many local organizations that needed help," said Lown. "He gave selflessly and generously. Joe was committed to this city, and its history."

It was just last week, said Lown, that he spoke to members at the annual meeting of the historical society about the many contributions Sawtelle had made.

"What a shock to hear this today," said Lown.

"I am speechless," said Peter Loughlin. The attorney befriended Sawtelle through many business dealings,

the most recent being the work to reform a Portsmouth marina property. "I usually pride myself on having something clever to say, but I am without words. I don't think there are enough good things that anyone can say about Joe."

Attorney Tom Keane said that Sawtelle has no match anywhere as far as he is concerned. He called the death a tremendous loss to a community he did so much for.

Beside his generosity, the trait that came out most when people spoke of Sawtelle was his selflessness. Everyone said he gave and gave, with no interest in recognition.

"He never wanted to be in the spotlight," said Lown. "He helped everyone, children, businesspeople, anyone who needed it just because he wanted to, and because he had the means to do so."

Schoolchildren in the Seacoast will forever be one of Sawtelle's greatest projects. Through the FUTURES program, many Seacoast children are guaranteed a college education. It is the only program of its kind in the state, funded forever through Sawtelle's vision.

Assistant mayor and former school board Chairwoman Noele Clews said Sawtelle will always be a huge part of the community through the FUTURES program.


"The FUTURES program was his idea, and a brilliant one," said Clews. "He was such a forward-thinking man, the man you looked to if you wanted to get things done."


"Joe did so many good deeds," said Loughlin. "I think there are countless acts that no one will ever know about. He just did them and didn't tell people. Most of us who knew him have an idea, but no real clue as to the extent of this man's contribution. He will be missed for a very long time."

The good works that Sawtelle did will continue, many in his memory because he was closely tied to them, said Cohen.

>I would first like to state I'm am thankful for this opportunity to speak before all of you and even more so to speak on behalf of what Joe Sawtelle has meant to our community.


>People before me have eloquently spoken about what Joe has given to his community he so dearly cared about. But the fact of the matter is nobody really knows the depths to which Joe gave.



"I am so awfully sorry," said Mayor Evelyn Sirrell. "Joe was one of those men who comes along once in a lifetime. He did so much for all of us."

Portsmouth Regional Hospital spokeswoman Nancy Notis confirmed the death that shocked and saddened the Seacoast. She said she knew Sawtelle for many years.

"He was a leader in so many projects. This is a great loss for the community," said Notis.

Sawtelle seems to have touched the lives of people in every walk of life. Through a multitude of business dealings, to the many charitable works and the countless hours he gave to the community, there is little doubt Sawtelle's passing will leave a gaping hole that will be hard, if not impossible, to fill.

Sheldon worked with Sawtelle in the development of his many projects since 1985. He said he knows that his friend Joe will be missed.

"When it came to people, Joe never said no," said Sheldon. "He was a true visionary, in every sense of the word. Joe had the ability to see the promise in things other people saw as failure. He was such a giving man, with a long-term view of life. He saw all the possibilities, as no one else could."









Sen. Burt Cohen was a friend and a neighbor to the

Sawtelles. He expressed shock at the news.

"I am extremely saddened, he was such a great man," said Cohen. "Joe was a giant, yet he was a quiet and unassuming man. He gave so much, accomplished so much. The extent of his contributions here is truly staggering. This is a huge loss."

Rep. Jim Splaine of Portsmouth, who held Cohen's seat in the early 1980s, said Sawtelle was "a class act in politics" who despite losing a primary race for the state Senate to Splaine easily won his friendship.

"He ran for state Senate in 1982 in the Democratic primary and I was the incumbent senator at the time," said Splaine. "He ran a beautiful campaign, a clean campaign, an issue-oriented campaign. I became his friend from that and managed his next campaign for the senate."

Splaine said one of his endearing memories of Sawtelle was him riding on top of the submarine Albacore when it was brought down the Piscataqua to its new home _ a park that Sawtelle had played a critical role in developing.

There were so many areas that Sawtelle brought his generous contributions to, his reputation reached throughout the state.

Gov. Jeanne Shaheen issued a statement offering the state's sorrow at his passing.

"I was saddened to learn of the death of Joseph Sawtelle," said Shaheen. "Joe was a true visionary who was committed to preserving what is special about the Seacoast. Seacoast residents will benefit from Joe's vision for restoring the inner cities in Portsmouth and Dover for years to come. He was a kind, compassionate man, who always helped those in need. His death is a great loss to the citizens of the Seacoast and to the state of New Hampshire."

Sawtelle was interested in preserving the history of the Seacoast. Bradley Lown, president of the Portsmouth Historical Society, called Sawtelle the most philanthropic man in the city.

"He was the savior for many local organizations that needed help," said Lown. "He gave selflessly and generously. Joe was committed to this city, and its history."

It was just last week, said Lown, that he spoke to members at the annual meeting of the historical society about the many contributions Sawtelle had made.

"What a shock to hear this today," said Lown.

"I am speechless," said Peter Loughlin. The attorney befriended Sawtelle through many business dealings,

the most recent being the work to reform a Portsmouth marina property. "I usually pride myself on having something clever to say, but I am without words. I don't think there are enough good things that anyone can say about Joe."

Attorney Tom Keane said that Sawtelle has no match anywhere as far as he is concerned. He called the death a tremendous loss to a community he did so much for.

Beside his generosity, the trait that came out most when people spoke of Sawtelle was his selflessness. Everyone said he gave and gave, with no interest in recognition.

"He never wanted to be in the spotlight," said Lown. "He helped everyone, children, businesspeople, anyone who needed it just because he wanted to, and because he had the means to do so."

Schoolchildren in the Seacoast will forever be one of Sawtelle's greatest projects. Through the FUTURES program, many Seacoast children are guaranteed a college education. It is the only program of its kind in the state, funded forever through Sawtelle's vision.

Assistant mayor and former school board Chairwoman Noele Clews said Sawtelle will always be a huge part of the community through the FUTURES program.


"The FUTURES program was his idea, and a brilliant one," said Clews. "He was such a forward-thinking man, the man you looked to if you wanted to get things done."

"Joe did so many good deeds," said Loughlin. "I think there are countless acts that no one will ever know about. He just did them and didn't tell people. Most of us who knew him have an idea, but no real clue as to the extent of this man's contribution. He will be missed for a very long time."

The good works that Sawtelle did will continue, many in his memory because he was closely tied to them, said Cohen.
