This resolution condemns the governments of Quebec and Canada for taking the private business of a New Hampshire resident and asserts that such actions violate the North American Free Trade Agreement.

Testimony

In 2002 I started a business in Quebec which provided outfitting services for Atlantic Salmon fishing and hunting. Outfitting included guided fishing and hunting trips, along with lodging and meals. My target market was the U.S., and most of my clientele came from New England and New York.

In total, I invested close to \$1.5 million into establishing, marketing, and branding this business. From the outset, however, there was opposition to my business within Quebec. Initially, my business was opposed by a competing outfitting business that was Quebec-owned. And, within a short time, The Quebec Government began to make things difficult for my business through the imposition of new regulations. Despite this, I remained in business.

The competing Quebec outfitting business, which had lobbied for the new restrictive regulations for my business, then reached out to The Quebec Government for money to build brand new lodging facilities to better compete with me. In turn, the Quebec Government partnered with the Canadian Government and provided this Quebec-owned outfitter with \$1.5 million in grants, along with some loans that were guaranteed by the Governments. Construction of these new facilities began in 2007, with completion in 2008. On May 22, 2008, just days before my first clients of the year were set to arrive at my lodge, the Quebec Government sent me a letter which revoked my authorizations of commerce, which immediately put me out of business.

The letter states "This decision, in force immediately, was taken for economical considerations linked to salmon fishing in Gaspesie and with the goal of maintaining an acceptable social environment for all anglers and salmon river management organisations on the Gaspe peninsula"

The Quebec Government specifically has been asked to explain its actions. It has refused to do so.

Quite simply, their actions taken in the May 22nd letter, were taken illegally and in violation of NAFTA. They viewed me then as they view me today; an American small business owner who would complain about the actions taken, but who probably would choose not to do anything because of the great effort and expense it would take to fight the Government of Canada.

We cannot have free trade when one party does not respect a trade agreement and acts in a discriminating manner toward a foreign investor. I would respectfully ask you to let those in Quebec and Canada who made this decision know that it is not acceptable, and that they should adhere to their obligations under NAFTA and to resolve this issue accordingly.

Mr. Chairman:

I would like to thank you and this Committee for this hearing and for the opportunity to address you today.

About nine years ago, I started an outfitting business in Gaspe, Quebec and between 2002 and 2008 I invested nearly \$1.5 million into this business.

The business was offering outfitting services consisting of primarily Atlantic Salmon Fishing on Quebec's Gaspe Peninsula. The outfitting services consisted of providing guided fishing or hunting along with meals and lodging.

Although we were a brand new business, with a little time and a lot of effort, we were able to establish and develop a strong reputation. During my first year in operation, we were featured on OLN (Outdoor Life Network). In the following years, we were featured ESPN, NESN, and The Outdoor Channel, as well as written about in numerous publications including The Denver Post, San Diego Union Tribune, Houston Chronicle, and The Bangor Daily News. Additionally, my business was featured in most of the outdoor fly fishing magazines.

Most of my clientele came from the United States, as the vast majority of my marketing was directed to the United States market. Due to that fact, and the fact that I am an American Businessman operating in Quebec, there was opposition in Quebec to my business. This opposition also grew out of the fact that I was in direct competition with businesses that were supported by the Quebec Government. To explain, there was a Quebec-owned local outfitting business which I directly competed with, who had very strong opposition to the existence of my business since its inception. Realizing that they would have now have to compete with me, this other business, which received all of its fishing access from the Government without charge, embarked on a substantial renovation plan for their lodging facilities. This Quebec-based outfitting operation secured grants and loan guarantees from the Quebec and Canadian Governments for approximately \$1.5 million. Consequently, there was a vested interest on the part of these Governments for this other business to succeed and not have competition.

In 2006, in an effort to limit or eliminate my business, and, as I believe, in response to the political opposition to me and my business, the Quebec Government changed fishing regulations which were specifically intended to impacted my business in a negative way. These new regulations were an attempt to limit the number of clients I would be able to service. However, in no way did these regulations affect the number of anglers on the rivers, it merely shifted those licensing opportunities to Canadian anglers. The Government in fact acknowledged that the changed regulations were made to affect my business specifically and caused a "prejudice" to my business.

In May 2008, the Quebec government made additional efforts to put me out of business, this time they were successful. In May 2008, I had yet to receive the renewal of my authorizations of commerce for the York, Dartmouth, and St. Jean Rivers. The authorization of commerce granted me the right to conduct business on these three rivers. At that time, the vast majority of my business came from activity related to those three rivers. By letter dated May 22, 2008, the Quebec Government revoked my authorization of commerce. This action put me out of business. The Quebec Government knew this action would have that result, as in prior years I had reported to the Government a detail of where all of my outfitting activity occurred. They were made aware of my dependence on those three rivers for my business to continue and that is why they targeted them.

Since the Quebec Government's actions that ended my business, I have worked with several elected officials including Senator's Sununu, Gregg, and Shaheen as well as Governor Lynch's office in an effort to resolve this issue and receive fair compensation. The US Departments of Commerce and State also have been involved on my behalf.

I also have taken the action of commencing an Arbitration pursuant to NAFTA Chapter 11. As a result of the commencement of proceedings under NAFTA, I have met with representatives of the Quebec and Canadian Governments in an attempt to resolve the dispute. I have made every reasonable attempt to resolve this issue with Quebec and they refuse to engage in any sort of good faith dialogue.

The Canadian Government has failed to seriously consider or discuss the improper actions that were taken against me and my company. In every instance in which the Governments of Canada and Quebec have been asked for specific reasons as to why my authorization of Commerce was revoked, they have refused to provide an answer. The reason for this refusal to respond is clear, there is no legal basis whatsoever for their actions. In my opinion, the reason is quite simple; it was a political decision and it was taken to protect the interests of a Quebec-based businesses.

The Governments of Canada and Quebec have refused to in good faith resolve this matter simply because they see me as a small business man without the resources to pursue justice through the costly NAFTA arbitration process. However, the fact that Canada's actions violate NAFTA is clear. Alarmingly, over 50% of all NAFTA claims over the past five years have been against Canada, and most have to do with rogue political decisions made by Provinces. Most recently, in August 2010, to resolve a NAFTA chapter 11 claim, Canada paid over \$120 million to a US based company Abitibi Bowater because its water and timbering rights were revoked and land expropriated by the Government of Newfoundland in violation of NAFTA.

I would respectfully ask that this Committee ask Minister Nathalie Normandeau from Quebec to provide specific and detailed answers as to why she made the decision to revoke my Authorizations of Commerce and thereby taking away my business, and why her Government

has refused to try in good faith to resolve this issue and compensate me for the business that was taken. Additionally, I would respectfully ask this Committee to ask Patrick Muzzi, Director of Quebec Trade Policy Division, to explain his letter to Commissioner Bald and the fact that no serious attempt was made to resolve this issue to the satisfaction of all parties as he stated to Commissioner Bald.

Finally, I note that if this unfair treatment can happen to me, it can happen to any businessperson in New Hampshire who makes an investment into Quebec or Canada. I would caution anyone who has invested in Quebec or Canada, or who is contemplating an investment to consider my experience.

Dear Ministers Van Loan and Cannon:

We are writing to express our concern about a trade dispute between a New Hampshire constituent and the Government of Quebec and to request your assistance in settling this issue in a manner that is fair and consistent with Canada's obligations under the North American Free Trade Agreement (NAFTA).

Mr. Bill Greiner, a New Hampshire resident and sole shareholder of the Quebec-based Malbaic River Outfitters, has filed a lawsuit against Canada under Chapter 11 of NAFTA.

Between 2002 and 2008, Mr. Greiner invested over \$1 million in Malbaie River Outfitters, which helps coordinate fishing trips throughout Quebec. Greiner, in order to comply with NAFTA rules, obtained authorization from the Canadian government to operate his business on Quebec rivers in 2003. In 2008, that authorization was unexpectedly revoked by the Quebec government and Mr. Greiner's business was subsequently destroyed. Mr. Greiner believes that this revocation was taken without legal authority or due process in an attempt to discriminate against his company.

Over the last two years, the New Hampshire Congressional delegation has made a number of inquiries on behalf of Mr. Greiner, and he has made multiple attempts to settle this issue with the Quebec Government in an amicable and just fashion. Due to an inadequate response, however, Mr. Greiner has filed a Chapter 11 lawsuit under NAFTA in order to recoup his lost investments.

We believe that a thriving and prosperous U.S.-Canada trade relationship is critical to economic growth on both sides of our border. As a close neighbor of Canada, New Hampshire has always had a deep and expansive economic relationship with businesses and individuals across the border.

We are concerned that disputes like this one can adversely damage our trade relationship and undermine support for expanding trade between our two countries. Businesses on both sides of our border have an interest in resolving this dispute amicably to the satisfaction of all parties involved. We urge you and your government to assist in settling this matter quickly and in a way that is consistent with our bilateral trade obligations under NAFTA.

Thank you for your letter of March 19 to Mr. Jacques Gadbois regarding the ongoing dispute pursuant to Article 1118 of the North American Free Trade Agreement (NAFTA) and involving Malbaie River outfitters Inc., a company owned by Mr. Bill Greiner.

First I would note that the actions taken by Mr. Greiner do in fact fall under Chapter 11 of NAFTA. Consequently, although the measure Mr. Greiner is challenging was implemented by the Government of Québec, resolving the dispute requires the active participation of Canada's federal government as well as close cooperation between the two Québec ministries involved, i.e., MDEIE and Ministère des Ressources naturelles et de la Faune.

You mention quite rightly that the most recent meeting with Mr. Greiner was in December 2009. Since that time the Québec and federal ministries concerned have further analyzed the situation in light of the meeting and intend to pursue discussions with Mr. Greiner or his representatives with the aim of reaching agreement on the matter.

Please accept my thanks for your interest in seeing this dispute resolved. Like you, we attach great importance to trade between the State of New Hampshire and the Province of Quebec. Rest assured that the Government of Québec is giving these discussions its utmost attention and hopes to conclude the matter not only quickly but also to the satisfaction of all parties involved.
