HB 461 FISCAL NOTE

AN ACT

FISCAL IMPACT:

The New Hampshire Retirement System states this bill will decrease state expenditures by \$503,415 in FY 2014 and \$526,069 in FY 2015, and will decrease county and local expenditures by \$680,224 in FY 2014, and \$710,833 in FY 2015. There will be no fiscal impact on state, county and local revenue.

METHODOLOGY:

This bill repeals the provision which allows group I and group II members of the New Hampshire Retirement System to purchase credit for out of state service. The New Hampshire Retirement System states a review of member's out of state service credit purchases made from FY 2008 through FY 2010 resulted in increased System costs ranging from .03% to .05% of membership payroll. Consequently, for the purposes of estimating the fiscal impact of the proposed legislation, the System calculated estimated cost savings at .04% of membership payroll. The System states if enacted, this bill would not affect employer contribution rates for FY 2011, FY 2012, or FY 2013 as rates for those fiscal years have already been established. However, the System states their actuaries project the following reductions in state and political subdivision employer contributions in FY 2014 and FY 2015:

What the bill does: This bill repeals provisions which allow group I and group II members of the New Hampshire retirement system to purchase credit for out-of-state service.

Who supports the bill: Senator David Boutin, Dist. 16; Rep. Carol McGuire, Merr. 8; Senator Ray White, Dist. 9;

Who opposes the bill: Arthur J. Beaudry, NH State Firefighters; Jay Ward, SEA; Bob Blaisdell, NHPA/NHTA; Esther Dickinson, PFF NH; Laura Hainey, ATF-NH

Neutral: Barbara Reid, NHMA

The hearing opened at 9: 20 a.m.

Senator Carson opened the hearing by calling on the prime sponsor of the bill.

Summary of testimony received:

- Representative Kenneth Hawkins (testimony provided) stated that the people who are going to buy into the retirement system are the people who are going to retire.
 - Currently, depending on the numbers, 18-22% of people who start to work and are in the pension system leave within the first seven years. In the state workers about 25% leave within the first year.
- This RSA was brought forward during the late 70s or early 80s to recruit teachers, there was a shortage of them, which was the purpose of putting this legislation in. Group II and police have taken advantage of this and have also used this legislation for a recruiting tool. Representative Hawkins stated that we are the only state that allows 20 years and retirement at 45 years of age. The legislation would allow 70-80% of base pay at age 45 for retirement.
- This legislation passed through the House last year, but when it came over to the Senate it was amended for another purpose.
 - Senator Carson asked if this is the same thing that is included in SB
 - Representative Hawkins stated that he has not seen the final version of SB 3, but realizes that it was amended in Finance.
- Senator Larsen asked if this was also contained in HB 580, with Representative Hawkins indicated that it was not, and that was why this bill was brought forward.
 - Barbara Reid from the New Hampshire Municipal Association then spoke indicating that she was not opposed nor in support of this legislation, but wanted to explain some of the concerns that the NHMA has.
 - In SB 3, Section 23 the purchase of out of state service credit is repealed.
 - Ms. Reid asked managers within the Municipality and they stated to her, that yes, it was used as a recruitment tool.
- Provision, which is in current law, is not advantageous to the system,
 the way that it is written.

- The history of the statute was that if you were joining the NH Retirement System from out of state, you had to make that choice within 18 months whether you were to transfer into the NH Retirement System, at which time, the monies would also be transferred into the NH Retirement System. That requirement time period was repealed.
- Senator Luther asked is Ms. Reid was comfortable with the way that SB 3 addressed the issue, and Ms. Reid stated that SB 3 repealed this issue and that the way it is presently written, that it is financially at a disadvantage to be used as a tool for employment.
- Senator White then spoke as a co-sponsor to this bill and emphasized that this bill states that credits that have been purchased in the past that there was a missing component which is the time growth of money. Two-thirds of the dollars that are paid out are a result of earnings not the result of employee/employer contributions; they are the result of the time growth of money. The simplest solution is to repeal the ability to purchase service credits. If at a later date we need the recruitment tool, great care and study needs to be put into how the credits will be purchased. These issues cannot be underestimated.
- Bob Blaisdell (opposed) lobbyist for the Demers Group and also representing the New Hampshire Police Association and the New Hampshire Troopers Association then spoke. Mr. Blaisdell is in support of the amended version, which passed the House Pension Committee, but that was flipped on the floor. What the amendment did is say that you can continue to use as a recruiting tool to get good qualified people, but to buy into the system, you have to pay for the full actuarial cost, and stated he thought that was a fair compromise.
 - Senator Luther asked about the amended version of the bill and Mr. Blaisdell stated there was an amended bill which passed the Pension Committee in the House by 6-5 OTP/A 0624h. But, did fail by OTP motion of 88-215 according to the docket.

Hearing closed at 9:37 a.m.

in response to Rep Sullivan's email we would like to provide the following:

Service purchases are almost never to the advantage of the system because the members who make those purchases always have more information than the system does and is not representative of the system's average member. Therefore there is a great risk for anti-selection (the members getting the most benefits being the only ones that utilize the provision). However, service purchase provisions are not created to give the system an advantage. Service purchase provision are created to provide an advantage to the employer and the employee. The advantage to the employee is that it provides additional flexibility/benefits (which is usually desirable from the employees' perspective). The advantage to the employer is that it makes them more competitive in hiring and retaining quality employees that might not otherwise accept employment.

Because there is almost never an advantage to the system, if the plan sponsor decides the system should provide this benefit, the system needs to develop a method of calculating service purchase costs that:

- 1) fairly charge the members for the cost of the purchase; and
- 2) minimizes the risk to the system.

We believe the language in the statute that GRS helped develop allows the Board to achieve both of those objectives. It also allows the Board to adjust the calculations, as experience necessitates to continually ensure the method is in line with the objectives.
