Senator John Gallus, District 1- Prime sponsor

- Hearing opened at 9:38 a.m.
- Senator Gallus introduced SB 32, a bill to address how record keeping is conducted and reported for snow making in NH.
- Current law has been interpreted to require a withdrawal record from a river or pond to a storage pond, and then another record keeping requirement for a withdrawal from the storage pond to the snow making system.
- This requires additional administrative work as well as the potential of costly water metering systems.
- Parties of interest have been working on the language and unfortunately they were not able to finalize it before the bill went to print or even before today's hearing.
- Senator Gallus asked that the chair recess the hearing.

- Senator Odell: How burdensome is this?
 - Senator Gallus said it is over burdensome on recording standards and is something that should be addressed at this time.

MEMBERS OF THE COMMITTEE PRESENT: Senators Odell, Gallus, Bradley, Lambert,

MEMBERS OF THE COMMITTEE ABSENT: Senator Merrill

Sponsor(s): Sen. Gallus, Dist 1

What the bill does: This bill provides for measurement of water withdrawn for snowmaking and requires record keeping for such withdrawals.

Who supports the bill: Senator John Gallus, District 1; Jay Gamble, Mount Sunapee and Ski NH; Greg Goddard, Gunstock and Ski NH;

Who opposes the bill: No one.

Neutral Position: Brandon Kernen, NHDES

Summary of testimony received:

- Senator Odell reopened at 9:00 a.m.
- The Chair noted that Senator Gallus was distributing amendment #161s for the Committee's discussion.

Jay Gamble, Vice President and General Manager of Sunapee, Chairman of the Ski NH Legislative Committee

- Speaking to the amendment in support of the intent of both the original bill and the amendment.
- Ski NH supports the amendment and has been in talks with DES for several addition amendments that will be presented in the coming days
- A little background on snow making reporting:

- Up until the 2006 ski season, ski areas had been dutifully reporting their withdrawals to DES.
 - However, during the 2005 legislative session, a new law was passed relative to water withdrawals, transfers and discharges.
- At the time, ski areas were told that DES was just codifying what had been their information collection practices.
- Upon implementation, the process became more technical and complex than what their previous practices had been
 - Because there was not the latitude that the law and rules suggested.
- The amendment is intended to bring more certainty to the reporting process.
- Question from Senator Odell: Are these surface water withdrawals? Not major underground, right?
 - To the best of my knowledge, but New Hampshire has many different waters used.
- Question from Senator Odell: Just so the Committee understands, the amendment still needs changes in collaboration with the Department?
 - Yes, and they are very close with a little language needed.
- Senator Odell asking a question on behalf of Senator Merrill: Why in line 9 the phrase “approved by the commissioner” has been deleted and replaced with reference to “the manufacturer’s plated specs...”? Also, not clear on whether “water entering into the snowmaking system” is a disposal or a transfer according to definitions of chapter.
 - The Commissioner appeared to have broad discretion and changeable reporting, whereas if a pump has a name plate specs for the purposes of reporting we would stick to a quantifiable means of doing that whether it be flow meters or name plate data on pumps.
 - But, quantifiable data would be the words chosen for the bill rather than something that is at the discretion of because most of these systems have quantifiable capacities.

Greg Goddard, General Manager of Gunstock and past chair of Ski NH

- In support of the bill and its proposed amendment
- Believe close to an agreement with DES on additional amendment language.
- The existing law and rules have been interpreted to require ski areas to record every water movement as it relates to snow making.
- As business, found that some of the recording requirements were redundant because ski areas were counting the same water multiple times.
- Also, having to meter this process made it quite expensive as well.

- With the new language, ski areas will now be able to give DES more accurate information on water as it is withdrawn from a river or pond or as it is diverted from a natural source into the snow making system.
- Question from Senator Odell: Am I correct that this is all surface water withdrawals?
 - Not aware of any ground water withdrawals and to the best of knowledge it is all surface water.

Brandon Kernen, DES, Hydrology and Conservation Program

- The Department can support the amendment with a few clarifications that has to do with broadening some options for measuring water use beyond just the pump capacity or meter and that water from natural sources need to be reported.
- Since 1988, water reporting has been a requirement and rule in New Hampshire.
- What changed in 2005: changes were made to clarify that those requirements were legal to enforce.
 - JLCAR hadn't supported the rules previously.
- So the changes that were made did not have to do with changing requirements but rather the ability to enforce those requirements.
- Question from Senator Odell: Do you agree with taking the language out that gives discretion to the commissioner and changing it to the manufacturers plated specs?
 - That is allowed now under our current rules.
- Odell: What about the large surface water removal place like golf courses. Do they have the same requirements?
 - Ski areas use a much larger volume of water in a time of year when there is not a lot of free flowing water.
 - As they are in a mountainous region they often have multiple sources of water that they are pulling from to keep up with their high demands
 - Golf courses don't have to pull from as many sources because of the availability of water in the summer months and they use far less water than a ski facility.
- Question from Senator Odell: What happens to the data and why is it important?
 - Take the data and see how much water is available to estimate recharge for a given physical property and you can go out and create a map of the state that looks at your areas of stress, which let's us see if there is environmental problems or give that information to towns.
 - The towns often request this information.
 - Follow up on ground water: No one is using it for snow making at this time, there is some being used for cooling compressors which takes up a lot less water.
- Question from Senator Odell: How many gallons a day does it take to be a large?

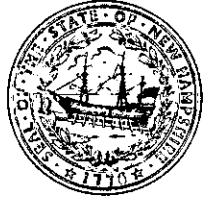

Dear Chairman Odell:

Thank you for the opportunity to comment on SB 32, which would modify RSA 488 relative to Water Use Registration and Reporting by changing the measurement and reporting requirements for water use associated with snowmaking.

The Department of Environmental Services (DES) does not support SB 32 in its original form because it is not consistent with the requirements of RSA 488:4, which states in part that "each withdrawal, discharge, or transfer required to be registered under this chapter shall be metered or measured by a technically appropriate and verifiable method...." The bill proposes to add a section, RSA 488:4-a, in order to clarify how measurement of withdrawals may occur for snowmaking at ski areas. However, it fails to clearly require that all natural sources of water from which withdrawals occur need to be measured. This is necessary in order to provide a complete understanding of water use for snowmaking by the ski areas.

At the public hearing on February 3, 2011, SB 32 was amended and many of DES's concerns with the original bill were alleviated with the exception of some minor clarifications. DES has since collaborated with representatives from the ski industry to draft the attached language that could be used to further amend SB 32. This possible amendment addresses our concerns with the original bill and its subsequent amendment. We believe that it also reasonably addresses the concerns of the New Hampshire ski industry by further clarifying in statute how ski areas might comply with the monitoring requirements of RSA 488. DES supports this amendment.

Thank you Mr. Chairman,

For the record, I am Jay Gamble, VP and General Manager of Mount Sunapee Resort. Today, I appear before you with a slightly different hat as the chair of Ski NH's Legislative Committee. Ski NH is the state association here representing 37 alpine and Nordic ski resorts throughout NH.

Ski NH supports the intent of Senate Bill 32 and today's proposed amendment. In addition to today's proposed amendment, Ski NH has also been in talks with DES about a couple of minor changes to the amendment language before you today and I believe we are close to reaching an agreement.

But first, a little bit of background. Up until the 2006 ski season, ski areas had been dutifully reporting their withdrawals to DES. However, during the '05 legislative session, a new law passed relative to water withdrawals, transfers and discharges. At the time we were told that DES was just codifying what had been their information collection practices.

Upon implementation, the process became more technical and complex than what their previous practices had been as there was not the latitude that the law and rules suggested. Therefore, you have the bill and amendment before you today that is intended to bring more certainty to the reporting process.

It deals with withdrawals as well as natural diversions of water that does not involving pumping.

Greg Goddard from Gunstock is also here today and will address the specifics of the bill in terms of how it affects a ski area with multiple sources of water for snowmaking.

Thank you for your time and I would be pleased to try and answer any questions you may have of me on this issue.

I have looked over all the amendments.

Re. SB 21: I think lines 9 and 14-15 need a little tweaking to make the sentence read properly. As amended, you end up with "Maintenance.....may be cleaned out...." Perhaps instead: "The maintenance of....." and then in lines 14-15 "storing and recycling water [may be cleaned out when necessary] to preserve their usefulness may be carried out without a permit from the dept." Also wasn't sure if all references in chapter should be consistent in terms of referring either to "do not need a permit" "without a permit from the dept" or "shall be exempt from a permit under RSA 482-A."

Re. SB 32: One question I have is why in line 9 the phrase "approved by the commissioner" has been deleted and replaced with reference to "the manufacturer's plated specs....." Also not clear on whether "water entering into the snowmaking system" is a disposal or a transfer according to definitions of chapter.

Re. SB 22: Numerous general questions (also w/ the other telecom bill). One specific one, though: In line 12 of amendment (also in bill as introduced)-- not sure what "combination of" means; seems vague. Personally, I hope these aren't exec'd today.
