What the bill does: requires the director of the division of motor vehicles to adopt rules relative to nonresident fees for motorcycle rider education.

Who supports the bill: Senator Rausch; Representatives Packard and Waterhouse; Bob Letourneau, Department of Safety.

Who opposes the bill: No one.

Summary of testimony received:

- Senator Rausch introduced the bill and indicated it was brought at the request of the Department of Safety.
- e Bob Letourneau, representing the Division of Motor Vehicles, Motorcycle Rider Education Program, explained RSA 263:34 b IV was amended in 2008 to allow drivers from other states to participate in NH's Motorcycle Rider Education Program. He cited the example of servicemen stationed at the Portsmouth Naval Shipyard, who are not allowed to operate a motorcycle on a federal base without training. The 2008 legislation allowed them to do so after having taken the training. However, fees for out of state applicants to take the training were not included in the revised law. SB 66 would allow the Director of Motor Vehicles to set training fees for nonresidents through Administrative Rules.

- Senator Stiles reiterated, "Guys on base can't drive motorcycles without first having training"? What if they have a valid license? Mr. Letourneau assured Senator Stiles that they could operate a motorcycle if they had acquired the proper training.
- Senator Rausch asked about out of state residents taking the NH training. Mr. Letourneau stated sometimes there is no availability in one state's program, or it takes too long to get a license. It happens frequently.
- Nothing changes for in-state riders with this bill.
- Senator Boutin informed Committee members this is similar to snowmobile training.

Future Action: The committee took no action on the bill.

> Testimony on SB 66 February 3, 2011

Good Morning Mr. Chairman and member of the committee:

For the record I am Bob Letourneau representing the Department of Motor Vehicles, Motorcycle Rider Education Program.

During the 2008 session this legislature amended RSA 263:34-b IV to allow drivers from other states to participate in our motorcycle Rider Education Program. This is good legislation, for example, service members stationed at Portsmouth or Pease while awaiting for repairs to a submarine or deployment cannot operate a motorcycle on any federal base without first taking an approved training course. This amendment to our law allows for them to take our training. What we forgot to do was to apply a fee to the out of state applicants.

Our Program is wholly paid for by the motorcyclists of New Hampshire through increased fees for their licenses and registration. Out of state people do not pay into the system. This amendment would allow the director to set fees through administrative rules with the recommendation of the Motorcycle Advisory Committee, as currently practiced since 1989.

- IV. Rider training courses shall be open to all residents of the state who either hold a current valid driver's license for any classification or who are eligible for a motorcycle learner's permit. The director may allow residents of other states who hold a current valid driver's license to take a rider training course only if an adequate number of rider training courses have been provided for New Hampshire residents.
- 263:34-c Rulemaking. The director shall adopt rules pursuant to RSA 541-A relative to:
 - I. Standards for the motorcycle rider education program as required under RSA 263:34-b, I.
 - II. Administration of the motorcycle rider education program.
 - III. Minimum standards for rider training courses as required under RSA 263:34-b, III.
- IV. Issuance and form of certificates of completion for rider training courses under RSA 263:34-b, V.
- V. The maximum tuition fee which may be charged by a private organization conducting a rider training course under RSA 263:34-b, VI.
- VI. Standards for an approved motorcycle rider education instructor preparation course under RSA 263:34-d, I.
- VII. Minimum requirements for the qualification of a rider education instructor as required under RSA 263:34-d, II.
 - VIII. Administration of the motorcycle rider safety fund established under RSA 263:34-e, I.
- IX. Disbursement of funds from the motorcycle rider safety fund as required under RSA 263:34-e, I.
 - X. Exemption from the licensing skills test under RSA 263:34-h.
- XI. Procedures for the collection of additional registration and permit fees under RSA 263:34-i.
