#### In the Year of Our Lord Two Thousand Twelve

AN ACT establishing a service animal registration commission.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1	1 New Section; Service Animal Registration Commission. Amend RSA 167-D by inserting after
2	section 10 the following new section:
3	167-D:11 Service Animal Registration Commission. There is established a commission to study
4	the registration of service animals.
5	I. The members of the commission shall be as follows:

18	attending to the duties of the commission.
19	III. The commission shall study the registration of service animals.
20	IV. The members of the commission shall elect a chairperson from among the members. The
21	first meeting of the commission shall be called by the first-named house member. The first meeting
22	of the commission shall be held within 45 days of the effective date of this section. Four members of
23	the commission shall constitute a quorum.
24	V. The commission shall report its findings and any recommendations for proposed
25	legislation to the speaker of the house of representatives, the president of the senate, the house
26	clerk, the senate clerk, the governor, and the state library on or before November 1, 2012.
27	2 Repeal. RSA 167-D:11, relative to the service animal registration commission, is repealed.
28	3 Effective Date.
29	I. Section 2 of this act shall take effect November 2, 2012.
30	II. The remainder of this act shall take effect upon its passage.

Dear Chairman McGuire and Honorable Committee Members:

My name is Tricia Piecuch and I am the Deputy City Clerk for the City of Nashua and the President of the NH City and Town Clerks Association. I submitting this written testimony today on behalf the NH City and Town Clerks Association to oppose HB1362 as amended. The Association did not oppose the original bill, but with this amendment being sought, the Association has changed their position.

These dogs are currently licensed by the city and town clerks, but do not pay a fee in accordance with RSA 466:8. Once the dog has been established in our systems as a service dog, it does not need to be re-established as one. Renewal and reminder letters are sent out to all dog owners, in accordance with RSA 466, for them to license their dog and if necessary to provide us with an updated rabies vaccination. In order to renew the dog license, the owners can do it in person, through the mail or even contact us if the rabies is up-to-date and we will send their license, since no fee is charged.

Licensing of dogs has been in place for over 120 years with the main reason being the protection of rabies control and by taking away this local control, from the clerks, it could affect public health safety. By the State doing the licensing, we no longer have access to information on these service dogs that live in our communities, making it more difficult on our animal control officers and police officers who are responding to calls.

The original legislation called for establishing a commission and we feel that this is where this should be discussed and if necessary changes made. Since the original legislation calls for a member of our Association to serve on the commission, we will be happy to work together to come up with a solution. Again, the NH City and Town Clerks Association opposes this legislation as amended and feels that the original bill ought to pass.

Madam Chair Carol McGuire and Members of the Committee,

I am Sandra Teti. As a service dog user, I support HB 1362.

For service dog owners who wish to do so, this bill would make it much easier for those of us with disabilities to register our service dogs.

Under RSA 466:8, our registration tags are free once we have provided proof by showing certification from a recognized training school, however, we must register them annually. For some with severe disabilities, the annual trip to the city/town clerk's office is difficult and a few service dogs go unregistered. A one time trip for these people, is manageable. Rabies vaccination documentation, when due, is easily mailed to the city/town clerk.

It also means less work for the city/town clerk as a service dog, until it has retirement, would only have to be registered once as opposed to annually.

Since registration tags are free for those of us who can provide proof, we feel it is only right to extend the same service to those who self train their dogs. In order to receive our dogs from a training school, we must submit medical records. Once trained, our dogs must pass, the Assistant Dogs International (ADI) public access test before we can leave for home with them. We feel that owners with medical documentation whose dogs pass the same test our dogs must pass, should be afforded the same free permanent registration tags.

The Governor's Commission on Disability would distribute these tags upon receiving applicable documentation.

NH would follow the lead of such states as OH and CA who already have permanent service dog registration laws in effect.

The cost of this is minimal. I suspect a pet food company might even be willing to sponsor this cause, thus covering this small expense for us.

RE: HB1362-AN ACT establishing a service animal registration commission

Dear Chairman McGuire and Honorable Committee Members:

My name is Tricia Piecuch and I am the Deputy City Clerk for the City of Nashua and the President of the NH City and Town Clerks Association. I submitting this written testimony today on behalf the NH City and Town Clerks Association to oppose HB1362 as amended. The Association did not oppose the original bill, but with this amendment being sought, the Association has changed their position.

These dogs are currently licensed by the city and town clerks, but do not pay a fee in accordance with RSA 466:8. Once the dog has been established in our systems as a service dog, it does not need to be re-established as one. Renewal and reminder letters are sent out to all dog owners, in accordance with RSA 466, for them to license their dog and if necessary to provide us with an updated rabies vaccination. In order to renew the dog license, the owners can do it in person, through the mail or even contact us if the rabies is up-to-date and we will send their license, since no fee is charged.

Licensing of dogs has been in place for over 120 years with the main reason being the protection of rabies control and by taking away this local control, from the clerks, it could affect public health safety. By the State doing the licensing, we no longer have access to information on these service dogs that live in our communities, making it more difficult on our animal control officers and police officers who are responding to calls.

The original legislation called for establishing a commission and we feel that this is where this should be discussed and if necessary changes made. Since the original legislation calls for a member of our Association to serve on the commission, we will be happy to work together to come up with a solution.Again, the NH City and Town Clerks Association opposes this legislation as amended and feels that the original bill ought to pass.

Chairwoman McGuire and Honorable Members of the Executive Departments and Administration Committee. I am pleased to come before you today as the sponsor of HB1362. Last vear. after the successful adoption by New Hampshire of the new definition of "service animal" under the Federal Americans with Disabilities Act, I was asked to file a bill to enact permanent service dog registration in New Hampshire. Annual registration may seem to be an inconsequential requirement. If you have impaired mobility, however, it can be anything but inconsequential. This legislation seeks to remove a statutory requirement that does nothing to enhance the life of a person who uses a service animal, and its enactment will not jeopardize public safety. In addition, this presents an option, not a requirement, for permanent registration.

You have before you an amendment (#2012-0490h) that replaces HB 1362 – which creates a study commission. I apologize for any inconvenience replacing the bill with an amendment may have caused you, or the public, in preparing for this hearing. In the time since filing the bill, I have been in contact with almost everyone who would have been represented on the Commission. There have been many revisions based on their input, and it is my hope that our work has yielded an amendment that addresses issues people have raised in the past. I understand that there have been other attempts to achieve permanent registration for service dogs. To assist in your work, I am including the current statute below.

Current NH law regarding registration of service animals which the amendment seeks to repeal and replace is as follows:

466:8 Exemption From. – No fee shall be required for the registration and licensing of a dog which has served with the forces of the United States and has received an honorable discharge therefrom. No fee shall be required for the registration and licensing of a guide dog which is used as a guide for a blind person, a hearing ear dog which is used by a deaf person, or a service dog which is used by a mobility impaired person. When a blind, a deaf or hearing impaired. or mobility impaired person is applying for a license. he shall present a proper identification card from a recognized guide dog, hearing ear dog, or service dog training agency or school.

# Q: What are the laws that apply to my business?

- A: Under the Americans with Disabilities Act (ADA), privately owned businesses that serve the public, such as restaurants, hotels, retail stores, taxi cabs, theaters, concert halls and sports facilities are prohibited from discriminating against individuals with disabilities.
- Q: How can I tell if an animal is really a service animal and not just a pet?
- A: Some, but not all, service animals wear special collars and harnesses. Some, but not all, are licensed or certified and have identification papers. If you are not certain that an animal is a service animal, you may ask the person who has the animal if it is a service animal required because of a disability.
- Q: What if a service animal barks or growls at other people or otherwise acts out of control?
- A: You may exclude any animal, including a service animal from your facility when that animal's behavior poses a direct threat to the health or safety of others. You may not make assumptions, however, about how a particular animal is likely to behave based on your past experience with other animals. Each situation must be considered individually.

### What is a Service Dog?

In the United States, the term "Service Dog" may be used synonymously with "Assistance Dog". An Assistance Dog is a dog trained to help a person with a disability in daily life. Many are trained by a specific organization, while others are trained by their handler, sometimes with the help of a professional trainer.

### **Classifications:**

There are three general types into which an Assistance Dog may be further classified. Most Assistance Dogs will be trained for only one of these, though "combination" dogs do exist.

**Dog Guides** assist the blind and visually impaired.

**Hearing Dogs**, or Signal Dogs, help the deaf and heard of hearing.

#### Service Dogs

describes dogs not specifically trained for visual or hearing impairment, such as Mobility Assistance Dogs, Seizure Response Dogs, and Psychiatric Service Dogs.



### **DGUNH's Mission**

The Dog Guide Users of New Hampshire is a support group that promotes the use of Service Dogs for the disabled through peer sup-

port, advocacy, education, and public awareness. The Dog Guide Users of New Hampshire also embraces all individuals who are interested in the care, handling, and/or raising of Guide, Hearing and Service Dogs for independent living.
