Re: HB 1631, allowing persons licensed to provide emergency medical services to work public gatherings and events.

Madam Chairman and Members of the House Executive Departments and Administration Committee:

The New Hampshire Trauma Medical Review Committee would like to voice our concern regarding HB 1631. Our Committee was created by statute to oversee the establishment and continuous improvement of the NH Trauma System. The Committee membership includes physicians, surgeons, emergency and trauma nurses, representatives from statewide EMS organizations, and members of other agencies involved in trauma care and injury prevention.

The proposed amendment in its current form removes the requirement that EMS providers have any medical oversight when hired as individuals to provide medical coverage at public events. It is outside the scope of practice of Nationally Registered Emergency Medical Technicians to independently diagnose, treat, and discharge patients. The role of EMT is to rapidly evaluate, stabilize, and transport patients. As such it is only appropriate that EMTs practice as part of a continuum of medical care.

We applaud event organizers across the state for their desire to provide a safe environment for the public. However, this amendment will not accomplish that goal. The amendment as proposed allows providers to function without an appropriate screening process and without any medical oversight. There are numerous safer options available when seeking to provide either medical coverage or first aid to event attendees.

The New Hampshire Trauma Medical Review Committee firmly asserts that this bill is unnecessary and unsafe. We respectfully ask that you vote "no" on HB 1631. Thank you for your time and consideration.

I regret that I am unable to attend the bill hearing today, but a severe case of pink eye is keeping me at home – and each of you safe from being infected by me. The doctor said treatment would make my vision blurry --- is the cure worse than the disease? Unfortunately that prediction was true and it is not safe for me to drive.

HOUSE BILL 1687-FN, AN ACT relative to state employee information available on the state transparency website. Sponsored by myself and Finance Chairman Ken Weyler and Finance Division I Chairman Bill Belvin is a simple but necessary bill.

The bill proposes to make a change to the transparency website and the language of that change is "b) Annual salaries of all full-time state employees, listed by pay type category and in a searchable format that includes the state agency, accounting unit, job title, position number, and whether the position is vacant or filled."

Finance Committees deal with position numbers, state agencies, accounting units and whether a position is filled or vacant. Last year's budget abolished many empty positions. However, when I chaired the Committee of Conference on HB2, we discovered that the Senate had chosen to add several positions back. We only had position numbers for those added back. Naturally the House wanted to know what those positions were and could not obtain that information due to a balky budgeting system and lack of manpower.

When the LBA was asked to produce a report showing agency and title for each position number added back to the budget, the C of C was told such a report would take between 50 and 100 man hours – man hours that were simply unavailable as the entire staff of the LBA was working from 7:00 a.m. until when we departed in the evening (typically around 11:00 p.m.) and both weekend days.

The inability of the state budget system to respond to other than the most routine reporting requests is a constant annoyance for legislators as well as state staff.

Had the above information been available on the transparency website, the House C of C members could have researched the positions added back and made responsible decisions. Since the majority of this information is already available, the computer process pulling and posting the information on the transparency website would need an adjustment to add these fields --- fields that are available within state computer systems.

Please support this needed bill and vote OTP.
