Summary of testimony received:

Hearing opened at 1:03 PM

Rep. Comtois, Belk 5

•Prime sponsor, this bill started in June 2011 as an effort to help farm stands as a focus on the homestead kitchen license. Our farm stand could not have others bake for us, it became too costly, they had to use the state's standardized recipes, and they'd have to submit our customers list to Health and Human Services. I started by trying to ease those regulations so small farmers and bakers could make a little extra money. I then learned that the raw milk distributors who could sell 20 gallons of raw milk a day were making cheese but could not sell it without a permit. I therefore added provisions in the bill to help them as well. The dept. of Health and Human Services has helped in this effort and even wrote the amendment.

•This bill allows people to bake non-hazardous foods up to \$10,000 gross a year as long as the food has a label stating you are unlicensed and the food was uninspected and includes ingredients and allergens. You will have to sell them yourself at home or at a farmer's market. Separately, the bill deals with the raw milk. Now farmers can take the 20 gallons of raw milk they can sell each day and either continue to sell it as raw milk, or now they can sell it as aged cheese, yogurt, kefir, cream or butter. That also has to be labeled and state that you are unlicensed. Since some people bring their own containers for the milk, we added signage requirements on the farm. This was voted favorably unanimously in the House. This will provide immediate relief for the small farmers in New Hampshire. This is a consumer-driven bill and these people do not advertise; they are sought out. Farmers who wish to sell to restaurants still need a license.

•<u>Sen. Sanborn:</u> Why can they only sell up to \$10,000 a year?

-Rep. Comtois: Health and Human Services provided that figure.

Everyone who showed up at the hearing was okay with the amount.

We can revisit this in the future as prices go up.

Kate Frey, Dept. Health & Human Services

. .

•In support, the department worked closely with the sponsor, the House committee, and the public to craft a bill that reduces regulations on homemade foods and dairy products while balancing food safety concerns. This exempts some homestead operations and products from licensure and allows the direct sale of some raw milk products without a milk producerdistributor license.

•Examples of nonhazardous foods permitted under this bill include jams, fruit pies, cakes, cookies, brownies, breads, muffins, dry mixes, coffee, candy, etc. Currently, there are two levels of homestead licensure. Level one relates to those who want to sell these nonhazardous products at their residence, farm stand, or a farmers market; level two allows licensees to sell products at retail stores and restaurants. HB 1402 allows those falling into level one to sell up to \$10,000 worth of products without a license. The bill clearly defines potentially hazardous foods and does not permit them to be made in a homestead kitchen.

•To add to what Rep. Comtois mentioned about milk sales, we specifically permitted aged cheese, aged up to 60 days, and not soft cheese because the commissioner believes strongly that soft cheese is more likely to be contaminated. HB 1402 enables micro-farmers to pursue entrepreneurial efforts without spending a considerable amount on compliance. •<u>Sen. Sanborn:</u> \$10,000 a year is only \$250 a week, how did you come up with the threshold?

-Ms. Frey: To make it clear, this only relates to the homestead food products not the milk. The original amount was \$5,000; \$10,000 seemed like the natural next step according to the House committee. We are happy to revisit that, but we are talking about things like cookies and cakes and they do not cost a lot.

Rep. Babson, NH Farm Bureau

. . .

•In support, five years ago I chaired the Agriculture committee and saw the that the Division of Food safety's regulations were so restrictive that people were giving up making these products. One farm in NH that had 27 varieties of jams gave up purchasing berries in NH because every jar of jam they made would have to be sent to a lab in Maine at a \$35 fee to be tested. At the time we drafted the Homestead license and it was a relief for growers, but now it is an albatross for them because of the increased demand. I thought we were lucky to get \$10,000 and if you would like to increase it to \$20,000, the Farm Bureau would say go ahead.

Dina Farrell, Micro Farmers of NH

•In support, this is a new group that was formed in January because both farmers and consumers believed there was real need for de-regulation on farmers. The milk producers were making dairy products and they were going to waste and to their pigs. As a full time farmer it is hard to bring in a complete income and the more money we are allowed to make, the better chance we can keep the farm running.

Dear Mr. Chairman and Members of the Committee:

The New Hampshire Farm Bureau (NHFB) is a federation of the ten New Hampshire county Farm Bureau organizations and consists of 3,000 Farm Bureau member families statewide. Our mission is to advocate on the issues important to the farmers and rural residents of New Hampshire.

Farm Bureau stands in support of *HB 1402*. The bill provides reasonable exemptions from homestead food licensing requirements for homestead operations (defined as a residential, non-commercial kitchen) with gross sales of non-potentially hazardous foods of up to \$10,000 a year. Non-potentially hazardous foods include baked items (such as breads, muffins and cookies), candy, jams and jellies. Potentially hazardous foods, which require temperature control for safety, are not included. Nor are processed acidified and low acid canned foods, which are also classified as potentially hazardous.

The bill also expands current law by providing in addition to selling a limited amount of raw fluid milk, the option to a milk "producer-distributor" (someone milking livestock and selling the milk) to process and sell raw milk products: cheese aged 60 days, yogurt, cream, butter and kefir. This option would be allowed provided the producer-distributor stays under the current limit of an average of 20 gallons of raw fluid milk in total a day.

This legislation will allow small-sized farm operations to get started in direct marketing products without having to spend considerable money complying with regulations. Food safety concerns are minimized based on the limited volume of product exempted and the requirement that sales are limited to those made directly from the operators homestead, farm stand or at a farmer's market. These sales will be made directly to consumers who will have sought-out these operations and who will have the opportunity to see first-hand the conditions the products are produced. In addition, the law contains specific labeling or signage requirements.

For these reasons **Farm Bureau supports** *HB* 1402 and we ask the Committee to recommend it Ought-to-Pass. We thank you for your time and consideration.

Senate Health and Human Services Committee Testimony on House Bill 1402 April 19, 2012

My name is Kate Frey, and I am the Legislative Liaison for New Hampshire Division of Public Health Services (DPHS) within the Department of Health and Human Services, which oversees the Food Protection Section.

I am here today to speak in support of HB 1402, relative to the sale of homemade food and licensing of certain milk producer-distributors, as amended in the House. The Division worked closely with the bill sponsor, Rep Comtois, the Environment and Agriculture committee, and constituents to make HB 1402 an effective piece of legislation which reduces the regulation of homemade foods and certain dairy products while balancing food safety concerns. This has been a very collaborative process and has resulted in timely topic considering this committee had related conversations when discussing HB 234, relative to food protection, last fall.

This bill exempts certain homestead food operations and homestead food products from licensure by the department. It also allows for direct sales of raw milk products without a milk producer-distributor license for certain small-scale dairy producer-distributors.

The following changes included in HB1402 are;

• Under RSA 143-A:5, an exemption is added to the Food Service Licensure statute to allow homestead food operations selling less than \$10,000 in annual gross sales, of non-potentially hazardous food from the homestead residence, farm stand, or at a farmers' markets. Examples of non potentially hazardous foods include; jams, jellies, double crusted fruit pies, cakes (including wedding and birthday cakes), cookies, brownies, breads, muffins, scones, biscotti, whoopie pies, tarts, packaged spice blends, dry mixes (soups and dips), roasted coffee, candy, chocolates, caramels, lollipops, fudge, popcorn, granola, vanilla, olive oil (rebottling), hot sauce and mustards.

Currently there are 2 levels of homestead licensure. Level 1 allows non-potentially hazardous food to be sold at the license holder's residence, farm stand or farmers market. Level 2 licenses allow the licensee to sell their products at retail stores and restaurants. Under HB 1402 those producers who have sales under \$10,000 and wish to only sell their product from their homes, farms or farms stands, do not need to obtain a license.

- Requires homestead food operations that exceed the \$10,000 maximum annual gross sales limit or wish to sell food non-potentially hazardous foods products at retail to be licensed under RSA 143-A:4.
- Under RSA 143-A:12, the bill defines foods that are potentially hazardous food and therefore are not allowed to be made in a homestead kitchen. A potentially hazardous food is food requiring temperature control for safety because the food is capable of supporting the rapid growth of pathogenic or toxigenic microorganisms or the growth of toxin production of *Clostridium botulinum*—the bacteria that causes botulism.

- Amends RSA 184 to allow milk producer-distributors who produce for sale milk products made from less than 20 gallons of raw milk; such as cheese aged at least 60 days, yogurt, cream, butter, or kefir to do so without a license, provided these products are offered as direct sales from the producer-distributor's own farm, farm stand, or at a farmers' market to the consumer and within the state of New Hampshire only. The current law only allows for the sale of raw milk under these circumstances. HB 1402 allows for the sale of other raw milk products with a license.
- Both raw milk and homestead food will be required to meet labeling requirements outlined in HB 1402, including a statement that these products are exempt from New Hampshire licensing and public health inspection.

This legislation does not eliminate licensing entirely and if a producer wishes to be licensed they can do so. The intent of the legislation is to enable micro farmers to pursue entrepreneurial efforts without having to spend a considerable amount of money to comply. The Division is supportive of these efforts provided the consumer is aware the products are exempt from licensing and inspection.

Thank you for this opportunity to address the committee on this bill. I have a staff member from the Food Protection Section here today, Colleen Smith, and we can answer any follow-up questions you may have.
