The 19 department shall not suspend or revoke certification except for just cause until the certified installer 20 has had an opportunity to be heard by the department. An appeal from such decision to revoke or 21 suspend certification may be taken pursuant to RSA 21-O:14. All certified individuals who perform 22 such culvert work shall submit a quarterly report to the department identifying their work for that 23 24 quarter.

25 XVIII. The department shall develop a certification program in conjunction with the 26 University of New Hampshire Technology Transfer Center for municipal culvert installers in 27 accordance with paragraph XVII, for the purposes of maintaining drainage infrastructure.

### **Hearing Report**

**TO:** Members of the Senate

**RE:** Hearing report on SB 247-LOCAL – relative to certifying municipal culvert installers.

**HEARING DATE:** February 7, 2012

**MEMBERS OF THE COMMITTEE PRESENT:** Senators Barnes, Forrester, Merrill, Boutin and Stiles.

MEMBERS OF THE COMMITTEE ABSENT: No one.

**Sponsor(s):** Senators Forrester, Gallus, Merrill and Sanborn; Representatives Chandler, Greemore and Worsman.

What the bill does: authorizes the Department of Environmental Services to develop a certification program in conjunction with the University of New Hampshire Technology Transfer Center for municipal culvert installers.

Who supports the bill: Senators Forrester, Gallus and Odell; Representatives Chandler, Worsman and Charron; Attorney Cordell Johnston, New Hampshire Municipal Association; Charlie Goodspeed and William Meagher, University of New Hampshire Technology Transfer Center; Rene Pelletier, NH Department of Environmental Services; Craig Green, NH Department of Transportation; Margaret Watkins, NH Audubon Society; Alan Cote, Town of Derry; Michael Faller, Town of Meredith; John Trottier, Londonderry; Carl Quiram, Goffstown.

Who opposes the bill: Theodore Kupper, Provan & Lorber, Inc.

#### Summary of testimony received:

•Senator Barnes opened the hearing at 9:40 am and introduced the prime sponsor, Senator Forrester, who explained the bill was a collaborative effort between the Department of Environmental Services ("DES"), the Department of Public Works ("DPW") and the University of New Hampshire's ("UNH") Technology Transfer Center. It creates a volunteer certification program for road agents and the DPW to become certified in culvert repair, and authorizes quarterly reporting to DES. It will allow towns to move more quickly and efficiently, and lessen the burden on the DPW. Further refinements to the bill have been made resulting in Amendment #2012-0613s, which was distributed to committee members.

•Senator Boutin wondered if the program might be offered at community colleges around the state as well as the University, to lessen travel and overnight accommodation expenses.

•Theodore Kupper, a professional engineer with 25 years of experience, believes allowing culverts to be designed by non-engineers participating in a one-day certificate program is a serious deviation from the purpose of professional engineering licensure. Authorizing a culvert certification program also violates both RSA 310-A:2-b and RSA 310-A:11.

•A qualified professional engineer should be involved whether you call it "design" or "replacement" of a culvert. Professional engineers need to be involved in the design and operation of the built environment, not bypassed by certificate programs.

•Senator Merrill inquired as to whether Mr. Kupper had reviewed Senator Forrester's amendment. Mr. Kupper indicated he had, but that his problem is with the certification program. If one culvert is replaced in the system, upsize it or downsize it, then the entire system has been changed. A certificate program is not intended to teach anyone about these systems.

•Rene Pelletier, Department of Environmental Services ("DES"), expressed the Department's full support for the bill. He distributed language similar to Senator Forrester's amendment, but his language includes a biennial \$80 permit fee to be paid to DES for expenses it will incur in administering the program. Senator Forrester stated she cannot support the \$80 fee proposed by DES.

•Currently, personnel involved in a routine roadway maintenance program can replace, repair or upsize up to a 48-inch culvert. Anything above a 48inch culvert ought to have an engineer's design, because that signals a historic, significant break in the watershed.

•This program was developed as a way to expedite the repair process. If personnel were out doing road work or repairs and found another culvert downstream that was rusted or corroded, this bill gives them the authority, if they were certified or an engineer, to make the decision to either replace or repair the culvert. They then would submit a quarterly report with certification. •It is cost effective for municipalities to go through the UNH Technology Transfer Program. The training will give participants in the program the appropriate knowledge to enable certification.

•Senator Merrill sought clarification that DES would determine the requirements for certification and issue the permit. The original bill indicated UNH would certify. Mr. Pelletier stated individuals would take the course at UNH, take the exam and upon passage, apply to DES for certification. Once certified, an individual would be required to take Continuing Education Units ("CEUs"), to insure they keep current with best management practices.

•Professional engineers who are duly licensed by the New Hampshire Board of Professional Engineers are exempt from the program requirements. They can take advantage of the quarterly reporting as well.

•Michael Faller, Public Works Director for the Town of Meredith, supports Senator Forrester's amendment and opposes the proposed DES fee. He stressed it is vital to maintain these culverts and protect the environment.

•This bill does not prohibit a municipality or a state agency from obtaining assistance from a professional engineer if need be.

•Charlie Goodspeed of UNH introduced members of their training program to the committee. He then reviewed the history of the Technology Transfer Program. The culvert certification course will run 3-6 hours in length. Those that pass the exam will have their information forwarded to DES for certification. The University will not assume the liability of certification. They will offer retraining on an annual basis. The charge for the course will be approximately \$40-\$70. They anticipate the certification course will enroll approximately 15 individuals per course. The first course is slated to be given shortly after the bill takes effect.

•John Trottier, Assistant Public Works Director for the Town of Londonderry and a licensed civil engineer practicing for 25 years, favors the amendment and opposes the proposed fee. Municipalities will be able to perform culvert repair work in an expeditious, cost-effective and efficient manner.

•Carl Quiram, a public works official and professional engineer, indicated the 48-inch culverts currently being maintaining on farm and local roads are not designed systems. They are merely old pipes put across the road so that vehicles could pass through. DPW needs to be able to respond to these situations immediately.

•Mr. Quiram indicated that a coalition of various public works associations in the state also supports the bill.

•Craig Green of the Department of Transportation voiced support for the language offered by DES.

•Margaret Watkins of the NH Audubon Society, reminded committee members that streams are important corridors for wildlife, i.e., fish. It is environmentally important to have a well designed and properly installed culvert system over such streams. The Society supports certification of installers.

•Senator Barnes closed the hearing at 10:34 am.

Action: Senator Stiles made a motion to adopt Amendment #2012-0613s. Senator Forrester seconded the motion. The vote was 5-0 in favor. Senator Stiles then made a motion of Ought to Pass with Amendment on SB 247-LOCAL. Senator Merrill seconded Senator Stiles' motion. The vote was 5-0 in favor. The committee then unanimously voted to place the bill on the Consent Calendar. Senator Forrester will report the bill out of committee.

Dear Chairmen Barnes and Members of the Senate Public and Municipal Affairs Committee,

I am writing on behalf of the Audubon Society of New Hampshire in support of SB247-L. We are a statewide non-governmental organization dedicated to protecting New Hampshire's environment for wildlife and for people.

SB 247 authorizes the Department of Environmental Services to work with the University of New Hampshire Technology Transfer Center to develop a certification program for municipal culvert installers. This program would ensure that culverts are installed and maintained in a way that provides safe roadways and protects the ecological integrity of streams. It would also benefit communities that employ certified installers by expanding the permit by notification program to include larger culverts than at present.

Culverts are essential features in our transportation network, and if designed appropriately, can provide both effective drainage and safe passage up and down stream for aquatic species, including fish, amphibians, reptiles, invertebrates, and some small mammals. However, if they are improperly designed and/or installed, culverts can prevent passage of aquatic wildlife within stream corridors, resulting in drainages that are severely depleted in native biodiversity. They are also more likely to cause serious damage during major flooding events as a result of inadequate sizing, excessive erosion, or other avoidable hydrologic phenomena.

New Hampshire currently has an estimated 17,000 culverts – a number that is likely to increase in the forseeable future. The potential for these structures to allow the flow of water and survival of stream organisms depends entirely on how they are designed, installed, and maintained.

We urge you to vote SB 247 Ought to Pass.

#### ATTACHMENT TO DES COMMISSIONER THOMAS BURACK LETTER OF TESTIMONY TO SENATOR JOHN BARNES, JR. ON SB 247 DATED FEBRUARY 2, 2012

AN ACT relative to certifying municipal culvert installers.

#### Be it Enacted by the Senate and House of Representatives in General Court convened:

2 New Paragraphs; Excavating and Dredging Permit; Certified Individuals. Amend RSA 482-A:3 by inserting after paragraph XVI the following new paragraphs:

XVII. State and municipal public works employees who have fulfilled the requirements of a certification program developed by the department of environmental services may maintain, repair, replace, or modify culverts up to a maximum diameter of 48 inches, or the functional hydraulic equivalent, as long as the structure can pass flows from the contributing watershed without causing damage to upstream or downstream properties, and the work is done in accordance with best management practices to protect water quality, without prior notification to the department.

XVIII. The department shall develop an installer's certification program, in accordance with paragraph XVII, and shall determine the requirements for certification, including continuing education requirements, in accordance with a program jointly developed with the University of New Hampshire Technology Transfer Program. Professional Engineers who are duly licensed by the New Hampshire Joint Board of Licensure are exempt from the certification program requirements of this section. All certified individuals who perform such work, or certified individuals who are responsible for the work, shall submit a quarterly report to the department fully identifying the work that they performed during each quarter.

XIX. The department shall issue an installer's permit to any individual who submits an application provided by the department, pays a fee of \$80 and has satisfactorily completed the program in accordance with paragraphs XVII and XVIII. Permits shall be issued from January 1 and shall expire December 31 of every other year. Permits shall be renewable upon proper application, payment of a biennial permit fee of \$80, and documentation of compliance with the continuing education requirement of paragraph XVII. The installer's permit may be suspended, revoked or not renewed for just cause, including, but not limited to, the installation of culverts in violation of this subdivision or the refusal by a permit holder to correct defective work. The department shall not suspend, revoke or refuse to renew a permit except for just cause until the permit holder has had an opportunity to be heard by the department. An appeal from such decision to revoke, suspend or not renew a permit may be taken pursuant to RSA 21-O:14. All fees shall be held in a non-lapsing fund identified as the wetlands and shorelands review fund established in RSA 482-A:3, III.

3 New Paragraph; Rulemaking. Amend RSA 482-A:31 by inserting after paragraph IV the following new paragraph:

V. The certification program for state and municipal culvert installers under RSA 482-A:3, XVIII.

Effective Date. This act shall take effect 60 days after its passage.

Professional engineers are mandated by law in New Hampshire to protect life, health and property and to promote public safety. (310-A:2 Definitions. – III. "Practice of engineering" means any professional service or creative work requiring education, training, experience, and the application of advanced knowledge of mathematics and physical sciences, involving the constant exercise of discretion and judgment, to such services or work as consultation, investigation, evaluation, planning, design, responsible oversight of construction, and responsible oversight of operation, in connection with any public or private utilities, structure, buildings, machines, equipment, processes, works, or projects, wherein the public welfare, or the safeguarding of life, health, or property is concerned.)

This is an obligation that most professional engineers I know take seriously. It is important that this legislative body understand this professional obligation because I believe allowing culverts to be designed by non-engineers participating in a one-day certificate program is a serious deviation from the purpose of Professional Engineering Licensure. In fact, I believe authorizing a culvert certificate program also violates New Hampshire laws that are already on the books. (310-A:2-b Jurisdiction of the Board of Professional Engineers; Regulation of Scope of Practice. – No agency or subdivision of the state shall adopt any rule, regulation, standard, code, ordinance, or policy that restricts or limits the scope of practice of any licensed professional engineer, whose practice shall be within the sole jurisdiction of the board of professional engineers and 310-A:11 Licensure Required. – No person shall practice engineering in this state... without a professional engineer's license issued under this subdivision.)

Conflict with existing State laws aside, the primary reason this culvert certificate program is so dangerous lies entirely with an understanding of how an engineer is educated and trained. Professional Engineers apply logic-based reasoning to the design of relatively simple components, that when these components are combined; they form a complex functioning system that performs to accomplish a particular goal. Buildings need masonry, steel, electrical, HVAC and plumbing systems to function properly. Wastewater treatment plants accept sewage and through mechanical and chemical processes, treat that sewage to form an effluent that can be returned to nearby rivers without any health implications. And so it is with storm drainage systems: Hydrology allows professional engineers to study the combination of rainfall, topography, soils, vegetation and impervious surfaces. Hydraulics allows professional engineers to study the flow of that rainfall over surfaces, in open drainage and finally in closed conduits. The unique quality of these professionally designed systems is that these relatively simple components work together so the outcome is the safeguard of life, health and property and to promote public safety and welfare. Change even one of the components of a designed system and the system may experience problems. The system may even fail catastrophically.

If a culvert "washes out" and the owner calls me to look at helping them with a replacement, I want to know why the culvert failed in the first place. Was it undersized? Was it installed incorrectly? What effect will a larger (even one-size up) culvert have on properties downstream? My point here is that a qualified professional engineer should be involved whether you call it "design" or "replacement". Remember that as PE's; we are

responsible for public safety. If a culvert fails and "washes out" the road you live on, will the fire truck or ambulance be able to get to your house to extinguish the fire, stop your heart attack or respond to a serious accident?

The general public has experienced this type of systems safety for over 100-years and has enjoyed safe air, road and rail services. We have enjoyed high-quality, safe drinking water and the lack of fatal sewage-borne diseases. We have experienced uniform and consistent safety in our buildings and on our bridges. New Hampshire towns and cities function regardless of the weather outside because of the storm drainage systems designed by Professional Engineers. These systems function invisibly to the general public without so much as a thought to the safety of the users. I would like to see this continue for another 100-years or longer. In order to do that, Professional Engineers need to be involved in the design and operation of the built environment not by-passed by certificate programs. Thank you.
