Summary of testimony received:

Senator Merrill, Dist 21

- This bill was filed at the request of the Dover Youth to Youth group. This group has done a very good job getting the word out on the problems of abusing tobacco and alcohol.
- These types of games can encourage excess drinking. Our neighbors in Vermont and Maine have similar regulations. Bars are certainly not the only place these games are played. We currently regulate other activities at bars like dancing and darts.

Senator Sanborn disclosed that he owns a restaurant/bar but plans to participate in the process on this bill.

- Senator Sanborn commented that we currently have statutes that prohibit these activities.
- In response to questions from the Committee, Senator Merrill responded that this is geared towards on premise activities.

Rep. Watters, Straf 4

• The Dover Youth to Youth group is very good at identifying what our future problems will be and finding a way to address them today.

Commissioner Michael Milligan, NH State Liquor Commission

• Supports the concept of this legislation. Would prefer to see this as an amendment to current statute, not a brand new section of statute.

Madison Retrosi, Dover Youth to Youth

- This bill was introduced at our request because we believe that drinking games such as beer pong can encourage people to drink more or drink faster than they normally would. We all know that drinking too much too fast can result in a variety of consequences, and in an extreme case, could even kill a person due to alcohol poisoning. We feel that drinking games encourage people to binge drink.
- This law would have no effect on people playing drinking games in their own homes. But in establishments, generally people go somewhere else after drinking in that location. If people try to drive drunk, they can hurt themselves and others. If they chose to go to a different establishment, the new place could be put to blame for over serving that person. Drinking games would have the most serious consequences if played at licensed establishments.
- Another consideration is how teens perceive these games. My group noticed a local bar that was advertising a "Thursday night Beirut tournament" on their Facebook page. Teens could see these games as just fun with no serious consequences attached. If these games are held in official establishments, it could come across like nothing is wrong with them.
- Putting a ban on drinking games at bars would reduce the possibilities of people over consuming alcohol, and therefore reducing the chances of being stricken with a consequence of binge drinking.

Dana Mitchell, Dover Police Dept

• This bill would draw a clear bright line that says you can't do this. There are certainly establishments that host drinking games. If this is currently not allowed than it's not clear enough. We need these statutes to be clear and specific. If smart people disagree on if this is currently allowed or not then we need to clarify the law.

Eddy Edwards, NH State Liquor Commission

• This is unnecessary, current law is clearly understood by those we license. You can have games as long as alcohol is not involved. The most dangerous forms of drinking take place in locations that are not licensed.

Peter Garp

• Current rules say you can give away wine at wine tastings. Is wine tasting considered a game?

Henry Veilleux, NH Lodging & Restaurant Association

• Expressed concern with the current draft of the bill. Believes that current statute is adequate and this change could confuse the issue relative to can a venue have darts or pool tables. Supports the concept of the bill.

Dear Senator Prescott and Honorable Members of the Committee,

On behalf of New Futures, a nonpartisan, nonprofit organization that seeks to prevent and reduce alcohol and other drug problems in New Hampshire through advocacy, education, and collaboration, I write to express our support for SB 251. SB 251 prohibits games or contests that encourage the excessive consumption of alcohol and would be an important tool in preventing over consumption, particularly among the cohort of young legal drinkers most likely to participate in such games.

Current data show that the cohort of legal drinkers aged 21 - 25 have the highest rates of any age cohort for alcohol use, binge drinking, heavy alcohol use, and driving under the influence. According to the 2009 National Survey on Drug Use and Health among young adult drinkers aged 21 - 25:

- 70.2% report current use (at least one drink in the last 30 days);
- 46.5% report binge use (five or more drinks within a several hour period on at least one day in the last 30 days);
- 15.1% report heavy use (binge use on each of five or more days in the last 30 days); and
- 24.8% report driving under the influence at least once in the last year.

The Liquor Commission statutes generally seek to maintain proper controls over the sale of alcohol by providing on-premises licensees flexibility in their business practices as long as the licensees do not violate the terms of their license or the public health and safety statutory provisions that prohibit service to minors or intoxicated persons. However, in cases where licensee practices so clearly encourage excess consumption, the Liquor Commission statutes expressly prohibit such practices. The most recent example of such a provision is RSA 179:31: XIII, enacted in 2011, which requires any on-premises licensee to make food readily available to patrons any time the licensee is advertising or promoting alcoholic beverages at reduced prices. There was no objection to the enactment of this requirement in large part because the risk of excess consumption when reduced price alcohol was available without food was obvious.

We believe that a similarly clear and direct connection exits between the conduct of the games described in SB 251 and the risk of overconsumption. Under such circumstances, a statutory prohibition on such high risk activities is an effective way to prevent excess consumption without imposing a significant burden on licensees.

Thank you for your attention to this important issue. We respectfully request that the committee recommend SB 251 ought to pass. Please do not hesitate to contact me if you have questions or need additional information.

On behalf of New Futures, a nonpartisan, nonprofit organization that seeks to prevent and reduce alcohol and other drug problems in New Hampshire through advocacy, education, and collaboration, I write to express our support for proposed Amendment 2012 - 0508s to SB 251. SB 251, as amended by 2012 - 0508s would prohibit a licensee from sponsoring, permitting, or encouraging "on the licensed premises, any game in which a patron is encouraged or required to consume alcohol as a condition, consequence, or result of participation or is rewarded alcohol as a prize for participation."

The amendment is the result of discussions between the sponsor, the citizen group that brought the issue to the attention of the sponsor, and the New Hampshire Liquor Commission. We believe that SB 251 as amended will be an important tool in preventing over consumption, particularly among the cohort of young legal drinkers most likely to participate in such games. Current data show that the cohort of legal drinkers aged 21 – 25 have the highest rates of any age cohort for alcohol use, binge drinking, heavy alcohol use, and driving under the influence. 2009 National Survey on Drug Use and Health.

New Futures supported the original bill (Letter of January 24, 2012 to Senator Russell Prescott from Tricia Lucas) and believes that SB 251 as amended is fully consistent with the purpose of the original bill – to prohibit a practice that clearly encourages excess consumption.

The proposed amendment is an example of the best in legislative practice in which citizens, legislators, and advocates work together to produce a compromise that all can support to address an important community concern. We respectfully request that the committee recommend SB 251 ought to pass as amended by Amendment 2012 - 0508s. Thank you for your attention to this important issue. Good morning, my name is Maddie Retrosi; I'm a junior at Dover High School, and am also a member of the Leadership Team at Dover Youth to Youth. Youth to Youth is an after-school drug prevention advocacy program that consists of over 60 middle and high school students in Dover. Each year our group gives dozens of educational presentations, creates media, and takes on advocacy initiatives, which is why I am here.

Our group brought forth the idea for this piece of legislation because we feel that drinking games such as beer pong can encourage people to drink more or drink faster than they normally would.

We all know that drinking too much too fast can result in a variety of consequences, and in an extreme case, could even kill a person due to alcohol poisoning. We feel that drinking games such as beer pong are encouraging people to binge drink.

This law would have no effect on people playing drinking games in their own homes. But in establishments, generally people go



somewhere else after drinking in that location. If people try to drive drunk, they can hurt themselves and others. If they chose to go to a different establishment, the new place could be put to blame for "over serving" that person. Drinking games would have the most serious consequences if played at licensed establishments.

Another consideration we must look into is how teens perceive these games. My group noticed a local bar that was advertising a "Thursday night Beirut tournament" (Beirut being a drinking game similar to beer pong) on their facebook page. I know for a fact that teens like facebook, so they could easily see this advertisement. Teens could see these games as just fun, no serious consequences attached. If these games are held in official establishments, it could come across like nothing is wrong with them.

In closing, drinking games can be dangerous because they can cause a person to drink more and drink faster than they normally would. Most people see these games as just a way to have harmless fun. Being allowed to hold or host them in bars or other licensed establishments is a bad idea, seeing as the consequences are raised significantly when the factor of travel is incorporated into the equation. Putting a ban on drinking games at bars would reduce the possibilities of people over consuming

alcohol, and therefore reducing the chances of being stricken with a consequence of binge drinking.
