Good morning Chairwoman Pantelakos and members of the Criminal Justice Committee,

For the record my name is Jill Rockey and I am the Executive Director of the Crisis Center of Central New Hampshire located in Concord. I am here today to speak to you on behalf of the 14 crisis centers who are member programs of the New Hampshire Coalition Against Domestic and Sexual Violence. Last year crisis centers in New Hampshire advocated for thousands of victims of sexual assault and domestic violence. We are in support of HB165 as drafted.

Some of you may remember me in my former role. In June of last year I retired as a Sergeant in the State Police Major Crime Unit. I was the Commander of the Family Services Unit and the Missing Persons Unit. I was also the first trooper assigned to New Hampshire's Sex Offender Registry in 1999 and I was brought back into the unit 2006 to assist in implementing the Adam Walsh Act.

I believe this committee will find after studying our current laws, both the registerable offenses and the registration requirements, there are areas of the law that can be improved upon. As an example, when changes were made to the child pornography statute we did not include a provision for predators who groom child over the internet. Unfortunately this means there are still offenders that can move to New Hampshire and aren't required to register when they would be required to register in the state where they committed their offense. Had the Internet Crimes Against Children Task force been asked for their input while that bill was being drafted, they could have been a tremendous resource.

We would also encourage you to look at the 2 different systems of registration. By offense as we do in New Hampshire and by evalution as they do in Massachusetts. Different forms of these 2 systems are utilized throughout the U. S. Both have their pros and cons.

While I could go on about this subject, the member programs of the New Hampshire Coalition support a thoughtful review of our current system to ensure our limited resources are being used to effectively manage our sex offender population.

I would be happy to be a resource for this commit.

I appear before you today in support of HB 165, because as a Registrant, while I do feel there is a necessity for seeking a way to protect the kids, this is a very flawed and failed system. It has given parents the false expectation that by having this registry, and viewing who is on it, that is all they need to do to protect their kids, as the police caught them all, and that is just wrong.

In my experience all this registry does is hurt people, put children in jeopardy, and put people in fear, while providing parents with a false sense of security.

This should be about protecting the kids, not just condemning the perpetrators. Instead what it really does is punishes many people beyond the scope of Justice and fairness, to the point that they must become a drain on society. Kids and their parents know what is right, and what is wrong. Spending all of a parents time viewing a website to see who is on it does little to stop most molestations. The idea of just not letting the ones that have been caught and identified near your kids does not mean that Law Enforcement, or anybody, has identified all those capable of this crime. I hope you are aware that a 2006 report for the Ohio Sentencing Commission said 93 percent of molestation victims were well known to their perpetrators, over half the offenders victimized close relatives, and 93 percent of molesters had never been arrested for a previous sex crime.

In 1987, 25 years ago, almost ten years before this even became law, I was foolish enough to accept a Plea Deal that sentenced me to two years probation and to get private counseling. Think about that, if I was heinous criminal why such a deal? One year before I should have easily been able to get the charges annulled, this law went into effect and even though it was not part of my sentence, it was immediately imposed on me as an additional sentence by an act of legislation. By being on this list it has put me and my family in jeopardy, has limited my ability to gain meaningful employment despite my work qualifications, and the final result is that now I must subside on food stamps to feed my family while struggling to keep a roof over our heads. And then there are the constant threats of harm or damage to my person and family by people claiming they support justice, and only want to protect the kids.

I invite you to look at the Sex Offender Registry and laws of Maine, where only those who are a real continuing threat are kept on the Registry after ten years. I have spent the last 15 years working to help Veterans and their needs, and now this Registry is being used against me to force me from that righteous endeavor. NH's Law offers no chance for redemption, little chance for appeal, and allows more harm to be done than good.

I'm not for ending the Registry, but I am for making it effective to protect the kids, while not harming others by its implementation. Education of the kids and parents, coupled with the identification of real threats, and how to expose them, is the key, not a website with pictures and addresses that says these are your only threats. But that is how the public perceives this Registry – if somebody is on it they are the threat, nobody else. That puts kids in jeopardy.

To the Members of the Criminal Justice Committee,

My name is Laurie Peterson. I was born and raised here in NH and am currently raising my 3 children, ages 7, 10, & 12 here in NH. I love this State and like any parent, I love my children. I want to protect them and keep them safe as much as I possibly can. However, as any parent knows, there are risks to raising children. We are not perfect parents, our children make mistakes, take risks, and sometimes things don't go as planned. Risk is such a funny word. It is simultaneously a brave thing and a thing to be avoided. In our own lives, we determine risk on a case by case basis. Should I start a small business? When should I let my son have a cell phone? These are important questions and the answer is different for everyone.

And so it is with the current NH State Sex Offender Registry. Our registry does not determine risk. It classifies offenders based on the sex crime they were ultimately convicted of, not charged with. It classifies offenders based on the number of counts, not the nature of the crime. There are offenders registering as a tier 3 offender that are guilty of having an underage girlfriend, and offenders that performed 2 sexual acts at the age of 50 on a 15 year old who are registering as a tier 2 offender. I know this because my husband was forced to register as a tier 3 offender here in the State of NH not so long ago. The last year he registered, 2010, he registered 10 separate times in the calendar year. Each vacation, each change of vehicle, each change of job required him to return and update his information. The law, in its current state, is unbalanced and is a miscarriage of justice to the public and, though no one really cares, the offenders themselves. Registration laws do not just target the offenders; they target everyone living in the home with that offender. His or her children, his or her spouse, and even sometimes the victims of sexual abuse all carry the burden that public registration imposes.

HB 165 seeks to correct these inequities. It seeks to address the unintended consequences of previous registration laws. It seeks to establish fairness and due process in the registration requirements in the State of NH. It seeks to assess risk on a case by case basis, the same way you and I assess risk in our lives for ourselves and our children. As a community member, a parent, and a person that has had extensive personal experience with registration laws in the State of NH, I urge you to establish this committee without delay.

Testimony of Chris Dornin on HB 165

Last spring this Committee rejected a bill similar to HB 165 that would have set up a commission to study sex offender issues in general. You praised the idea, but thought the group was too unwieldy to get anything done. It would have included many stakeholders and lobbyists as well as lawmakers. You strongly suggested people who know and care a lot about the issue meet on their own, learn from each other and report back.

Well, nine people met on Dec. 6, including two prosecutors, three defense attorneys, a senior law enforcement official, a therapist for both sex offenders and their victims, and a couple of board members of Citizens for Criminal Justice Reform. Sixteen other stakeholders expressed great interest in participating, but had schedule conflicts and babies to deliver. The second meeting is tomorrow, Jan. 16, at 3 p.m. in Concordia Lutheran Church in Concord. Members of the House Criminal Justice Committee are certainly welcome to attend as guests.

The initial gathering quickly came up with a consensus on two pieces of policy. Ask lawmakers to study the sex offender public registry in depth because it is flawed and could be improved. We also opposed residency restrictions against sex offenders as unconstitutional and dangerous to the public. I drafted some possible legislation and shared it with the group by email. We haven't voted on it. We haven't decided how to make group decisions like that. But nobody told me it was bad legislation.

Rep. Timothy Robertson filed the LSR that became HB 165 because I had the flu and was slow getting the language to him. He asked Legislative Services to give him a generic bill for a study commission. That is the boilerplate legislation in front of you now. He and I met with Legislative Services well before their final deadline and gave them the text of a longer bill, which I would ask you to accept now as an amendment replacing HB 165 in its entirety. We understood or we misunderstood that this would become the official version of HB 165. I'll take responsibility for the glitch, because that is what it was. We found out the language had not changed only shortly before the cutoff. We humbly ask this committee to correct the mistake.

The new bill would set up a commission of four reps and three senators who would seek testimony from most of the stakeholders. It would also set an ambitious agenda of things to learn about the issue in two years of research. Lawmakers may very well reject this year's bill too. I have begun to suspect elected officials are simply incapable of changing sex offender laws in any way that makes them seem less harsh to the voters. If HB 165 dies, I believe most of the stakeholders will keep talking to each other. Given enough time we might do a great deal of good on our own.

Rest assured litigation will eventually repeal what needs repeal and improve what can and should be saved. The Civil Liberties Union has a case pending on behalf of one plaintiff that might declare the registry an unconstitutional retroactive punishment for him because he committed his crime long before the roster went public. Citizens for Criminal Justice is raising money for a later class action suit against the registry if the ACLU plaintiff wins. An outside attorney has written the brief pro bono and recruited a group of plaintiffs. Our organization would help pay for the expert witnesses. So far we have raised about \$1,000 from solicitations mailed to folks on the registry. That's 11 percent of our goal. Please feel free to contribute to this good cause.
