- 1 Committee Established. There is established a committee to study the construction of a permanent memorial to Governor John Gilbert Winant on state property other than the state house grounds.
 - 2 Membership and Compensation.
 - I. The members of the committee shall be as follows:
 - (a) Three members of the house of representatives, appointed by the speaker of the house of representatives.
 - (b) One member of the senate, appointed by the president of the senate.
 - II. Members of the committee shall receive mileage at the legislative rate when attending to the duties of the committee.
 - 3 Duties. The committee shall study the construction of a permanent memorial to Governor John Gilbert Winant on state property other than the state house grounds, including an appropriate site, design, and private funding source.
 - 4 Chairperson; Quorum. The members of the study committee shall elect a chairperson from among the members. The first meeting of the committee shall be called by the first-named house member. The first meeting of the committee shall be held within 30 days of the effective date of this section. Three members of the committee shall constitute a quorum.
 - 5 Report. The committee shall report its findings and any recommendations for proposed legislation to the speaker of the house of representatives, the president of the senate, the house clerk, the senate clerk, the governor, and the state library on or before November 1, 2014.
