STATE OF NEW HAMPSHIRE

AN ACT

establishing a pilot program for New Hampshire citizen emergency response teams.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 New Chapter; Citizen Emergency Response Teams. Amend RSA by inserting after chapter 107-D the following new chapter:

CHAPTER 107-E

CITIZEN EMERGENCY RESPONSE TEAMS

- 107-E:1 New Hampshire Citizen Emergency Response Teams; Rockingham County Pilot Program Established.
- I. The governor shall develop a pilot program for the citizens of the state of New Hampshire, Rockingham county to come to the aide of their neighbors and communities in times of distress and emergency for the purpose of creating a statewide system in each county.
- II. The Rockingham county citizen emergency response team shall supplement local and county law enforcement, and fire and emergency personnel during times of natural disaster, emergency, or crisis. Specific tasks may include field first aid, assistance in quarantines, health and wellness checks of shut-ins, search and rescue, clearing of debris, and construction of barricades and levies.
- 107-E:2 Emergency Response Team Supervisor; Duties and Responsibilities. The governor, with the consent of the council, shall commission a Rockingham county citizen emergency response team supervisor.
- I. It shall be the responsibility of the Rockingham county citizen emergency response team supervisor to nominate a deputy supervisor, medial task deputy supervisor, search and rescue task deputy supervisor, and engineering task deputy supervisor to be confirmed by the governor and to appoint an assistant supervisor. The Rockingham county citizen emergency response team supervisor shall manage and coordinate the activities of the Rockingham county citizen emergency response team and shall maintain all records. The Rockingham county citizen emergency response team supervisor may recommend additional task teams based on regional or management needs to be approved by the legislature or the joint fiscal committee if the legislature is not in session.
- II. It shall be the responsibility of the Rockingham county citizen emergency response team deputy supervisor to assume all the responsibilities of the Rockingham county citizen emergency response team supervisor should the supervisor be unable to complete those responsibilities.
- III. It shall be the responsibility of each task deputy supervisor to manage and coordinate the volunteers to their respective task teams and to assign a task assistant supervisor.

IV. It shall be the responsibility of the Rockingham county citizen emergency response team assistant supervisor to train and coordinate the task assistant supervisors and, with the assistance of the task assistant supervisors, to develop training manuals for the task teams. V. It shall be the responsibility of the task assistant supervisors to train the volunteers in each of the task teams. 107-E:3 Pay and Allowances. Members of the Rockingham county citizen emergency response team shall receive no pay or other form of compensation from the state. 107-E:4 Equipment; Acceptance of Surplus Equipment Permitted. The state shall not be required to supply equipment or uniforms to the Rockingham county citizen emergency response team. The state may supply equipment or clothing to the Rockingham county citizen emergency response team which is considered surplus or obsolete by the national guard or which is donated by a service organization. The Rockingham county citizen emergency response team may apply for grants and donations to pay for equipment and supplies. The Rockingham county citizen emergency response team may also apply to the armed forces of the United States of America and other departments of the state of New Hampshire for surplus equipment. 107-E:5 Acceptance of Gifts Prohibited. The acceptance of gifts, donations, gratuities, or anything of value by any individual member of the emergency response team from any individual,

firm, association, or corporation, by reason of such membership is prohibited. Violation of this section may be cause for dishonorable discharge from further service as a member of the emergency response team.

107-E:6 Administration. The Rockingham county citizen emergency response team shall have sole authority and responsibility to administer, prepare, and otherwise maintain all records of personnel and materiel through volunteer administrative staff.

2 Effective Date. This act shall take effect 60 days after its passage.

Response in NH during an incident is based on National Response Framework. Framework resulted primarily from terrorist attack of 9/11 and Hurricane Katrina.

Responses are locally driven in NH. That is a strong foundation that we operate under and have operated under.

Unity of effort is prime concern. We respond together under the National Response Framework with a defined Command Structure that is well practiced today.

Part of the Framework is that there are 15 Emergency Support Functions in New Hampshire. DHHS is the lead for two. Emergency Support Function 8, Health and

Medical is our primary concern here today. We are also the lead for Emergency Support Function 6, Mass Care and Sheltering.

Governor can declare a state of emergency.

RSA 4:45

Most recent – Hurricane Sandy

Commissioner of DHHS can declare a Public Health Incident.

RSA 508:17-a

Most recent – Hepatitis C outbreak at Exeter Hospital.

Activated our local Multi-Agency Coordinating Entity

Used volunteers from all over NH – over 200! Not just Rockingham County Coordinated by Joint Incident Command at Exeter and DHHS

State (Department of Safety) Coordinates Emergency Management and response for all of the state.

Joint Legislative Oversight Committee on the Emergency Management System. This should, at a minimum be vetted through them. During the past session, we (DHHS, both Public Health and The Emergency Services Unit) appeared before them. Positive reviews on how we are approaching our incident response.

"Good morning Mr. Chairman and members of the committee. My name is Domenic J. DiNatale Jr., I am the Director of Emergency Services at Volunteer NH and the State Coordinator for NH Citizen Corps and CERT, Community Emergency Response Teams. I am speaking in opposition to House Bill 279, an act establishing a PILOT program for NH citizens emergency response teams.

While I commend the committee for recognizing the need for, and support of, such a team, "there is no need to establish a pilot program as called for in this bill, because they are already established and functioning in Rockingham County and throughout New Hampshire as CERT, Community Emergency Response Team one of several programs within the Citizen Corps family.

New Hampshire has 22 CERTs registered on the National CERT website, found at www.citizencorps.gov. In addition to these response teams, New Hampshire also has 16 Medical Reserve Corps Teams, 14 Volunteers in Policing programs (VIPs) and 1 Fire Corps – all Citizen Corps Partner Programs, that recruit, train, and organize volunteers with response support functions. These organizations also help to make sure that their trained volunteers are NIMS (National Incident Management System) trained and ready to respond. Although not a part of Citizen Corps, NH also has a trained volunteer animal response team, NH DART, and almost 4000 AmeriCorps members capable of augmenting our Citizen Corps partners.

Since 2005, NH Citizen Corps has received almost \$1M in "ear-marked" funds through the Department of Homeland Security Grant to establish and support over 40 Community Emergency Response Teams and train close to 3500 NH Citizens in the 20 hour FEMA CERT course. In Rockingham County, teams from Salem, Londonderry, Derry, Kingston and Greater Exeter have been established, are active. participate in exercises and continually answer the call to serve during a disaster. While not every citizen remains an active team member, NH Citizen Corps has always promoted for our citizens to take care of themselves, then their neighbors, community, town, and state. A task that I am proud to say has been recognized by Department of Safety, Homeland Security and Emergency Management, Department of Health and Human Services, Department of Agriculture and the Department of Administrative Services to mention a few. NH Citizen Corps, in accordance with Chapter 21 -P: 48, is also an active member, and appointee since 2007, to the Governor's Advisory Council on Emergency Preparedness and Security, (ACEPS). There is also specific language in RSA 281-A:2, VII(a)(8) that addresses Citizen Corps members status when called to serve.

The FEMA CERT program trains citizens to safely assist their families, neighbors, coworkers, or anyone who needs help during a local, regional or widespread emergency when professional responders may not be able to reach everyone as soon as help is needed. The 20 hour, 10 module curriculum, SM-317, is delivered nationwide as a baseline core competency to any citizen interested in preparing themselves for a disaster or volunteering to become an active member of a local, regional or statewide team.

At the end of 2012, nearly 2,200 CERT Programs across the U.S. registered on the National Citizen Corps and CERT website and have recorded over 1.2 million volunteer hours with their CERT.s

According to FEMA records, Nationally, 65% of local or regional programs have used their Teams in multiple actual emergencies. In NH, every CERT since 2005 has been deployed in some capacity to each of our 13 disasters to support:

- Damage assessment and reporting
- Basic search & rescue
- Evacuation and traffic management
- Distribution of time-sensitive information
- Staff support at Emergency Operations Center
- Shelter Operations & Management
- First aid
- · Recovery operations
- Debris Removal
- Animal Sheltering
- and recently provided support for the Exeter Hep C clinics.

NH Community Emergency Response Teams have been recognized by FEMA Region 1, and at the National Citizen Corps HQ as some of the best.

"I urge the committee to report Inexpedient to Legislate on House Bill 279.

Summary

The Greater Exeter Citizen Corps and the Greater Portsmouth Medical Reserve Corps are cadres of trained volunteers who support first responders during emergencies, as well as promote emergency preparedness within 23 Rockingham County communities in the Seacoast Public Health Region. Combined, the programs have a total of 85 volunteers, and are one of the most active nation-wide.

Outreach & Education

The following trainings opportunities were offered to area residents, partners and GECC/GPMRC members in 2012:

- VII. (a) "Employee", with respect to public employment, means:
- (1) Any person in the service of an employer, as defined in RSA 281-A:2, IX, including members of the general court, under any express or implied voluntary contract of hire and every elected or appointed official or officer of the state or any political subdivision or agency thereof while performing official duties.
- (2) Any person who is a call firefighter or special police officer, volunteer or auxiliary member of a fire or police department, ambulance or rescue service, or the state police, whether paid or not paid. For the purposes of this chapter, such a person shall be deemed to be an employee of the political subdivision of the state in which the department is organized.
- (3) Any person who is a regularly enrolled volunteer member or trainee of the emergency management corps of this state as established under the state emergency management act. For the purposes of this chapter, such a person shall be deemed to be an employee of the state.
- (4) Any person who fights a forest or other type of fire and who is either voluntarily under the direction of those authorized to give direction in the fighting of fires or who is under statutory compulsion to fight fires pursuant to RSA 227-L:11 and 227-L:13, or RSA 154:7, 8, and 9. For the purposes of this chapter, such a person shall be deemed to be an employee of the state with respect to fires fought under the provisions of RSA 227-L and deemed to be an employee of the municipality in which the fire is fought with respect to fires fought under the provisions of RSA 154.
- (5) Any person who assists in a search for or an attempted rescue or rescue of another pursuant to RSA 206:26, XII, after January 1, 1982, and who is voluntarily under the direction of those authorized to give direction in searching for or attempting to rescue or rescuing another. A person who assists in the search for or attempted rescue or rescue of another shall, solely for the purposes of this chapter and not otherwise, be deemed to be an employee of the state with respect to such activity. Any payments required to be made as a result of this paragraph shall be a charge against the general fund.
- (6) In the absence of any mutual aid agreement or other similar written agreement that specifically addresses the issue of workers' compensation benefits, any person who acts as an agent to the department of health and human services or the department of safety by providing assistance in response to a specific public health or public safety incident. Such person shall be deemed an employee of the state for the purposes of this chapter. In order to be eligible for workers' compensation benefits under this chapter the person shall have been specifically designated in writing as an agent by the commissioner of the department of health and human services or the commissioner of the department of safety, or their respective designees, in accordance with the provisions of RSA 508:17-a. This subparagraph applies only to such designated agents who are not receiving compensation from either the department of health and human services or the department of safety, other than possible reimbursement for expenses actually incurred for such services, such as travel expenses, but who may be receiving compensation from his or her regular employer or from any other source.
 - (7) Any member of the New Hampshire national guard while on state active duty.
- (8) Any person who is officially designated by the governing body of a political subdivision as a volunteer in a New Hampshire citizen corps local council program that is organized, recruited, trained, supervised, and has been activated by an authorized political subdivision employee or official acting in his or her capacity as the emergency management director of the political subdivision.
