

Dear Representative Cossette and Members of the Judiciary Committee:

As the Director of the Office of Public Policy of the Roman Catholic Diocese of Manchester, and on behalf of Bishop Peter Libasci, I write to express our **opposition to HB 403**. This bill proposes to establish a commission to study so-called "death with dignity" for persons suffering from a terminal condition.

To live in a manner worthy of our human dignity, and to spend our final days on this earth in peace and comfort surrounded by loved ones – that is the hope of each of us. In particular, Christian hope sees these final days as a time to prepare for our eternal destiny.

Today, however, many people fear the process of dying. They are afraid of being kept alive past life's natural limits by burdensome medical technology. They fear experiencing intolerable pain and suffering, losing control over bodily functions, or lingering with severe dementia. They worry about being abandoned or becoming a burden on others.

Our society can be judged on how we respond to these fears. A caring community devotes more attention, not less, to members facing the most vulnerable times in their lives. The healing art of medicine is an important part of this assistance. Even when a cure is not possible, medicine plays a critical role in providing "palliative care" – alleviating pain and other symptoms and meeting basic needs. Such care should combine medical skill with attention to the emotional as well as spiritual needs of those facing the end of life.

This study commission seeks to respond to these fears in a radically different way. It uses the term "death with dignity" to describe a self-inflicted death, generally using a drug overdose prescribed by a doctor for the purpose of suicide. While some may argue there is no harm in studying physician-assisted suicide, passing this bill would send the message suicide has a place in our society, and suicide is a terrible tragedy our society should work to prevent.

Physician-assisted suicide also violates the Hippocratic Oath that has guided physicians for millennia: "I will not give a lethal drug to anyone if I am asked, nor will I advise such a plan." Proponents know these facts, so they avoid terms such as "assisting suicide" and instead use euphemisms such as "aid in dying."

Proponents will claim physician-assisted suicide enhances choices or freedom for people with serious health conditions, but several factors call this into question:

- Medical professionals recognize that people who take their own lives commonly suffer from a mental illness, such as clinical depression. People who request drugs are vulnerable. They need care and protection. To offer them lethal drugs is not a victory for freedom but a serious risk of neglect. Such abandonment is especially irresponsible when society increasingly is aware of elder abuse, our limited resources for those with mental illnesses, and other forms of mistreatment and exploitation of vulnerable persons.
- Even apparently free choices may be unduly influenced by the biases and wishes of others. Our culture places an excessively high premium on productivity and autonomy, which tends to discount the lives of those who have a disability or are dependent on others. If these persons say they want to die, others may be tempted to regard this not as a call for help but as the reasonable response to what they agree is a meaningless life. Those who choose to live may then be seen as selfish or irrational, as a needless burden on others, and even be encouraged to view themselves in that way.
- The founders of our country declared that each human being has certain inalienable rights the government must protect, and life is the first of these named rights. The campaign for assisted suicide is a threat to authentic human freedom.

There is a better way – what Pope John Paul II called "the way of love and true mercy – a readiness to surround patients with love, support, and companionship, providing the assistance needed to ease their physical, emotional, and spiritual suffering.

Catholic teaching affirms the sacredness and dignity of every human life from conception to natural death. We urge you to report HB 403 as inexpedient to legislate because we, as a society, can respond to New Hampshire citizens at the end of life with care and compassion, not with death as the solution. Thank you for your consideration of our testimony and for your service to the people of New Hampshire.

(d) A licensed hospice and palliative care physician, appointed by the New Hampshire Medical Society.

(g) A representative of a hospital with a dedicated palliative care program, appointed by the New Hampshire Hospital Association.

(h) A representative of a Medicare certified home health and hospice agency, appointed by the Home Care Association of New Hampshire.

(i) A representative of the New Hampshire Hospice and Palliative Care Organization, appointed by the organization.

(j) A representative of spiritual care professionals specializing in palliative care, appointed by the New Hampshire Council of Churches.

(k) A representative of a nursing home facility, appointed by the New Hampshire Health Care Association.

(1) Two public members, appointed by the governor.

II. Legislative members of the commission shall receive mileage at the legislative rate when attending to the duties of the committee.

III. The commission shall study the current state of palliative care and quality of life initiatives statewide and make recommendations to the general court relative to improvements and best practices in consumer and professional information, educational opportunities, and access to palliative care.

IV. The members of the commission shall elect a chairperson from among the members. The first meeting of the commission shall be called by the senate member. The first meeting of the commission shall be held within 45 days of the effective date of this section. Eight members of the commission shall constitute a quorum.

V. The commission shall report its findings and any recommendations for proposed legislation to the


