Harry Accornero, former state representative. Speaking in support of the bill. Having to drive 30 to 35 minutes to get to Concord DMV is a real hardship especially for the elderly.

Roland Mayheu, speaking in favor of the bill. Understands the cost to state government, but this is really needed.

Rick Bailey, Director of NH DMV speaking in opposition to the bill. While he agrees with the hardships, what do they say to the other communities which have equally longer drives to open offices. The staff was laid off, and the equipment went to busier offices. They have added an on line option. What locations would they pick to open a DMV station? Many areas of the state have 25 - 30 mile drives. Staffing is the cost item. * written testimony provided which includes cost estimates.

Rep. Hikel, is there any way to bring these functions to local clerk's offices? Registrations now allowed, but licensing presents a high security problem.

Rep. Bouchard, funding for these sub stations comes from the highway fund? If there were more money could more stations be opened? Yes, more money would allow more stations to be opened.

Rep. O'Flaherty, is there anything which can be done to warn people about the malicious web sites? Some things were possible, but now web search engines offer possiblities when the address is wrong. They are looking to improve the language for the web site.

Rep. Hikel, was there a bill to close Milford. No.

HB_500 SB__ AS INTRODUCED (X) AMENDMENT NO. ____

This bill would require the DMV to maintain a driver licensing and motor vehicle registration substation in Belknap County. It is inexplicable why there is no fiscal note accompanying this bill, because it is obvious that there will be a fiscal impact involved in implementing it, and the fiscal impact would certainly exceed many times over the \$10,000 threshold amount where the Legislature requires fiscal notes.

For a number of years, DMV maintained a substation in Belknap County, at first in a furniture store building on Court Street in Laconia, and later at the Belknap Mall in Belmont. Two years ago when the Legislature passed a budget that forced the agency to make some serious cuts to expenditures, the only option that would produce enough savings to implement the cuts was to close several substations. We picked the ones that did the least amount of business, and Belmont was one of these.

The DMV has soldiered on and managed to improve services in the face of these cuts, but there is no more "low hanging fruit" that we can harvest to save money — DMV is at the tipping point now, and any additional budget cuts in the new budget, or expensive mandates such as opening another substation, will unavoidably lead to serious degradations to our customer service and losing much of the ground we have gained in the past few years in this area.

Currently, residents of Belknap County who need to conduct transactions at a DMV office have two options — the State Police Troop E substation in Tamworth, which is in Carroll County, or the DMV home office in Concord, in Merrimack County. For most parts of Belknap County, Concord would be the closest. For example it is only 18 miles from Belmont and takes less than a half-hour to get there.

Moreover, most customers can be serviced without the need to travel to a substation. For example, driver licenses are only renewed every 5 years, so at the worst someone from Belknap County would only have to travel to Concord for this purpose twice in a decade. And, if they choose to do so, they can renew their license once every 10 years by going online and doing it with a credit card on the DMV website. They can also pay traffic fines online. Municipal

Agents, their local city and town clerks, can complete all but a very few motor vehicle registration transactions, and soon car and truck dealers will be able to issue number plates when they sell a car to you.

The Department would love to be able to return to Belknap County if fiscal conditions would allow us to do so. However, given the current fiscal climate and that in the foreseeable future, we do not believe the limited number of times when a trip to Tamworth or Concord is necessary to complete a transaction with the DMV is worth jeopardizing service to the rest of the state, including residents of Belknap County, and that unfortunately would be the result if this bill passes.
