Mr: Chairman and fellow members of the committee, my name is Michael Connor and I work for the Department of Administrative Services where I serve as the Director of Plant and Property Management. I am here today to testify in support of HB 509.

The American Legion owned land where the State House Annex is currently located and in 1921 the legislature approved legislation (laws of 1921, Chapter 175) that authorized and directed the Governor and Council to provide office space and related heat and lights in the State House for the department of the American Legion.

Through the years they have moved from the State House and they are currently located on the fourth floor of the State House Annex.

This legislation will provide authorization to the Department of Administrative Services to provide office space at no cost to the New Hampshire Department of American Legion at any state owned building located in Concord.

We are currently renovating the Anna Philbrook Center located on the Governor Hugh Gallen Office Park for use by several state agencies. The American Legion would like to relocate their offices once the renovations are completed so that they can be located in a space with better parking and accessibility to the veterans that they serve. This legislation will allow that to occur and provide office space at no cost to the American Legion for years to come.

Thank you Mr. Chairman and members of the committee

For the record I am Rep. John A. Graham, Hills District 7, which is the town of Bedford. Truth in lending (or at least testifying) time, I am also the treasurer for the American Legion here NH.

The genesis of this bill is actually quite simple. As many of you know as part of the Capital Budget we have been renovating buildings at the Gallen Office Park (the old state hospital grounds). One of the buildings being renovated will be used to provide space for various boards, councils and committees of the state – thereby reducing the amount of revenue needed for rent or leases for these entities... During one briefing on this building I noticed that one small office suite had no planned occupants.

Wearing my Legion hat I realized that this suite might offer an opportunity for the Legion. Currently the Legion occupies a small 3 room suite in the State House Annex. Since 1921, please refer to the handout of the laws of 1921, the state has been required to provide this space.

However it would be advantageous to the Legion to move to the Gallen Park. Advantageous primarily to our employees, but also to anyone who might have business with the Legion headquarters. And here I am referring obviously to the parking situation around the state house complex. As an aside, it would also save the Legion some money since we do provide a small stipend to our employees to help offset the cost of parking.

When I approached Admin Services about the idea of the Legion moving from the Annex to another state owned building they begin some informal talks with the Legion and have reached an agreement in principal concerning the move. However, existing law specifically states that the Legion will be housed in the state house. It was suggested to me that the best alternative would be to update the law to allow the state to continue its support in another location within Concord, and that it be made a part of the RSA's and not chapter law – so that it could be more readily found in the future.

In summary, this bill merely updates existing law and does not change the relationship of the state of NH and the American Legion.
