ANALYSIS

This bill requires that the division of higher education in the department of education develop and adopt a policy on academic credit for a student's military occupation, military training, coursework, and experience, and to consult with institutions of higher education in implementing the policy.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 New Section; Division of Higher Education; Military Academic Credit. Amend RSA 21-N by inserting after section 8-a the following new section:

21-N:8-b Higher Education; Military Academic Credit.

I. The division of higher education shall develop and adopt a written policy requiring each public institution of higher education to develop a set of written policies and procedures governing the evaluation of a student's military occupation, military training, coursework, and experience, to determine whether academic credit shall be awarded by the institution for the evaluated occupation, experience, training, and coursework. The division's policy may require that the occupation, training, experience, or courses meet the standards of the American Council on Education or equivalent standards for awarding academic credit. The division may also develop and adopt a written policy requiring each public institution of higher education to develop a set of written policies and procedures to standardize credit-by-exam equivalencies for exams funded through the Department of Defense. The educational credit shall be awarded based upon each institution's admissions standards and shall be consistent with the mission of the state's system of public higher education. Each public institution of higher education shall designate a single point of contact for a student who is enrolled in such an institution and who is also a veteran, as defined in RSA 21:50, I, to conduct such an evaluation and determination.

II. The division shall consult with the chief executive officers of each public institution of higher education in implementing the policy set forth in paragraph I and the policy adopted by the division shall, to the greatest extent possible, provide for consistent application by all of the state's public institutions of higher education and promote accurate and complete academic counseling.

2 Effective Date. This act shall take effect 60 days after its passage.



TESTIMONY OF DR. RICHARD A. GUSTAFSON, DIRECTOR

DIVISION OF HIGHER EDUCATION - HIGHER EDUCATION COMMISSION

Thursday, February 7, 2013

I am here today to testify in opposition to HB 519, an Act requiring the division of higher education to develop a policy on academic credit for a student's military occupation, military training, coursework and experience.

I am testifying in opposition to this legislation because I believe it is unnecessary for the following reasons.

All New Hampshire institutions of higher education are accredited by one or more regional or national accreditation organizations and each of these require that the institution have written and well publicized policies and procedures regarding the manner in which they review and accept academic credit from other colleges and universities as well as via other means. Other means usually refers to accepting credit by examination, credit for life experience and credit for education and training courses taken in the military or through other professional associations such as banking, accounting, health care professions, real estate or engineering.

The policies for acceptance of academic credit by colleges and universities, public and private, vary widely as a reflection of the mission and purpose of the institution. The policies also vary widely as a reflection of the specific academic programs within the institutions. Again, accreditation associations require that these policies and procedures are well defined and openly available to all prospective students. It is not at all unusual for a national program accrediting association such as nursing or engineering to strictly limit the number and types of academic credit that may be accepted into an accredited program.

Nevertheless, every institution with which I am familiar has transfer policies and practices that recognize the education and training that military personnel and

other professionals may have received prior to enrolling in a college or university. The highly regarded ACE Book, a publication developed by the American Council on Education, has a long history of providing an extensive listing of military and other high quality education and training courses and the academic credit recommended for each. This volume is vetted and updated annually through the use of panels of faculty and other subject matter experts and is used by all institutions.

Virtually all colleges and universities also have provisions for earning credits by examination through such organizations as the "College Level Examination Program", (CLEP). There are also other standardized examination series in the fields of business, health care, facilities management, etc. Further, most colleges and universities have programs where students can be awarded academic credit for life experience through a process of documentation and evaluation.

However, all of the above avenues for achieving academic credit have limits. These limits usually require a student to earn at least 25% of his/her academic credits at the institution from which the degree will be awarded. Also, a student bringing in a substantial number of academic credits may find that they all do not count toward a degree program that is different from the original area of study. For instance, there may be academic credits in electronics that will not apply in a physical therapy program.

Men and women returning from military service are most welcome on all college campuses here in New Hampshire. We know they are nearly always highly motivated, disciplined and strong academic students. They also are outstanding role models for others and take their studies very seriously.

I should also note that all of New Hampshire's public and private institutions of higher education have programs approved by the Veterans Educational Services Office within the Division of Higher Education. In addition, all of these institutions already have well operating veterans affairs offices staffed by an approved veterans affairs certifying official. Our office conducts program reviews of these programs on a cycled basis.

As many of you know, I was formerly president of Southern New Hampshire University for a number of years. This was an institution that always welcomed returning veterans as well as other non-traditional students. These students were given every opportunity to bring in academic credits reflective of the education, training and experience they received during their service. It is the same today at all of our New Hampshire institutions.

Our state, regional and national higher education oversight associations already require our institutions of higher education to have written policies and procedures which govern the evaluation of previous education and training for academic credit, and the application of these policies and procedures are evaluated as part of the accreditation process.
