Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 New Section; Task Force on the Judicial Branch Family Court Division. Amend RSA 490-D by 2 inserting after section 15 the following new section: 3 490-D:16 Task Force on the Judicial Branch Family Court Division. I. There is established the task force on the judicial branch family court division consisting 4 5 of 21 members. The governor shall appoint the members in subparagraphs (a) through (l) who shall 6 serve at the pleasure of the governor and shall include persons familiar with family law and 7 mediation. All persons who desire to serve as governor-appointed members shall submit a letter of 8 interest to be considered for appointment by the governor. The members of the task force shall be as 9 follows: 10 (a) Two Court Appointed Special Advocates (CASA) guardians ad litem. 11 (b) Two guardian ad litem board certified guardians ad litem. 12 (c) A sitting judge of the superior court. 13 (d) A sitting judge of the judicial branch family court division. 14 (e) Two attorneys practicing family law. 15 (f) An attorney employed by the department of health and human services, division of 16 children, youth, and families. 17 (g) A representative of the department of health and human services, division of child 18 support and child support enforcement. 19 (h) A child psychologist. 20 (i) An adult psychologist. (j) Two retired marital masters. 21 (k) One male and one female member of the public who are experienced consumers of the 22 23 judicial branch family court division or mediation. 24 A mediator-attorney with the New Hampshire Conflict Resolution Association 25 (NHCRA). 26 (m) Two members of the house of representatives, one of whom shall be a member of the 27 children and family law committee and one of whom shall be a member of the judiciary committee, 28 appointed by the speaker of the house of representatives.

(n) One senate member, appointed by the senate president.

(o) The executive director of the judicial council, or designee.

17	(2) Recommendations for modifying court rules as they apply to the judicial branch

19	(3) Recommendations to increase efficiencies of case processing, reporting, and		
20	information exchanges.		
21	V. The task force shall report its findings and any recommendations for proposed legislation		
22	to the senate president, the speaker of the house of representatives, the senate clerk, the house clerk,		
23	and the governor on or before November 1, 2014.		
24	2 Repeal. RSA 490-D:16, relative to the task force to study and make recommendations on the		
25	judicial branch family court division, is repealed.		
26	3 Effective Date.		
27	I. Section 2 of this act shall take effect November 1, 2014.		
28	II. The remainder of this act shall take effect upon its passage.

Madam Chair and Honorable Members of the Children and Family Law Committee. I am pleased to introduce **House Bill 571** establishing a task force to study and make recommendations on the judicial branch family court division.

The desire to establish a judicial system that handles all things family in a respectful, appropriate and timely way and to "reduce the adversarial nature of proceedings involving families" dates back at least to 1995 when a family division pilot program was established in Rockingham and Grafton counties. By 2005, New Hampshire set up a statewide family division. For most families, our family court system works well. For some it has not, and when it does not, children and adults suffer.

A little background on this bill: I inherited a family court bill Rep. David Robbins, who was, to my dismay, not re-elected. He and I, as well as the former Chair of this Committee, Rep. Ed Moran (who elected not to run again), had the opportunity to meet with family court people, parents, as well as engage in separate fact finding activities in an attempt to determine if there was something legislatively we could do to make things work better for some families. We all felt that there were system issues and that New Hampshire could be doing a better job. The bill Rep. Robbins ended up filing was a small fix. After observing two family court hearings myself, and then meeting with a couple of family court attorneys and mediators, I became uncomfortable with the bill.

HB 571 is the result of my belief that there are people within the system and, in the case of legislators outside of the system, who working together can make improvements. I would like to give New Hampshire the opportunity to do better, I hope you will help this happen by voting in favor of HB 571..
