Bill Analysis: This bill modifies the definition of mixed use school bus, requires criminal records checks of driver education instructors, updates references relating to suspending or revoking a school license or driver education certificate, and authorizes background checks on candidates for employment or promotion at the department of safety. This bill was requested by the department of safety.

Who supports the bill: Senator Jim Rausch, Rick Bailey (Director, Division of Motor Vehicles), Martha Roy (New Hampshire Association of Counties-Human Resources Affiliate), Betsy Miller (New Hampshire Association of Counties)

Who opposes the bill: No one

Summary of testimony presented in support:

Director Bailey (Division of Motor Vehicles) provided a position paper • This bill was a department request and does three things

• First, a correction in regards to mixed use school bus regulation. In a previous session it was decided there was a problem when school districts were required to hire a full size school bus for small teams(ex: 10-12 members). The legislation that passed allowed for smaller buses and vans to be used for those groups. The problem that arose is there was language missing that required the driver to be an employee of the school district. This bill corrects that and therefore requires that they are employees and consequently are properly vetted and insured through the district.

- The next two sections deal with the Department of Safety and the ability to do multistate background checks. Those checks require cooperation with FBI and they require specific enabling legislation by the state in order to do this. The first section covers driver's education instructors and allows the Department to do multi-state background checks. If it is limited to only NH, which the department can already do, then some vital information could be easily missed if someone had moved from another state.
- The second section, allows for the same authorization for multistate background checks for DOS employees, like employees of the DMV. Feels this is especially important when they are dealing with such sensitive information of NH employees.
- Senator Stiles asked if the smaller buses that drive children with disabilities would also be covered by this.
 - \circ If they are doing home to school or school to home then yes.
- Senator Watters asked if people would be charged a fee for the background checks. • Yes there is a fee, around 40 dollars
- Senator Watters asked if that is under rules or statute. • Rules, and that is the same for any entity,
- Senator Watters asked how many employees would be subject to this.
 - All of law enforcement already does under a separate statute, and explained the reasons it would cover DMV employees.
- Senator Watters asked if they have had problems in the past in employees abusing authority that might have been prevented by this check.
 - They have had a few in the past couple years and they have had a few instances with candidates they were lucky to catch for some other reason. Described a situation from two years ago in Salem, which resulted in the employee being incarcerated. However, in other states when issues arise, employees could simply get a suspended sentence and without the multistate background check, it would be extremely difficult to be aware of that.

Martha Roy (New Hampshire Association of Counties-Human Resources Affiliate) presented an amendment

- Presented an amendment that would enable the counties to require an FBI check for all applicants for county employment.
- Described an example from a county that had a person apply for a nursing position and passed the state background check. The county found later that the person had several felonies in another state, even though they had signed a form indicating that they had none.
- This ability is already in place for towns and school districts
- Would also apply to the register of deeds, engineering and maintenance departments.
- Senator Rausch and Senator Watters voiced concerns that this may not be the appropriate bill or committee to review this information. Senator Boutin suggested that it may fall in line with the changes that the House had made.
- Senator Watters asked about the fee for the background checks.

• The counties would pay that charge

- Senator Gilmour voiced concerns that other entities that would build off this and require these checks as well.
 - Believes this closes the loop. There are two other state laws that pertain to towns and school districts respectively, but for some reason counties were overlooked.
- Senator Boutin asked if other state employees go through the background checks. • Director Bailey answered that there are other pockets that do, but not all.

Betsy Miller (NH Association of Counties)

- Did not realize counties did not have this authority and there have been a few instances of bad behavior by employees.
- Decided to bring this forward when the amendment for Department of Safety employees was placed on the bill.
- Checked with Earl Sweeney and Trooper Jeff Kellett (Criminal Records Unit) and they are fine with this. Mr. Kellett helped with the language so that it mirrors the town authority.
- Senator Watters asked if maybe it is something that should be taken up next year in order for the proper process to occur.
 - There is no way to know if something may happen between now and next year. Had an employee arrested last month for financial issues.
- Senator Rausch asked Director Bailey for his stance.
 - As long as they have worked with Mr. Kellett and the language is what we know would pass with the Feds, then it should be fine.
- Senator Boutin asked what is utilized for the background checks.
 - Finger prints, name and date of birth
- Representative Theberge spoke in support.

HB_282_ SB__ AS INTRODUCED () AMENDMENT NO. __

This bill was introduced at the behest of the Department of Safety. It is largely a housekeeping measure, and it amends the definition of "mixed use" school buses and requires criminal record checks of driver education instructors and updates a statutory reference relative to suspending or revoking the license of a driving school or driver education instructor.

Two years ago we supported a bill to change the definition of a mixed school bus in order that school districts could travel small groups such as the golf team or the debate club to another town or place to take part in an event, without having to go to the expense to rent a 66-passenger bus. The concept was the school district would own a small passenger van and the van could be driven by a school district employee such as a teacher, coach, or janitor. These school district employees all have had criminal record checks anyway, and it would be up to the Superintendent to make sure they had clean driving records. They would not need a school bus driver license endorsement for taking these trips.

Unfortunately since that time, a few schools and some individuals have subverted the original intent of that bill, and parents and others who are not employees of the school districts are driving these vans with children in them, to and from these activities. We feel, and the testimony that the Legislature relied on in passing this exemption originally, was that the vans would belong to the school district and the drivers would be district employees, who had undergone criminal and driving record checks and who were overseen and subject to the authority of the principal and the superintendent of schools. Part 1 of the bill simply cleans that up by specifying that to qualify as a mixed use school bus the vehicle must be owned by or leased to the school district, and the driver must be a district employee.

Part 2 of the bill imposes a requirement for a criminal record check for a driver education instructor. Virtually everyone today who has regular contact with school-age children, including teachers, coaches, school bus drivers, substitutes, teacher aides and volunteers, has to have a criminal record check. All, that is, except driver education teachers, who spend more time in cars with other people's kids than almost anyone else. This would simply mirror the law that applies to everyone else that deals with youths in an educational type setting.

Part 3 of the bill is simply a reference change. The DMV has always been able to suspend or revoke the driver education certificate of a driver education instructor or driver education school whose proprietor is convicted of DWI. That law has always been on the books but recently the Legislature re-codified the DWI statutes and they are now in Chapter 265-A instead of Chapter 265. This provision simply updates that requirement by making reference to the new statute number.

Not in the bill but something we would like to see is the ability for the DMV to perform criminal record checks as a condition of hiring our own employees. Those that handle driver licenses, ID cards and vehicle titles particularly have lots of opportunities to commit fraud and other crimes and unfortunately, we have had to arrest some of them in the past 3-4 years. We would need a law similar to the one here on driver education instructors in order for the FBI to release criminal record information to us. If the Committee has time and would entertain an amendment to this bill, we can provide you with one later in the week, before you hold your Executive Session on the bill. We do not believe this would be controversial, since we would be doing it to ourselves and not to the public at large or some other industry.

Dear Honorable Committee members,

I am writing on behalf of the NH Association of Counties Human Resources Directors' Affiliate, in favor of Senate Bill 282. We urge you to vote in favor of this legislation for the following reasons:

- 1. The amendment to this bill allows County employment applicants to be checked through the Federal Bureau of Investigation thus insuring that they do not have felonies in any state.
- 2. More than half of all County employees are in constant contact with our Nursing Home residents who need to be protected from predators. Currently, State rules only require a State criminal records check of applicants. Without a thorough national check there is no guarantee that an applicant may not have a felony in another state.
- 3. All other State municipalities i.e. towns, school districts and cities already have similar language in law under RSA 189:39 and RSA 41:9-b. This amendment will add our one remaining State municipality, effectively closing the loop on this critical issue.

PROPOSED AMENDMENT TO HB 282, relative to mixed use school buses, relative to licensing and criminal records of driver education instructors, and relative to background checks for department of safety employees.

proposed amendment: relative to background checks for county employees ----

This amendment exactly parallels the statutory language already in place for municipalities and school districts giving the counties the authority to pursue criminal background checks through the Division of State Police for both state and federal records checks.

Amend RSA 28 by adding a new section after RSA 28:10-b as follows:

28:10-c Employee Candidate Background Checks.

I. The county commissioners may require a background investigation and a criminal history records check on any candidate for employment, prior to a final offer of employment. A county may request only a state records check or both a federal and state records check, to be conducted through the division of state police. The county may extend a conditional offer of employment to a candidate, with a final offer of employment subject to a successfully completed criminal history records check.

II. A candidate for employment in a position which the county commissioners determine requires a background investigation and a criminal history records check shall submit to the county a notarized criminal history records release form, as provided by the division of state police, which authorizes the release of the person's criminal records, if any. The candidate shall submit with the release form a complete set of fingerprints taken by a law enforcement agency as directed by the governing body or town manager. In the event that the first set of fingerprints is invalid due to insufficient pattern and a second set of fingerprints is necessary in order to complete the criminal history records check, the conditional offer of employment shall remain in effect. If, after 2 attempts, a set of fingerprints is invalid due to insufficient pattern, the county may, in lieu of the criminal history records check, accept police clearances from every city, town, or county where a candidate has lived during the past 5 years.

III. To obtain a state records check only, the county shall submit a state criminal history records release form to the division of state police. To obtain both the federal and the state records check, the county shall submit the criminal history records release form and applicant finger print card to the division of state police, which shall conduct a criminal history records check through its records and through the Federal Bureau of Investigation. Upon completion of the background investigation, the division of state police shall report any criminal conviction information to the county commissioners. The county may submit fingerprint information electronically, in accordance with procedures established by the division of state police. The

county shall maintain the confidentiality and security of all criminal history records information received pursuant to this paragraph.

IV. The county commissioners may require the candidate to pay the actual costs of the background investigation and the criminal history records check.

V. In this section, "candidate for employment" shall include candidates for volunteer positions in the county.
