Who supports the bill: Representative Theberge, John Wimsatt (Fish and Game), Stephen Kace (State Police), Chris Gamache (NH Trails, Department of Resources and Economic Development)

Who opposes the bill: No one.

Summary of testimony presented in support:

Representative Theberge presented an amendment

- This bill clarifies the language regarding the use of an OHRV.
- The amendment changes the effective date to 60 days after passage in order to have this in law enacted before a big event and clarifies the language within the bill.

Captain Wimsatt (NH Fish and Game) provided a position paper

- Supports the amendment as it clarifies the restrictions explicitly.
- OHRV laws are somewhat confusing and this legislation clarifies that.
- Until recently, NH did not have a lot of roads open to OHRVs, but more road systems have been opened up by towns and by SB 250 from last year.
- Currently, a 12 and 13 year old, who has a safety certificate, may operate on a trail if accompanied by someone over the age of 18 and cross a road at a 90 degree angle. A 14 or 15 year old, who has a safety certificate, can ride unaccompanied on trails and roads.
- This bill would restrict those 14 and 15 year olds, until they get their drivers license, from riding unaccompanied on the roads.

- The "Not withstanding" section is simply to ensure that it will not trump any other current OHRV statutes. For example, current OHRVs statutes make specific reference parental responsibility.
- Senator Rausch asked if a 14 year old can ride on trail alone, but cannot operate on roadway without an 18 year old.
 - Under this bill that is correct. From a safety perspective, those 14 and 15 year olds should not be driving on the roads on their own.
- Senator Rausch questioned the issue that many of the trails are connected by roads. • If it is an actual sanctioned trail, those 14 and 15 year olds would be able to operate with no problems. This specifically addresses roads approved for OHRV use.
- Senator Stiles asked how often the OHRV classes are held and how much they cost. • The course availability is posted on their website and they have two or three coming up in the coming weeks. During snow machine season, they ramp that up. If they get a call that they do not have a class when someone needs one, they put one together. Most of it is volunteer instructors and they work to meet the demand. There is no cost for the class per statute and rule.
- Senator Boutin asked for clarification as to what accompanied means.
 - Within sight, when actual physical direction can be made. On a machine behind or in front of the other operator's machine or on the same machine.
- Senator Watters asked if parental consent is required participate in the courses. • There is a parental consent form. Kids cannot receive the card until they are 11
 - and it is not valid until their 12th birthday.

Steven Kace (State Police, Department of Safety)

- In favor of the amendment.
- Originally had concerns, but that position was formulated from an unenlightened place and they have seen the light.

Chris Gamache (NH Trails, Department of Resources and Economic Development) provided a position paper

- This has been the number one topic of discussion regarding OHRVS and it is something they requested be worked on.
- Supports the proposed amendment.

Senate Transportation Committee March 18, 2013

Chairman Rausch and members of the Senate Transportation Committee, for the record my name is John Wimsatt. I serve as Administrative Captain for the Law Enforcement Division of the NH Fish and Game Department. I am responsible for oversight of the Snowmobile and OHRV program. This bill is Department supported legislation and the New Hampshire Fish and Game Commission voted to support HB 383.

Over the last few years, several public roads have been opened for use by All-Terrain Vehicles (ATVs) and other Off Highway Recreational Vehicles (OHRVs). Some of these roads have been opened by the local governing municipality while certain state owned roads have been opened by legislation enacted last year in Senate Bill 250.

The purpose of HB383 is to address legitimate safety concerns regarding youth operator requirements on these roads. Current law allows 14 and 15 year olds that have successfully completed and approved OHRV safety course to ride on approved **trails** without the requirement of being accompanied by a licensed adult. This has worked relatively well and within acceptable safety considerations for many years. However, these 14 and 15 year olds can also legally operate on approved **roads** unaccompanied. Very few public roads have been open to ATV/OHRV use historically. Only in the recent few years have these restrictions changed to allow increased road use. It was not the legislative intent of the current OHRV law to provide an opportunity for unlicensed drivers to be able to operate OHRVs on public roads, essentially as a motor vehicle.

HB383, if enacted into law would require all operators of OHRVs to be licensed to drive or those operators 12 years of age and older in possession of an approved OHRV safety certificate would be required to be accompanied by a properly licensed adult at least 18 years of age.

In short, this bill makes good sense and prioritizes safety concerns for youth operators. It will be enforceable by law enforcement.

Thank you for the opportunity to testify before the Committee today regarding HB383 and I would respectfully urge the Committee members to vote to support HB 383.
