Bill Analysis: This bill adds a requirement of 2 years of experience working under a licensed elevator or accessibility lift mechanic in order to be licensed in this state and clarifies the eligibility for licensure by reciprocity. The bill also exempts licensed elevator and accessibility lift mechanics from requirements for licensure as an electrician for work in both commercial and residential installations on elevator and accessibility lift controls.

Who supports the bill: Rep. David Hess, prime sponsor, Rep. Lucy Weber, Chair, House ED & A; Christine Farmer, New Hampshire Department of Labor; Robert E. Paveglio, New Hampshire Department of Labor, Chief Elevator Inspector; David M. Porter, All-Ways Accessible

Who opposes the bill: No one

Summary of testimony presented in support:

Rep. Hess opened and explained the background for this legislation. He stated he had an amendment to the bill, which he will explain to the committee members.

- Legislation was brought forward for a constituent, an elevator mechanic, due to an uneven playing field with sister states in regard to reciprocity of qualified elevator mechanics and being able to become qualified and work in neighboring states.

- New Hampshire has lax regulations that allow out-of-state certified elevator mechanics and engineers to work in New Hampshire.
- Therefore, impetus for this bill, to level the playing field.
- Section 1 levels the playing field.
- Electricians were concerned about Section 2 because an elevator mechanic does not have to be a licensed electrician. He worked closely with the Electricians Board to come up with language acceptable to them.
- The question is when do you draw the line, where the elevator installer takes over, and where the electrician stops. This is where the proposed amendment (2103-1383h) comes in. The amendment was requested by the Department of Labor over concern about the language of the bill, as amended by the House.
- The bill provides that in order to become an elevator installer or mechanic you have to pass a test after 2 years of certified experience.
- Section 1 is new reciprocity language.
- If someone has the same standards, or lesser standards for competency, then the State of New Hampshire will adopt those standards.
- The board wanted an additional short circuit in case the standards for competency were not satisfied, so that out-of-state mechanics would not be absolutely precluded from getting licensed in New Hampshire.
- Inserted a new provision in Section 1, which states that in order to become a licensed mechanic in New Hampshire you need to take a test, serve as an apprentice for 2 continuous years, or have certification from another state, which can be documented for five consecutive years, and a minimum of 1,800 hours in each of those 2 years. This language provides a way around the reciprocity issue.
- No opposition in the House.

Senator Watters asked about reciprocity, stating that in looking at lines 19 and 20 are there neighboring states that this would particularly address what their requirements may be. **Rep. Hess** said that this legislation is intended to get the attention of the sister regulators to the south.

Senator Soucy asked if the amendment presented was requested by the Labor Department. **Rep. Hess** said that the Commissioner had provided them with similar language, but that it was tweaked at the Office of Legislative Services (OLS). He forwarded these changes on to Commissioner Wihby, and the Commissioner was fine with the changes made.

- **Rep. Hess** stated the Labor Department was represented at the hearing and would be happy to answer questions.
- **Senator Soucy** asked if the amendment was not considered during the House hearing. **Rep. Hess** said lines 9 through 12 were new so, no, these were not considered by the House.

Christine Farmer, Administrative, Inspection Division, Department of Labor and Robert E. Pavaglio, Chief Elevator Inspector, Department of Labor

Senator Reagan asked Mr. Paveglio if he previously was an elevator mechanic. Mr. Paveglio stated no.

Mr. David Porter, All-Ways Accessible, Hall Street, Concord, NH

- Is not an elevator mechanic, but works at All-Ways Accessible.
- Stated there is an uneven reciprocity with regard to labor going back and forth to the surrounding states.
- The owner of All-Ways Accessible is a licensed elevator mechanic and has been for 18 years.
- Cannot go to another state without serving 5 years in an apprenticeship program. Folks from another state can come to New Hampshire, with 2 years of experience in their particular state, and can sit and take a test; very unfair.
- This is not an even playing field. This legislation would even that out.
- Second part of bill speaks to installation and whose license works where.
- He feels the local electricians are less familiar with what the elevator mechanics do. The elevator mechanics are professionals and licensed.
- Cost generating factor when you bring in scheduling from another firm to complete something which you are in the process of already doing.

Rep. Lucy Weber, Chair of House ED & A Committee (speaking for clarification to amendment)

- In the amendment one thing the House ED & A Committee did not look at were lines 7 and 8, where it expands the 2 years documented experience, and requires a minimum of 1,800 hours in each of those 2 years; 36 hours per week for 50 weeks in each of the 2 years. She was not sure if this was a realistic amount of hours for this particular industry because the issue was not addressed by the House ED & A Committee.


