Bill Analysis: This bill repeals the December 31, 2014 repeal date of RSA 651-F, relative to the information and analysis center.

Sponsors: Rep. Kurk, Hills 2

Who supports the bill: Rep. Kurk, Captain William R. Haynes, Rep. Dianne Schuett.

Who opposes the bill: No one.

Summary of testimony presented in support:

Rep. Neal Kurk stated this was a relatively simple bill which removes the sunset provision from the fusion center (also known as the Information and Analysis Center).

- Department of Safety wanted to create a centralized organization for centralize information relating to terrorism, disasters, etc. There was a variety of federal funding and the Information and Analysis Center was appropriated and staffed from different government agencies.

- There was a provision in the bill which required an oversight committee, and a thorough review completed by Assistant Commissioner Earl Sweeney, Department of Safety on the conduct of the center after approximately one year of being in effect. - The Center and its operating procedures are very sensitive to collecting and retaining data of innocent citizens.

- He is convinced that the Center can move forward and continue to perform coordination of information function, without citizens being concerned that the Center is going to be a place where government captures information about citizens. **Senator Reagan** asked what the result would be by lettering this repeal go through. **Rep. Kurk** said that the Center will continue in existence, and the oversight committee remains. He stated that the privacy protections built in statute are being adhered to and that regular reports on their operations will be completed and reviewed by the Department of Safety.

Nothing would change, and the sunset would disappear. Senator Reagan then asked, if it sunsets and disappears, then what. Rep. Kurk stated that a valuable tool will be lost in a natural disaster. They have names of those people who are the first responders, presently they can coordinate efforts with the Governor being well informed in briefings. If this Center goes away, then it would be completed by separate entities, all with relevant information, but none of which communicates with each other, except informally. He believes the Governor can make better decisions with this in place (i.e., declaring emergencies, locating resources, etc.). Senator Reagan then asked what the cost was. Rep. Kurk believes there is no cost to the General Fund, but he would have to ask someone at the Department of Safety. He indicated there was a separate budget for this that appears in the state budget. He thought that it was federally funded or federal funds were involved with services of an FBI agent, whose salary is paid by the feds. Senator Soucy then asked about the makeup of the advisory board. Rep. Kurk stated that there was someone from the ACLA, state representative, not recalling the others, but saying that state agencies were involved. Senator Watters asked, knowing that this was going to sunset, was their funding in the Governor's budget or House budget proposal for this. Rep. Kurt believes that there is funding in the budget for this. Senator Cataldo asked if this program were redundant. Rep. Kurk stated that in order to have coordination, there is some redundancy involved, but without redundancy, coordination is much more difficult. The benefit is consolidation of information.

Captain William Hayes, Department of Safety (in support)

This particular Information Analysis Center does a number of things.

- This Center takes all information that comes in, analyzes it, validates as to whether it is legitimate.

- This allows them to make decisions based on information vetted and validated.

- Tons of information comes in to the Center.

- Provides a resource to respond to the citizens of the state.

Provides a service to the citizens of New Hampshire.

Senator Reagan asked how many people were dedicated to this organization. Captain Hayes stated that there were four people in the office; an FBI agent, and at times a representative from the National Guard, but it depends on the level of information coming in to the Center. Senator Reagan then stated that without this organization, these people do not show up to work. Captain Hayes stated the National Guard is part of the National Guard Intelligence; Sargent Scott is a Sargent with the State Police. He encourages all members of the committee to go and observe.
