Who supports the bill: Representatives Daniels, J. Belanger and Tucker; Senator Stiles; Atty. Cordell Johnston, NH Municipal Association; Lori Radke, NH City & Town Clerks' Association.

Summary of testimony presented in support:

Representative Daniels:

• If a town is going to establish an ordinance, current statute requires two public hearings and then a voting session. Those sessions must be separated by 10-14 days. Unfortunately, meeting times for school boards or select boards don't always coincide with such required meeting times. This bill would change the requirement from 10-14 days to 10-21 days, to eliminate the need for a special session.

Representative Belanger:

• The bill has much validity.

Atty. Cordell Johnston, NH Municipal Association:

- This is another one of the NHMA policy bills. This problem can occur any time there are five Mondays, Tuesdays, etc. in one month.
- Any time a select board is considering an ordinance or amendment during one of those months this problem would arise. HB 506 fixes the problem. No one has suggested any reason not to pass the bill.
- This applies only in towns with more than 10,000 residents—a limited number of municipalities. However, it is a problem that needs to be fixed.
