FISCAL IMPACT:

The Department of Transportation and the Department of Resources and Economic Development state this bill, as amended by the House (Amendment #2013-787h), may increase state restricted revenues by an indeterminable amount in FY 2014 and each year thereafter. There will be no fiscal impact on county and local revenues, or state, county, and local expenditures.

METHODOLOGY:

The Department of Transportation and the Department of Resources and Economic Development state the proposed legislation authorizes the Departments to solicit proposals, subject to the approval of the long range capital planning and utilization committee, for sponsorship of; or the purchase of naming rights to any state rest area. The proposed legislation specifies any resulting revenues be utilized to support the operations of the rest area(s). The Departments are unable to estimate to what extent the sale of sponsorships or naming rights to state rest areas will increase state restricted revenues. The Departments note the marketability and revenue potential of sponsorships and naming rights would vary dependent upon each rest area's location and level of exposure.

Summary of testimony presented in support:

Representative Burns

- NH rest stops are not always in the best condition and many of them are closed.
- Need to have a study to see what can be done to keep them open, reduce costs and generate money.
- Have civil organizations to run them to cut some costs and sell some NH products.
- Senator Stiles who gets the money o That's parts of the study

Representative Chandler

- This was heard by House Public Works and Highways. Felt it was important to at least get the departments involved, whether Department of Transportation or Department of Resources and Economic Development.
- DRED operates them and DOT owns them, which is why both agencies are named in here. The wording allows either one of these departments to use the money.
- It might generate some money, don't know if it is allowable under federal laws and therefore giving the authorizing for them to do it if they want to, instead of wasting a year simply studying it.
- Gives us a black eye because many of them are not open and the condition of them. If this generates a small amount of money that keeps them open, then it is worth trying.
- There is another bill dealing with naming rights that is on a broader level that we have retained because of federal issues. Feel this is a small step forward, still need to do the study because it is a bigger issue then this, but this may help.
- Senator Boutin pointed out that there are no guidelines as to how they are going to decide which solicitations to accept.
 - o That's why it is worded the way it is. The solicitations would come before Long Range and Capital Planning, which will give legislative oversight. Not even sure if we will get enough responses for this to be a concern.
- Senator Boutin referenced concerns with one of the state agencies currently dealing with a snafu with a contract awarded. If you don't have any guidelines established it could result in problems.
 - o I have confidence in the departments. McDonald's might send in a proposal for 1 year for \$10,000 and Wendy's might send on in for 25 years at \$5,000 a year and I think it would be up to the Department to analyze what's best. We would waste the first year of what the study is going to do if we came up with the guidelines, but I would like to see if we can do this without that.
- Senator Boutin asked who will set the standards, the Department or Long Range if McDonald's wants to put up a 300ft sign and Burger King wants to get a 500ft sign.
 - o I think we will be able to accomplish something without that kind of guidelines, like we did in Hooksett. I don't know what the department would say, I would rather give them the flexibility and they can set those guidelines.
- Senator Gilmour asked if this would only be limited to signing or if sponsors could sell their products there as well.
 - o It would give them sponsorship and signage, but not the ability to sell products.
- Senator Stiles asked in talking about naming rights, if it would be like an advertisement.

 An advertisement, for an amount of money, like the naming of the Verizon Wireless

 Center, not talking about allowing them to build something.
- Senator Stiles asked if Representative Chandler is envisioning volunteer groups, because if there is a Dunkin Donuts sign then people may expect to get coffee.
 - o The signs would say this rest area is sponsored by... The old way of running these aren't going to work anymore and these shouldn't be funded in whole by the DOT and the Highway Fund. If it needs refining then fine, but thinks it is so important that we need to try to do something.

- Senator Watters pointed on line 23-24 where it says "existing rest areas" and asked if that would be the ones that are currently closed.
 - o Ideally those would be the ones we would want to get reopened. There may be some that are determined to not warrant being open, but there are some that are closed in the winter and open in the summer. "Existing" was to make clear that we are not opening a new one.

Summary of testimony presented in opposition: None

Summary of testimony presented in the neutral:

Mike Pillsbury (Department of Transportation)

- From a study perspective we support this bill. There are three seasonal rest stops that are currently closed and there is a desire to look at the travelers needs.
- The amended part, authorizing the departments to solicit proposals is almost enabling legislation. In recent Transportation Reauthorization, Map-21, the federal government did decide to allow rest areas, where federal funds were used, to solicit for sponsorships. Still waiting for guidance as to what would be allowed: the size of signs, receipt uses, etc. This legislation would allow us to roll those in when the federal guidance is crafted.
- Senator Boutin asked what the department would be more comfortable with: blanket authorization or having more guidelines determined by this study committee.
 - o The federal government will be restrictive on what we can and cannot do and there could be a conflict if we say now what will be allowed. Nearly all of our welcome centers were done with federal funds and we cannot sell items there. There are a lot of restrictions already and we need to get a better understanding of what they will end up being. Where the federal government is leaning towards is the sign, sponsorship, and picking up trash. I am comfortable with the way it is now because it comes back to Long Range. I do not think it is premature, but if we put on qualifications on it now the feds could end up restricting that.
- Senator Watters pointed to lines 24-25 that the RFPs would go to Long Range. Would the procedures go to JLCAR and what kind of oversight would there be on the processes involved as to who gets to do what.
 - o Doesn't see any legislative oversight beyond Long Range. If there needed to be rule making, then it would go to JLCAR, but that would have to be a legislative statement and therefore the department would have to go through the rule making process. Subsequently, would want to wait for federal guidance to ensure that they match up.
- Senator Stiles asked when we could anticipate the guidelines.
 - o They have some other policies they are working on and this is not high on their priority list. I would expect guidance within a year.
- Senator Stiles asked if this timeframe is going to help address this.
 - o The expectation isn't that we would put sponsorship out this summer, understanding that we still need to determine the guidelines in conjunction with the federal government. It would be a year from now and at the same time the study would be looking at the closed centers. In discussions with DRED on where the operating

costs lie and to use federal planning funds to look at rest areas in general. There are 5 welcome centers in VT, Maine has 7, and including the closed ones, we have 16.

- Senator Rausch asked if all of the rest areas fall under the federal guidelines.
 - o Currently, the Hooksett ones are outside of them and there may be one or two on a secondary road, but most have used some federal funds and therefore fall under that jurisdiction.
- Senator Rausch stated that we really need those guidelines in order to proceed with this.
 See that the feds have opened it up and this is directing the department to work towards that.
- Senator Rausch asked if it is appropriate that both departments are in the bill and need to concur.
 - o I think that is appropriate as we have been working together on these. Currently, discussing DOT employing DRED to operate the facilities.
- Senator Rausch asked if the language should only read to sponsor and not purchase as well.
 - o I think it is fine as it reads, the federal government has used sponsorship and this will give us the flexibility if they expand.
- Senator Boutin stated that on line 23, any proceeds would be used to operate existing rest areas and asked since in some cases DOT runs it and some DRED does, so who would receive the proceeds.
 - o Currently, the operating budget for all of them has been transferred to DRED. In working on the Budget with the House, the operating budget is being transferred to DOT and then they will have a class line to transfer the funds to DRED. Therefore, in this, the DOT would have an organizational code, so that the revenue would go directly into that class line for DRED.
- Senator Stiles asked where the proceeds to run these are currently coming from o From the Highway Fund or Turnpikes.
- Senator Rausch stated that the DOT receives the moneys and they pay DRED out of a line item.

Good Morning,

Thank you for considering my bill.

I don't have prepared notes for everyone, however you are welcome to share this.

For two years, I have driven to Dover Point or to York, Maine and passing by this State Rest Area on Route 4 in Epsom, I got so disappointed at seeing this place so lonely, so desparate for someone to cut the grass, spruce up the outside, cut down the rope preventing someone who is tired and needs a break for a few minutes before having an accident. The big sign states this is a "Blue Star" rest area. I am not sure what the Blue Star means, but I feel it is a patriotic meaning.

I decided to find out who was responsible. I had also seen a similar situation on Route 25 in Rumney, a building that use to be bustling and now sitting there wanting to know, how come? The following Monday, I spent 3 hours on the telephone calling so many agencies and getting the same answer, hold on, I will transfer you to the right department. Then I get told please try this number, as they will know who the correct person is. Okay, so I try another 2 hours of useless calls. Finally I decided once I got elected to State Representative, I would file a bill and then see if something would get done.

Then, in my role as NH State Grange Historian and Community Service Director, I ask Granges throughout the Granite State to do community service projects for the year. Winthrop Grange of Shelburne chose as their project the State Rest Area Building on Route 2 in Shelburne. The members of this Grange along with area Granges felt this rest area provided services to travelers throughout the Northeastern section of NH and Western Section of Maine who are traveling for skiing and snowmobiling etc. They wrote letters to the Governor, Executive Council, and many other politicians. They got responses from some

who agreed with them but to date, nothing has been done. They submitted a booklet outlining their project to me for consideration to be judged. I was very impressed with their efforts.

I know that the State had to make cuts but I feel these two Rest Areas, along with Shelburne and Antrim? provide an important outlet for people who are traveling. If the building couldn't be opened, the driveway should be for travelers who need a break from driving should be open. How about travelers who have a dog in the car and would like to stop for a moment and take the dog for a little walk and even themselves for a breath of fresh air. How about the kids who are tired from riding and are asking to stop for a few minutes? There are many reasons for the driveway to be opened for travelers to stop for a few minutes. If you are traveling East from Concord to Portsmouth. there are no areas along Route 4 to stop and take a break. Yes, there are a couple of little stop offs to so to speak in Epsom, but they don't have picnic tables or trash barrels, or room for more than two vehicles at one time. James Park in Epsom was at one time a nice picnic area, now it is in shambles. Traveling through Northwood, Notitingham, Barrington, and Lee, there is nothing for a rest area to stop. Yes you have a couple of restaurants at the Lee traffic circle, but unless you want to eat, there is no place to pull off the road and rest. Continuing into Durham, then Dover Point, the only place is Hilton Park, but you have to turn off to the right just before the Spaulding Tpke and it is not very accessible. The traveler then gets on the Spaulding Toke, and goes either onto I-95 to Hampton or Mass or stays on Spaulding to the Portsmouth Traffic Circle and then whether they go to Portsmouth or to Kittery Maine, again, there is not area to pull off to the side.

Traveling from Concord to Woodsville, once you leave I-93 at Exit 26 and travel through Plymouth, you can stop at Dunkin Donuts or Burger King, but there is nothing until you get to Woodsville. The rest area on Route 25 in Rumney was a good spot to stop and stretch or gather information about the tourist attractions in the White Mountains.

I wonder if it would be possible for a committee to look at the possibilities in getting these opened up. Is it possible to do Adopt a Highway type program with these rest areas? The Route 4 in Epsom could be adopted by possible the Town of Epsom, or how about the Lions Club, Elks, Garden Club, VFW, American Legion. I was thinking these could be open from Friday to Sunday from Mid May to Columbus Day; and again from Mid November to Mid March; Or Thursday to Sunday with the times being 9 a.m. to 6 p.m. If one organization couldn't do the whole time, how about having the Lions, Elks, Moose, Kiwanis, Rotary, Grange, Woman's Clubs, Jaycees, Odd Fellows, Masons, Eastern Star, Rebekahs, Garden Clubs, Churches, the list goes on and on. They could join together and adopt the rest area, what pride they could have, someone from those groups must have a lawn mower that could mow the grass, trim the bushes, the Garden Club could plant flowers, and Bird Club could provide bird houses if there was a small pond or

brook. Who knows, there are so many possibilities that could take place. They could even sell products made by their clubs, farms in the area, maple syprup, berries, etc. Only products made in NH, no made in china. Most importantly, the flags would be flying outside. The welcome signs would be out. I know there could be pitfalls, but to me, the endless possibilities are there. What about the holiday weekends, you could be serving coffee for those drivers, we have seen them on the interstates in some states. I k now there are many details but let's have a small committee to work with DRED and Transportation to see if these could work. nothing ventured, nothing gained.

Let's show New Hampshire is a friendly place to visit!

I have met with both Dept of Transporation and with Department of DRED and found them to be very supportive and willing to come and talk today.

I am also pleased to have Rep. Scott Burns working with me.

Thank you for listening to my thoughts.

Representative Patten came to me on this idea of studying our rest areas to keep them open. I thought about this past year when our rest areas were threatened to close. I know when I was working in Virginia; all rest areas were closed because of budget cuts. Who moved the lawns? Volunteers did. Rest areas are for safety when traveling a long distance. These need to stay open to some extent. The facilities were closed but truckers could still stop and rest or sleep. There were different organizations that were responsible for moving the lawns and cleaning up the garbage.

I travel the interstate highways throughout New England. In Connecticut, there is a rest area that has the local Boy Scouts giving out coffee. There is a sign promoting to use the rest area for safety reason. Take a break and have a cup of free coffee. When you enter, there is a tent full of food to go with your coffee where you can give a suggested donation. When I go to Vermont, they have their own Vermont Green Mountain Coffee which you can donate money if you chose. Why doesn't NH have their own coffee? Why doesn't NH have free coffee at their rest areas? We should be promoting more NH values and products at our rest areas.

We really need to have someone study these rest areas to keep them open and reduce the amount of state funding. Coffee is a way to get people to use the rest area. If more people use the rest areas and if there was a way to generate some revenue then this would be cost effective.

One suggestion to generate revenue for the state is to install 110 or 220 outlet for hybrids or electric cars. By 2015, they will be more in demand and consumers will have more options to buy. If we can somehow install these outlets and charge the customer money, then we can generate some revenue. This is another reason why we need to study rest area usage.

I urge the committee to support HB 635. There is a lot to think about to ensure we can keep our rest areas open to encourage safety on our highways, reduce spending of our rest areas and generate some revenue from our rest areas.
