Summary of testimony presented in support:

Representative Byron (submitted written testimony)

- This is the result of an incident in Litchfield a year and half ago, where an abutter asked to restrict outward boaters on a pond and sent a petition to the Department of Safety
- Under current RSAs this petition results in public hearings held by the Department of Safety and the Department then makes a decision as to whether or not it should move forward.
- Did some research and found under RSA 270:75, the only exemption to an enacted restriction would be provided to state employees when it is essential to the discharge of their duties during an emergency or extraordinary situation.
- Municipal employees are not covered under this exemption.
- Originally, this bill would have allowed municipal emergency personnel to be exempt and to allow them to practice on these bodies as well.

- In the House there was a lot of discussion and concerns dealing with the permitted use, the process for allowing this, and how some ponds are environmentally sensitive
- It was suggested in the House to implement a permit basis, where the municipal offices would have to get a permit from the State each time. This was determined to be too cumbersome.
- This amended version only gives municipal employees the same rights in emergency situations as state employees
- Feels that this version does not consider enough possibilities and you can't make a blanket statement to address all these scenarios.
- Recommends changing the RSA to allow the Department of Safety, during their hearing process, to determine whether or not to allow certain exemptions.

Captain Dunleavy (Marine Patrol-Department of Safety) (submitted written testimony)

- In favor of the bill in its proposed form and believes municipalities should have the same exemption state employees have.
- The Department does have a permit process that in the case of hardship they can issue for a body of water that has a ban.
- This permit does not need to be renewed annually, only when there is a change in ownership
- The Department is willing to discuss the Representative's recommendation but, a blanket statement for training purposes might be a slippery slope
- Senator Birdsell questioned if the Representatives recommendation regarding permits would be a slippery slope.
 - O Doesn't think that would be, but there are many of bodies of water in the State that already have a restriction in place. That would mean they would all have to have another hearing, which would be a significant lift to re-hear all of those restrictions. The Department could potentially already do this with the permit process they have.
- Senator Lasky asked how long it currently takes to get a permit.
 - o The application is available online and they normally go through the process within a week and are free. The restriction hearings can also only be heard between June-September, by statute, to allow vacation homeowners to be present.



LEGISLATIVE POSITION NH DEPARTMENT OF SAFETY

HB 254: Relative to exempting municipal employees from operating restrictions of power boats during the execution of their duties at time of an emergency or extraordinary circumstance.

Position: In Favor

Dear Honorable Members of the Committee:

HB 254 proposes to extend the same exemptions to municipal employees currently granted to State employees by allowing them to operate power boats on restricted bodies of water while executing their duties during an emergency or extraordinary circumstance.

Currently RSA 270:75 allows for the operation of motor boats on restricted bodies of water by State officials *only* while responding to an emergency. Current restrictions in this sub-section include outboard motors, motors above certain horsepower levels, petroleum powered motors, electric motors, and a variety of speed limits.

Reasons for the above restrictions often include the size of the water body (safety concerns when large boats operate at high speeds), drinking water supply, water depth (environmental impacts), and endangering critical wildlife habitat.

It is the opinion of the Department of Safety that exempting public safety officials at the State and municipal levels from these restrictions is essential to their duties in emergency situations.

The Department of Safety respectfully recommends passage of HB 254.
