Testimony of Deputy Attorney General Ann Rice 2017 Senate Bill 67 March 29, 2017

- DOJ requested bill to address ambiguity in law re SP jurisdiction to enforce MV laws
- Amendment necessary to protect criminal charges and eliminate liability question
- MV enforcement critical to stemming flow of illegal drugs into NH on our roads and to protect NH travelers from drugged driving
- Bill wd give SPolice statewide jurisdiction to enforce MV laws
- Current law: RSA 106-B:15
- SP has full law enforcement authority, concurrent with local police, on all turnpikes, toll roads and interstates, and in towns under 3000.
 - In places over 3000: no jurisdiction except:
 - Witness a crime
 - Is in pursuit of a suspected law violator
 - In search of person wanted for crime, or witness to crime
 - When traveling through
 - When acting as agent of DMV to enforce rules re: drivers' licenses, registration, and inspections
 - When requested to act by another law enforcement agency
- NHSupreme Court recognized RSA 106-B:15 is compromise between 2 objectives: (a) minimize competitive friction between law enforcement agencies and to provide for efficient deployment of SP and (b) enforcement of criminal laws. *State v. Bennett*, 116 N.H. 433 (1976).
- Law has worked well for 35 years, but population has grown, world has become more litigious, and we are seeing problems
- SP has routinely patrolled major, highly travelled roads like 101, 202/9, 125, 16, 106.
- Initially, those roads passed thru towns under 3000K limit.
 - W/population growth many towns have exceeded that limit
- SP has continued to patrol; not as a result of specific request, but more "implied"
- Public / locals expect SP presence
- But, as we become more litigious, cooperative "implied" agreement insufficient
- Criminal defendants are challenging SP MV stops on grounds it was outside SP jurisdiction
 - Claim is that SP is patrolling area illegally
 - Most claims brought in Keene area, but spreading
 - o Recently, SP charge in Concord was dismissed be of jurisdiction
 - Ironically, neither the Concord, nor Keene chief have problems with the actions of SP
- SB 67 wd give SP statewide authority to enforce Title XXI relative to MV laws
- Similar change was made for F&G Conservation Officers in 2014

- RSA 206:26, XV added gives same authority, even absent any violation or suspected violation of F&G laws
- Bill would eliminate the problem of SP patrolling areas without express request from locals
 - o MV enforcement key to drug interdiction
 - Ensure that MV stops and any criminal charges that stem from them aren't subject to legal challenge
- Makes clear that so long as trooper was acting in good faith, no claim against the state or the individual
- Proposal wd not alter the current cooperative balance of law enforcement agencies
 - Not meant to diminish authority of local chief to any degree
 - Troopers trained to notify locals, even in towns under 3000K
 - o Included statement of purpose for that reason
- NH has huge opiate problem, and it's coming into state by MV
- We should eliminate any barriers to using all available LE resources to fight that flow, as well as the ongoing issue of dunk/drugged driving
- SP has worked with local chiefs on bill
 - o Bill has support of the members of NH Chiefs' Ass'n

Senate Bill 67 - Relative to the authority of state police employees

Dear Representative Welch and Members of the Committee:

My name is Peter Bartlett; I am the Chief of Police in Hooksett, and I appear before you on behalf of the NH Association of Chiefs of Police in support of SB 67.

Senate Bill 67 addresses the issue of jurisdiction of the NH State Police in communities where it has traditionally been limited (unless ordered by the Governor or requested by a local chief) ever since the NH State Police was created in 1937. Let me start by saying first that the relationships between local law enforcement agencies and the NH State Police have, perhaps, never been better in their 80-year history. I and my colleagues from throughout NH appreciate that, because it has not always been the case. Today, we work cooperatively with law enforcement throughout the state to serve the people of NH. And, as you well know, today's environment requires all of law enforcement to continue a smooth, cooperative effort to combat those challenges, especially the drug crisis that has gripped this state for the last several years.

With respect to the bill, the Chiefs recognize the concerns that the NH State Police have with liability issues and are very willing to address them. This is why we worked so carefully to ensure that any change in law is done correctly. In our discussions with the NHSP, we worked to incorporate language into the statute that addresses the NHSP liability matter. Our discussions were fruitful with both sides trying to achieve a result that will address liability while maintaining appropriate authority of the different law enforcement agencies.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1	1 Statement of Purpose and Findings.
2	I. The general court finds that:
3	(a) The use and misuse of prescription pain drugs and opioids has become a significant
4	problem in our state.
5	(b) The incidence of dependency, addiction, and death continues to increase at an
6	alarming rate.
7	(c) The opioid drug misuse problem has broad implications for society, including the

9	(d) A focus on ways to address the opioids drug abuse problem will benefit society, save

26	treatments, including non-opioid and abuse deterrent formulation opioid therapies.
27	II. The committee shall solicit information from health care providers, drug addiction
28	counselors, patients and any other person or entity the committee deems relevant to its study.
29	5 Chairperson; Quorum. The members of the study committee shall elect a chairperson from
30	among the members. The first meeting of the committee shall be called by the senate member. The

- 1 first meeting of the committee shall be held within 45 days of the effective date of this section. Three
- 2 members of the committee shall constitute a quorum.
- 6 Report. The committee shall report its findings and any recommendations for proposed

 clerk, the house clerk, the governor, and the state library on or before November 1, 2016.
- 6 7 Effective Date. This act shall take effect upon its passage.
