Sen. Fuller Clark introduces her bill. Reestablishes commission with no real changes. Forty thousand children go to bed hungry every night. There is hunger in public schools. Free breakfasts for those receiving reduced cost lunch at public schools FAILED in NH Senate. Commission looked at causes of hunger in NH and what could be recommended: Keep SNAP program, new stand alone bill for Granite Works (separate from SNAP), family assistance for 2 parent families but limited income (program done away with in 2011). Free breakfast for ALL NH students because some middle class families have problems with getting everyone breakfast (the idea died in Senate.) Summer food program for children but not taken advantage of - if we added parents, too, maybe we would get children's participation, too. Disabled children aging out of their programs. Access of food for homeless.

**<u>Rep. Nelson</u>** - The more we do, the less parents take responsibilities, and that's not good in the long run.

<u>Sen. Fuller Clark</u> - Not sure of that. In spite of turnaround in our economy, there's <u>more</u> demand on our food banks. Build a safety net around our kids even if a few parents are not doing their part.

**<u>Rep. LeBrun</u>** - Would you give us a copy of report from last Commission?

Sen. Fuller Clark - Yes.

Bill Sponsors:

Rep. Kotowski - Why was former Commission on Hunger ended?

Sen. Fuller Clark - Sunsetted.

**<u>Rep. Guthrie</u>** -Have we identified what child hunger is? I had tea and toast and that was okay. Has the definition of hunger changed?

Sen. Fuller Clark - I have no answer to that.

\*Elaine Van Dyke, NH Hunger Solutions - read her written testimony.

<u>MaryLou Beaver, Family Assistance Advisory Council</u> - Hunger is still growing. We need innovative solutions and creative partnerships. The previous commission brought a diversity of people to the table, many with different perspectives and ideas.

<u>Eileen Liponis, NH Food Bank</u> - Fourteen million pounds of food go to 435 agencies around the state, especially to school food pantries and to help children not being fed in their schools and on weekends. Children of parents caught up in drug crisis. If they stay with grandparents, the grandparents are often not sure what they should/could do.

Rep. Kotowski - Is legislation necessary for you to do the good work you're doing?

<u>Ms. Liponis</u> - A commission gets us out of our individual silos. Absent legislation, our respective bosses will pull us back into our own silos.

# Testimony



#### Testimony SB 484 as amended- Re-establishing the Commission on Childhood Hunger

Good Afternoon, I'm Elaine VanDyke representing **NH Hunger Solutions**, a non-profit organization advocating and educating the public about issues related to food insecurity and access. Today we have an opportunity to discuss the merits of re-establishing a Commission on Childhood Hunger in NH.

Hunger, economic events, local geography, cultural backgrounds, family dynamics, life experiences, educational attainments, local state and national governmental philosophies of assistance, all play a part in how a state chooses to help those who need temporary or permanent help providing for themselves and their families.

This commission was tasked with assessing our landscape and bringing forward policy changes that would positively assist our children with access to healthy meals, assist in better understanding the realm of hunger and insecurity in our state, and identify existing partners in plans that would tackle a very complex issue.

We learned though some of the work of the commission, there is no one strategy, there is no one way, but multiple partners and methods that when coalescing together have impact. Hunger is complicated, children are complex in family environments, and we should not assume a quick result. NH is unique in its methods of evidence surveillance. We often take differing paths than other states, however, we would be incomplete without looking to other state models for guidance and thought, and we also must look to all the organizations within our state who are individually tackling hunger within families, with children, seniors and others. These are the grassroot efforts of this commission that will give a voice to our children and their need to be healthy and secure.

The re-establishment of this commission will allow a strong group of organizations, legislators, and others to continue to develop the NH way of tackling hunger among our most vulnerable – our children. This committee understands the importance of children being the healthiest they can be in their early years. Every time we enhance the health of our children we help ensure a healthy adult. We know children whose daily lives are full of uncertainty are presented with a more difficult successful path to adulthood. We continue to learn of the connections of childhood trauma and stress on children and know the fact that NH children often go to bed without a meal or an inadequate meal, or get up without a breakfast. This is a daily stress on children that is unnecessary and that benefits no one and does not make a strong resilient confident child or maturing adult.

Today you will hear, or have heard, from many who are involved in innovative efforts and the commission should be available to learn of this work. For so long it was believed that there were no hungry children in NH, and frequently we continue to hear this whispered today. There are NH children who are hungry, just ask school food service employees, ask a school nurse, check with a child care provider, they deal with hungry children every day and the numbers are not diminishing- this commission can and should come back with data to substantiate and put to rest the notion that there are no NH children that are hungry-let's move this conversation to a solution for what we know is a problem and let us bring this knowledge to the rest of NH. Allow us to continue this work by re-establishing the Commission

(e) One member of the New Hampshire housing finance authority, appointed by the 1314 authority. 15 (f) One member of New Hampshire Kids Count, appointed by that organization. 16(g) One representative of New Hampshire Hunger Solutions, appointed by the coalition. 17(h) One representative of the Granite State Children's Alliance, appointed by that 18 organization. 19 (i) One representative of the New Hampshire chapter of Every Child Matters, appointed 20by that organization. 21(j) One representative of a community action agency, appointed by the governor. 22 (k) One representative of United Ways of New Hampshire, appointed by that 23organization. 24(1)One representative of the New Hampshire Head Start Directors Association, 25appointed by that organization. 26(m) One representative of a Boys and Girls Club of New Hampshire, appointed by the 27governor. 28(n) One representative of End 68 Hours of Hunger, appointed by that organization. 29 (o) One representative of Child and Family Services of New Hampshire, appointed by 30 that organization.
