Be it Enacted by the Senate and House of Representatives in General Court convened:

1 District Courts; Judicial Districts. Amend RSA 502-A:1, X to read as follows:

X. CONWAY DISTRICT. The district for northern Carroll county shall consist of the towns of Conway, Bartlett, Jackson, Eaton, Chatham, Hart's Location, Albany, Madison and the unincorporated places of Hale's Location, Cutt's Grant, and Hadley's Purchase[, and those portions of the towns of Waterville and Livermore within the watershed of the Saco River and its tributaries]. The district court for the district shall be located in Conway, holding sessions regularly therein and elsewhere in the district as justice may require. The name of the court shall be the Conway District Court.

2 District Courts; Judicial Districts. Amend RSA 502-A:2, XXIX to read as follows:

XXIX. PLYMOUTH-LINCOLN DISTRICT. The Plymouth-Lincoln district shall consist of the towns of Plymouth, Bristol, Groton, Wentworth, Rumney, Ellsworth, Thornton, Campton, Ashland, Hebron, Holderness, Bridgewater, Alexandria, Lincoln, Woodstock [and those portions of the towns of], Livermore, and Waterville [not within the watershed of the Sace River and its tributaries]. The district court for the district shall be located in Plymouth, holding sessions regularly therein and elsewhere in the district as justice may require. The name of the court shall be Plymouth District Court.

3 Effective Date. This act shall take effect 60 days after its passage.

Summary of testimony presented in support: Senator Woodburn

- Represents Livermore, but not Waterville.
- · Asked to sponsor this bill by Rep. Ham.
- Knows the Judicial Branch has some language and supports that change.
- Livermore was a logging community.
- Created a YouTube video a number of years ago that chronicles the history of Livermore.
- Senator Lasky asked what the population of Livermore is.
 - o Zero, and it is quite difficult to get to.

Representative Bonnie Ham

- Represents Livermore and Waterville.
- Livermore is an unincorporated place, and it was the site of East Pond and a mill.
- Lincoln has been put in charge of any issue that comes up in Livermore.
- The Kancamagus Highway and the Triple-I Road both run through Livermore, so there could be cause to arrest someone there.
- Although it is a quiet area, if something did happen the law would require the Chief from Lincoln to go to the Conway Court.
- Lincoln's prosecutor is in Plymouth and going to Conway is quite the commitment.
- This will allow the Chief to go to Plymouth instead of Conway.

Chief Ted Smith (Lincoln Police)

 Previously, they were responding to accidents in Livermore but, they did not have jurisdiction.

- The Sheriff's Department and the State Police did not have the resources to cover it.
- Went to the Legislature and was given police jurisdiction over Livermore.
- Normally, only responds in Livermore to help with accidents or to help Fish and Game.
- There have not been any serious incidents.
- There was an armored car robbery, but that was taken over by the FBI because it was a federal offense.
- This bill will allow the police to go to the Plymouth District Court in the case of an arrest or ticket where the department has two attorneys.
- The Department's attorneys will not go to North Conway

Howie Zibel (NH Judicial Branch)

- Doubts there will be many cases.
- It would be best to have a certain effective date and would suggest July 1, 2018.
- Senator French asked if this will cause any particular burden on Plymouth.
