Be it Enacted by the Senate and House of Representatives in General Court convened:

1 McAuliffe-Shepard Discovery Center Board; Membership. Amend RSA 12-L:14, I to read as

- follows:

  I. The powers of the McAuliffe-Shepard discovery center corporation shall be vested in the members of a board consisting of not less than [9] 7 members. [One member shall be appointed by the speaker of the house of representatives and one member shall be appointed by the senate president.] The number of, the means of selection for, the length of terms, and the initial selection of
- the [remaining] board members shall be determined by the McAuliffe-Shepard discovery center commission, established in RSA 12-L:3, working in conjunction with any nonprofit organizations
  - supporting the center, and shall be submitted to the fiscal committee of the general court for approval before September 1, 2012.
    - 2 Effective Date. This act shall take effect 60 days after its passage.

# Summary of testimony presented in support:

Senator Reagan brought this legislation forward stating, by way of background, Senators were assigned to approximately 150 committees, which was in addition to their regularly scheduled standing committees.

- A few years ago when study committees were developed through legislation, three senators were assigned to each study. He suggested when study committees were developed through legislation there be assigned only one or two legislators on any one study committee.
- He accepted the appointment to membership on the Board of Directors of McAuliffe-Shepard Discovery Center.
- Once he accepted the appointment to be on the Board he realized there was no legislative reason for either a Senator or Representative to sit on this board.
- The McAuliffe-Shepard Discovery Center used to be a state agency. Since it has ceased to be a state agency, the two legislative members were never removed. This bill removes the legislative members from their board of directors.
