#### 1. Rep. Connors (Hills 13, Manchester Ward 8) - Prime Sponsor

- a. This addresses an issue they have been facing in Manchester. In talking to the city welfare director, the second largest expense is for cremation or burial. When someone dies and no one claims the body, the expense is left with the local welfare department. Opioid crisis causes people coming into the city without local family
- b. Currently, if they have less than \$1000 in liquid assets, funeral homes can use that money for the expense. However, if there's \$1001 in liquid assets, none of the funds can be used for cremation/burial.
- c. Q Dolan: How do you deal with joint accounts? (great question for lawyers, not sure, welfare director might know)

g. Q - Belanger: Law as written now speaks of the liquid assets at death -- cash in the bank. Once that sentence is deleted, the rest doesn't make sense. Assignment from where? (true, could use clarification)

#### 3. Buddy Phaneuf - Cremation Society of NH -- supports the bill with amendments

- a. His funeral home does 25% of all cremations in NH. \$1000 is the discounted rate. Each town/city details what they pay. Last year served 900 families across the state.
- b. The dollar limit isn't sufficient
- c. Should be in RSA 325 -- funeral RSAs
- d. Let's say someone has \$800 in the bank, but Manchester says \$750 is the limit, then that person is no longer a welfare recipient for assistance. They get an affidavit from the bank, shows a receipt, gets the money and works with family on the remainder
- e. For more than \$1000, they are not an assisted person, and therefore welfare parts no longer apply If welfare pays nothing, then the person is not a welfare recipient and no one gets anything.
- f. Someone could have \$3000 but the funeral homes are only able to get \$1000, the rest of the money has to be probated through probate court which is nine to twelve months currently in NH
- g. This would be better served being in the RSAs about funeral homes since funeral homes are the ones making up the difference and deal with this.

# Testimony

Re: Support of HB 301

Dear Honorable Chairman Carson and Committee Members,

As you know, NH State law requires that municipalities pay for the cost of final arrangements for deceased indigent persons, as well as, all unclaimed bodies found in the community at the time of their death. With the rise in the opioid crisis, and strained family relationships, welfare departments throughout the state have seen an increase in the cremation costs their budgets must bear. Paying for this cost when there is no other resource to pay for it is not at issue. That's what local welfare departments should do. However, paying for a person's final arrangements unnecessarily; in some cases when a deceased person has thousands for dollars in the bank, simply defies logic, and should not be a burden falling upon local taxpayers.

This proposed amendment will correct this situation. It will allow funeral directors to obtain the necessary funds from a person's bank account without involving the local welfare department. It will also provide relief to the deceased person's family, when those individuals themselves are indigent and unable to access the bank funds or raise the necessary money to take care of their loved one's final arrangements.

I want to thank Representative Erika Connors for sponsoring this common sense legislation that will save local welfare departments time and money.

Rep. Perreault,

Following the hearing on HB 301 you asked me to contact a geographically diverse mix of funeral homes and find out what prices they charge for burial or cremation services in the circumstances addressed by HB 301.

I spoke with welfare officers in municipalities around the state to determine which funeral homes they most often worked with, and then attempted to contact those businesses. I was eventually able to speak with knowledgeable staff at ten funeral homes, located in Alton, Laconia, Conway, Keene, Berlin, Manchester, Henniker, Newmarket, Claremont and Rochester.

As burials are more expensive than cremation, it was infrequent that the families of welfare assisted persons requested burial, and I was told in two cases that towns would flatly refuse to contribute money toward a burial.

The fee for a basic cremation ranged from \$1900 to \$2500. In cases where a welfare office was involved, the funeral homes offered a reduced rate, ranging from \$1000 to \$1650. I was told that municipalities offer a set benefit in these cases, and that each municipality is different. These benefits range from \$400 to \$1000, and are most often around \$700.

When I asked how the difference between the town benefit and the reduced rate was made up by the family of the deceased, most funeral homes indicated to me that they would attempt to seek funds from family, but that often it was simply written off as a loss. I was told that funeral homes have little leverage to extract repayment, and that within this population there is seldom the means to offer repayment. One funeral home director told me that payment plans are sometimes informally arranged – another that they would like to offer payment plans as an option, but that they don't have the administrative staff to make that practical.

I was told that funeral directors rely on knowledge of the community and personal interviews when they assess whether family might be able to contribute towards expenses. While the welfare offices possess more formal, detailed financial information, if that information indicates an ability to pay, the municipal contribution is reduced.

### HOUSE BILL 301-FN-LOCAL

This bill authorizes towns and cities to access certain funds for burial or cremation of assisted persons.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- Aid to Assisted Persons; Funeral and Burial or Cremation Expenses. Amend RSA 165:27-a, I
   to read as follows:
- 3 I. Except when a town or city assisted person has made arrangements for a prepaid funeral,

4 [if the total of his liquid assets at death are less than \$1,000;] there shall be an automatic

5 assignment to the funeral director or the person who paid for the funeral and burial or cremation of

- 6 the deceased to the extent of funeral and burial or cremation expenses up to \$1,000.
- 7 2 Effective Date. This act shall take effect 60 days after its passage.

#### METHODOLOGY:

RSA 165:3 requires towns or cities to provide burial or cremation services at the expense of the town or city for any person receiving local welfare assistance. RSA 165:27-a, I currently applies to such an assisted person and allows for the automatic assignment of up to \$1,000 for funeral and burial or cremation expenses to a funeral director or person who paid for such expenses, if the total liquid assets at death are less than \$1,000. This bill allows for the automatic assignment of expenses of up to \$1,000 in all cases irrespective of the calculation of liquid assets at death.

The New Hampshire Municipal Association states this bill may increase the number of cases in which funeral expenses are paid partially from the decedent's estate and could result in a decrease in the amount of expenses that are paid by municipalities. The Association has no information on the amount of funeral expenses paid by municipalities and the specific circumstances of individuals throughout the state, therefore they cannot estimate the possible decrease in municipal expenditures. There is likely no effect on municipal revenues.
