

Testimony

March 30, 2019

Testimony to the Members of the House Commerce and Consumer Affairs Committee:

I urge you to vote for SB 115 as amended. I have been a Licensed Clinical Mental Health Counselor since the license has existed. My New Hampshire license number is #32. I have been a counselor for 40+ years. I have been in private practice for more than 30 years.

I am sure that most of you are unaware that there is as much as a \$40.00 difference in the price paid to me per session based on which insurance a patient has. I am also sure that most people are unaware that the insurance company dictates what I will be paid for a particular service and that number is NEVER the amount that I charge. If I choose to be in the patient's network I cannot recover the difference. Although therapists are prohibited by law from comparing reimbursement rates, it is common knowledge that large groups can negotiate with insurance companies and obtain higher reimbursement rates than sole practitioners.

Regretfully, I have decided to deal with this situation by refusing to accept the low paying insurances. I have a full practice with a waiting list. I can do this and still see as many patients as I choose. But that's not right. All patients, regardless of their insurance, should have access to experienced clinical specialists.

I strongly urge the legislature to study this situation and look for ways to put all patients seeking mental health services on a level playing field, at least financially. If high quality mental health providers can make a living by accepting all insurances, or at least having the option to negotiate rates, I for one, would be happy to serve anyone I can help.

Introduced by Jessica Bourque, Administrative Assistant for Sen. Feltes – Commission is to take stock of previous efforts.

Question - Rep. Weber asks if consideration was given to combining with SB 176. **Answer** - Will get back to the committee.

Tyler Brannen, NH Insurance Department -

Department takes no position. There have been a number of insurance laws that have changed and have impacted this matter. Have updated network adequacy rules, minimum standards, county by county. One change is a higher standard for access to mental health services. So, it may be a good time to look at where we are and where we are going.

Question - Rep. Campion: Are standards more rigorous?

Answer - Yes. A new rule has a number of specific services and the standard is the type of service. Some services should be available locally within the network if they are available within the area, based on a time and distance standard.

Question - Rep. Shapiro: Why are community mental health agencies not included? Answer - We were not involved in the drafting of the bill.

Paula Rogers, Anthem -

Supports the bill. Hears concerns about network adequacy and reimbursement. Looking at the certificate of coverage gives some information but there are some trickier areas in which to measure parity. Anthem is under exam by the department. Recently the state adopted the 10-year mental health plan, which has a lot of focus on reimbursement. One of the complexities around insurance reimbursement is whether a hospital may have a separate contract which is more complex than a statewide amount. Some projections in the 10-year plan suggest that commercial providers' efforts will be inadequate, but Anthem has made efforts to assure mental health parity. Anthem thinks a public discussion of this is important.

Question - Rep. Woods: Would the report be made available to the commission?

Answer - It is part of the public record.

Question - Rep. Nelson: How many carriers are there in NH?

Answer - There are 4 dominant carriers. Other carriers may have a smaller book of business. Question - Rep. Schapiro: Some commercial payers pay less than half of what others pay, and those rates are less than what Medicaid pays. Will this lead to...?

Answer - Some would say you want to avoid having the state set rates. The bill gets at the point of

provider reimbursement. There is a lot of talk in the environment about the inadequacy of commercial reimbursement and there are some studies that feed into that discussion. We need to discuss if there is disparity.

Question - Rep. Schapiro: Would you be in favor of representation by the public mental health centers?

Answer - If somehow it could be recalibrated to cover this concern, she would have no objections.

Lynn Stanley, National Association of Social Workers, NH Chapter -

Supports the bill. The bill came from Clinicians United, whose members are primarily people in private practice. The more people who are in the conversation, the better. NASWNH is listed twice because it hosts the mental health coalition from which the representative will be chosen.

Question - Rep. Marsh: Negotiating wages will drive up the costs. Will this drive up the costs? Answer - That's why the commission is being established. It's not just about rates. Question - Rep. Campion: Most of the members listed are for one member of the public. Is that meant to imply that these members would not be providers of mental health services?
