Introduced By: Sen. Reagan -

Bill was sponsored at the request of the department. Intent is to receive de-identified data about people's use of therapeutic cannabis. The department is currently allowed to give out data only in an annual report.

Question - Rep. Fothergill: The original bill had some language about inspections of alternative treatment centers. Are you aware of this?

Answer - No.

Question - Rep. McMahon inquires.

Answer - This is a thing they did in Maine. Employees were confused in distribution centers, so they set up a spreadsheet about what conditions were best served by which strains of cannabis. Distributors were not expecting to collect and distribute data. This raw data may help research. Question - Rep. McMahon: With that information, are there any rules which will need to be put into place to put the data into context?

Answer - Rules may need to be edited.

Michael Holt, DHHS, Program Administrator for the Cannabis Program -

The department requested and supports the bill. Current law contains strict privacy and confidentiality requirements. Currently, the only way to release data is through the annual report which falls short. The bill allows the department to release data for public health research purposes. The program has been operational for three years. It is important to look at outcomes from a public health perspective. The department was approached by Dartmouth Health Center. They were unable to engage with researchers because there was nothing in the statute to allow this. Could also use the data to demonstrate a decrease in Medicaid costs.

Question - Rep. Shapiro: Does this change the kind of data that is collected?

Answer - No. Efficacy data is currently permitted to be collected on a voluntary basis.

Question - Rep. Woods: How granular is that data that you are collecting?

Answer - Some data only covers the primary condition. The 2018 data report shows what is currently collected. We are entering data that Alternative Treatment Centers collect. Doctors are welcome to indicate any secondary conditions, but we do not parse out which are primary, and which are secondary.

Question - Rep. Woods: Have researchers requested particular data sets?

Answer - Yes.

Question - Rep. Knirk: Why was a section of the bill as introduced, having to do with problems

with quality, pesticides, etc., removed?

Answer - The bill was introduced as a place holder while the department completed work on it. The discussion in the Senate was on the amendment only. The bill was intended to be a single-issue bill. The issues removed can be taken up by the oversight board and further legislation.

Question - Rep. Knirk inquired further.

Answer - Since the medical oversight board is charged with looking at cannabis testing data, they would be permitted to look at cannabis testing data.

Question - Rep. Campion: Regarding line 9, health care information sharing has to do with the ability to transfer care from one provider or another but can also be used for claims. To what extent will these be used for business development purposes?

Answer - Unknown. The data requests are per the approval of the commissioner. If the commissioner believes it is inappropriate, it would not be permitted.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 Use of Cannabis for Therapeutic Purposes: Annual Data Report. Amend the section heading of RSA 126-X:10 to read as follows:
- 3 126-X:10 Annual Data Report; Release of Data.
- 2 New Paragraph; Use of Cannabis for Therapeutic Purposes; Annual Data Report. Amend 5 RSA 126-X:10 by inserting after paragraph V the following new paragraph:
 - VI. Notwithstanding any other provision of law, data collected under this chapter, including de-identified or aggregate data contained in the confidential registry database, may be released, with the approval of the commissioner or designee, to individuals or entities for the purposes of public health, health care operations, or research if such release is consistent with all applicable HIPAA standards.
 - 3 Effective Date. This act shall take effect 60 days after its passage.
