This bill allows for the automatic assignment of expenses of up to \$2,000 in all cases if there are any liquid assets at death.

The New Hampshire Municipal Association states this bill may increase the number of cases in which funeral expenses are paid partially from the decedent's estate and could result in a decrease in the amount of expenses that are paid by municipalities. The Association has no information on the amount of funeral expenses paid by municipalities and the specific circumstances of individuals throughout the state, therefore they cannot estimate the possible decrease in municipal expenditures. There is likely no effect on municipal revenues.

Summary of testimony presented in support:

Representative Connors

- This issue came up when she was meeting with the local welfare department in her district.
- The number two expense for the department is funeral expenses for individuals with no family or money for burial.
 - They spent \$25,000 last year in burial assistance.
 - Current law states that if someone dies in the city and has less than \$1,000 in their account the welfare office can access those funds to pay for funeral expenses.
 - If the account has more than \$1,000 the welfare department cannot access the money.
 - The bill was amended in the house to bring the discounted rate for funeral expenses to \$2,000.
 - Senator Birdsell asked if there is any information on how much that brought in for the city. Representative Connors replied that last year they paid out \$25,000 but she does not have a figure on how much was reimbursed.
 - Senator Morgan asked when the \$1,000 rate was set. Representative Connors

replied that she does not know.

Cordell Johnston - NH Municipal Association

• The existing statute does not make sense. If you die with no money you have to pay but if you die with money you don't have to pay.

Patricia Murphy - NH Local Welfare Administrators Association

- Under RSA 165 local welfare offices are required to pay for basic needs such as burial expenses.
- This bill is making a correction from 2001 when they set the discounted rate at \$1,000.
- When people do have the funds to pay, the welfare office cannot access those funds.
- With this bill the funeral expenses will be paid directly to the funeral company.
- Senator Birdsell asked if \$2,000 is enough. Ms. Murphy replied that as referenced in the fiscal note they are just looking for cremation and burial services and \$2,000 should cover that.

Peter Morin - NH Funeral Directors Association

- He is a licensed funeral director.
- This bill will allow funds to be accessed up to \$2,000 instead of only \$1,000 as current law allows.
- The funeral profession has always cared for the people in the community and they are facing an increased number of indigent deaths due to the opioid crisis.
- The change is language creates a limit of \$2,000 which reflects real cost. Real costs are a basic overhead cost. Funeral homes have to be open 24 hours a day to serve if needed.
- Many funeral homes have been subsidizing this, but they cannot any longer.

Please accept this letter as testimony in support of HB 301 on behalf of the Local Welfare Administrators Association (NHLWAA). Our Association is a professional non-profit organization that works to support our municipal members to insure that we are providing the basic needs assistance to our residents (mandated under NH RSA 165) while being cognizant to the delicate balance of spending municipal taxpayer dollars.

Under this general assistance per NH RSA 165 municipalities support the very basic of human needs such as housing, electricity and heat, food and personal care items, and access to medication for some of our most vulnerable constituents.

One category of general assistance includes basic expenses for cremation or burial. When there is no family or family are unable to afford to pay for basic cremation or burial then the municipality in which the deceased last resided may have to pay for this basic need. If the resident has assets and has no legal process to access those liquid assets, funeral companies refer these cases to the local welfare offices for payment.

This bill will allow the funeral companies, to be able to access enough liquid funds, if available, to be paid directly to the funeral company and eliminate the need for an immediate payment until the estate is probated and settled by Local Welfare.

Funeral costs are expenses for municipalities and there are not always liquid assets available to hope for repayment. The costs for these actual expenses are attached in a spreadsheet. If this bill passes the reduction of expenses will only apply to those assisted who have liquid assets that cover this basic expense.

Dear Senator Levesque and Members of the Committee:

My name is Peter Morin, and I am here to testify in support of HB 301 on behalf of the New Hampshire Funeral Directors Association. I am a practicing NH licensed funeral director and embalmer, and I am also the current Executive Director of the Association.

The New Hampshire Funeral Directors Association consists of 200-member funeral directors from 89 funeral homes and chapels. Since our founding, the guiding principle of the New Hampshire Funeral Directors Association has been the commitment to represent our member funeral homes and advocate for the families of New Hampshire.

HB 301-FN-LOCAL would authorize towns and cities to access certain funds for burial or cremation of assisted persons.

The statute currently has a total asset cap of \$1000. In the case of an assisted person having any amount exceeding \$1000 in liquid assets, these funds are ineligible. The change in language creates a limit of \$2000, which reflects real costs, but removes the disqualifying clause in the event the deceased had assets greater than \$2000.

Municipalities bear the legal and financial responsibility of providing for the disposition of deceased indigent and unclaimed residents from their jurisdiction. New Hampshire cities and towns face the increasing number of indigent, homeless and unclaimed opioid overdose deaths.

Some of these individuals may not qualify as assisted persons, but HB 301 would create a more straightforward process to access available funds to help alleviate the overall financial burden faced by cities and towns.

For these reasons, we ask you to vote Ought to Pass on HB 301-FN-LOCAL.
