Some who testified said they left the child day care business entirely because of this problem. 

Rep. McWilliams, prime sponsor and an architect, introduced the bill. She wanted a better appeals process and wanted the study committee to learn how other boards handle violations; how they handled due-process considerations. She said there were two types of appeals available. One was "internal" and the other before the Commissioner of HHS. She said the internal appeals felt "stacked." She said the other appeal tended to be used for major violations that could result in loss of license.

Kristen Biron, who owned a day center in Manchester for 25 years, spoke in support. She said that the rules were hard to understand and follow. She described her personal experience with the appeals process and was eventually vindicated.

Sally Wuellenweber, a child care center owner, spoke in support. She described her experience with the relicensing process. She said there were inconsistencies in the appeals process. She felt there was no due process and could lead to damage to reputation and livelihood.

Melissa Clement, Chief of Child Care Licensing Unit of Dept of HHS, spoke for information and said she supported the bill.

Brenda Converse, owner of a child care center in Allenstown, spoke in support. She described her personal situation. She said the person who was doing the relicensing inspection was "argumentative" and spoke poorly of the inspector who preceded her. Ms. Converse felt that the appeals board was agency people and felt that she was not heard.

Joanne O'Shaunessey, an owner for 45 years who had just sold out, spoke in support. She said that when the relicensing inspector came "everybody starts shaking." She said that notice of the violation appeared on the internet before the case had been decided.

ANALYSIS

This bill establishes a committee to study the creation of a neutral appeals process to review violations committed by a child day care agency.

This bill is a request of the committee to study issues and impediments to starting, running, and growing home and commercial day care facilities in New Hampshire established in 2019, 173.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 Committee Established. There is established a committee to study the creation of a neutral appeals process to review violations committed by a child day care agency.
 - 2 Membership and Compensation.
 - I. The members of the committee shall be as follows:
- (a) Three members of the house of representatives, appointed by the speaker of the house of representatives.
 - (b) One member of the senate, appointed by the president of the senate.
- II. Members of the committee shall receive mileage at the legislative rate when attending to the duties of the committee.
- 3 Duties. The committee shall study the creation of a neutral appeals process to review violations committed by a child day care agency.
- 4 Chairperson; Quorum. The members of the study committee shall elect a chairperson from among the members. The first meeting of the committee shall be called by the first-named house member. The first meeting of the committee shall be held within 45 days of the effective date of this section. Four members of the committee shall constitute a quorum.
- 5 Report. The committee shall report its findings and any recommendations for proposed legislation to the speaker of the house of representatives, the president of the senate, the house clerk, the senate clerk, the governor, and the state library on or before November 1, 2020.
 - 6 Effective Date. This act shall take effect upon its passage.
