The majority agrees. The majority has confidence in the wisdom of the people of New Hampshire and believes that they should be heard. The majority concluded that to not support this Ammendment was to not trust the people to know what is best for themselves and would be antithetical to the principals of self-governance."

To the Honorable Members of the NH House Criminal Justice and Public Safety Committee:

I am against this Amendment because:

- 1. It unnecessarily pits NH State law against Federal law and sets a negative precedent.
- 2. In vetoing proposed gun legislation last year, Governor Sununu said that the language of the NH Constitution "provides what many believe to be more expansive legal protections for gun ownership than the Second Amendment to the United States Constitution."
- 3. The statement that "All persons have the right to keep and bear arms in defense of themselves, their families, their property, and the State" does not and should not eliminate the ability of NH residents to devise solutions to social problems related to gun violence. Cutting off debate on gun rights by limiting the ability to pass gun safety laws would silence the many NH residents who believe in sensible gun laws.
- 4. The proposed amendment ignores the fact that, according to the American Public Health Association, gun violence is becoming a significant public health crisis and a leading cause of premature death. This issue is not only about the loss of human life from homicide and suicide but includes the trauma that gun violence survivors live with every day.
- 5. According to the American Public Health Association,
 - More than 39,000 people in the U.S. die as a result of gun violence;
 - Gun violence has a disproportionate impace on young adults, males, and racial/ethnic minorities;
 - Guns are the leading method of suicide in the U.S.;
 - Gun violence cost the U.S. \$229 billion in 2015, or an average of \$700 per gun in America
