### STATEMENT OF INTENT

This bill amends RSA 41:14-a which relates to the statute which outlines how a select board may acquire or sell municipal land, buildings or both. This bill makes two major changes to the statute. First, it adds the demolition or disposal of municipal buildings, other than a sale, to the breadth of the statute. Currently the process calls for the planning board and the Conservation Commission, if they exist within a town, to make recommendations to the select board concerning the disposition of municipal land and buildings. The second statute change within this bill is the addition of the Heritage Commission, if such a commission exists within a town, and the Historic District Commission, if the building lies within the defined district, to become part of the review process for recommendations being made to the select board. What prompted this bill was that there were more and more examples of towns knocking down historic buildings. The current statute only addresses the sale of municipal buildings and not the demolition of these buildings. When it comes to historic buildings, the Heritage Commission within a town is best positioned to inform the select board of a buildings historic value. The committee unanimously agreed that these two changes were needed.

Dear Chairman Donlan and members of the committee:

The NH Preservation Alliance urges your support of HB164, a proposal that includes "demolition or disposal" in the list of municipally-authorized activities along with "acquisition or sale" and includes municipal heritage commissions and local historic districts in the consultative process as outlined in RSA 41:14-a.

As the statewide non-profit historic preservation organization, the Preservation Alliance has individual, business and organizational members throughout the state. We help about 100 community projects a year and represent and assist towns and cities, planning boards and heritage and historic district commissions as well as community development organizations, historical societies, "friends groups," planning commissions and housing agencies.

Municipalities are juggling so much day to day, year to year. This important change should be a very positive addition to city and town law and procedures.

- From a municipal management process, we think this proposal adds predictability to acquisition and disposition processes. This commitment to utilizing the commission advisors seems practical and sound.
- From a historic preservation and community development perspective, processes like this help can set a positive and effective course for acquisition and management of a historic resource, and/or help prevent unnecessary losses of irreplaceable historic assets.

Heritage Commissions are doing tremendous work across the state. The number has grown steadily since the Legislature established this younger "sister" of Conservation Commissions, and we're approaching 70 by our most recent count. From Keene and Lebanon to Erroll. These groups of volunteers are actively engaged in survey and planning projects, education and outreach, assistance to other municipal bodies, and, at times, rehabilitation or restoration projects. They are important players in the positive

trends of investment in our communities that we can see in the growth of use of preservation and community development tools that the NH Legislature has established over the years, at ribbon cuttings and awards ceremonies, in support of local jobs and stabilized or enhanced property values, and in daily life in our communities.

This bill authorizes selectmen to demolish municipal buildings. This bill also provides for review of any proposed demolition by the heritage commission and the historic district commission, if any.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 Selectmen; Demolition of Buildings. Amend the section heading of RSA 41:14-a to read as follows:
- 3 41:14-a Acquisition or Sale of Land, Buildings, or Both; Demolition or Disposal of Buildings.
  - 2 Selectmen; Demolition of Land or Buildings. Amend RSA 41:14-a, I to read as follows:
  - I. If adopted in accordance with RSA 41:14-c, the [selectmen] select board shall have the authority to acquire or sell land, buildings, or both [;], and to demolish or otherwise dispose of buildings, provided, however, they shall first submit any such proposed acquisition, [or] sale, demolition, or disposal to the planning board, [and to] the conservation commission, the heritage commission, and the historic district commission if the building lies within a defined district for review and recommendation by those bodies, where [a] such board or [commission or both, commissions exist. After the selectmen receive select board receives the recommendation of the planning board, [and] the conservation commission, the heritage commission, and the historic district commission if the building lies within a defined district, where such board or [commission or both] commissions exist, they shall hold 2 public hearings at least 10 but not more than 14 days apart on the proposed acquisition, [ex] sale, demolition, or disposal; provided, however, upon the written petition of 50 registered voters presented to the [selectmen] select board, prior to the [selectmen's] select board's vote, according to the provisions of RSA 39:3, the proposed acquisition, [ex] sale, demolition, or disposal shall be inserted as an article in the warrant for the town meeting. The [selectmen's] select board's vote shall take place no sooner then 7 days nor later than 14 days after the second public hearing which is held.
  - 3 New Paragraph; Demolition or Disposal of Municipal Buildings. Amend RSA 41:14-a by inserting after paragraph II the following new paragraph:
  - III. The provisions of this section shall not apply to the demolition or disposal of, and the selectmen shall have no authority to demolish or dispose of, any real estate that has been given, devised, or bequeathed to the town for charitable or community purposes except as provided in RSA 498:4-a or RSA 547:3-d.
  - 4 Application. This act shall be effective in all towns that have previously adopted the provisions of RSA 41:14-a, without further action by the town.
    - 5 Effective Date. This act shall take effect 60 days after its passage.
