Q Harvey – Did you say this is something cannot be changed in rules/ Why?

A Because it currently exists as RSA

Q Laflamme – Is it because hunting pistols are revolvers that there is the increase to 6 rounds, because most game arms have 5?

A Request of constituent

CHAIR - we will ask that of Col. Jordan

- *William MacDuff Hunter in Carroll county. Our belief is the current list of approved calibers needs to be improved. Current allowed firearms have more muzzle velocity than pistols. Requesting the change to 6 rounds because most revolvers have a capacity of 6. Believes these changes will be good for new generation.
- *Col Jordan To speak to 6 vs 5 rounds issue. Initially hesitant because municipalities may have their reasons. But agrees with list in bill. Concerned about legislation that confuses people and makes criminals out of people making mistakes. Worried about not having a consistent number. Asked sponsors to make consistent, so went with 6 for all firearms across the board. Simple and not confusing and not a resource issue. Commission does not oppose.

QChair – Could there be a problem when a hunter is carrying for personal safety?

A This would clear that up

QWolfe - Are we stepping on towns?

A Towns that had these restrictions were concerned about safety so we are hesitant to run over towns decisions. Having the Municipal Association review this would be good. But it doesn't have an effect on resource or humane take. We cannot speak for towns and we haven't had issues.

QWolfe – How many towns affected? A Believe there are 5.

QWolfe – Have we heard from them? A Not yet, no one has reached out.

Q Spillane – Ballistics on modern long guns in excess of pistols in bill, and if there were problems in these towns wouldn't they have already had issues because these rules were created a long time ago? A Agrees, some are 1400-1500fps, not a safety issue.

Testimony on HB 192, relative to pistols permitted for the taking of deer and HB 342, relative to the taking of game by certain lever-action firearms

We write to express the position of the New Hampshire Fish and Game Commission and the New Hampshire Fish and Game Department to express concern with the language of these bills as introduced, and work to clarify the provisions with the Committee.

HB 192 seeks to amend RSA 208:3-d in two ways. It adds additional models of pistols that may be used for the taking of deer in certain towns in the state that are listed in RSA 208:3-a through RSA 208:3-c. The Department has determined that for the purposes of our laws, the specific firearms listed are not of concern, as they are consistent in their capabilities with the currently allowed firearms.

The concern arises with the proposal to allow such firearms to be loaded with 6 rounds of ammunition, as opposed to the 5 rounds in the language of the current provision. Our desire is to avoid confusion for licensed hunters, whether resident or non-resident, as to the number of rounds that may be loaded into a firearm while hunting. If this provision is adopted as introduced, it becomes inconsistent with the 5 rounds allowed in rifles under RSA 207:3, II, and thus induces confusion.

For this reason, in the event the Committee determines that this change should be recommended, the Department respectfully suggests that the Committee make a decision as to whether RSA 208:3-d should read 5 rounds or 6 six rounds. The Department has no position on this decision.

We offer joint testimony here on HB 342, since the policy decision made in HB 192 impacts RSA 207:3. That bill proposes to add certain lever action carbines to the list of firearms approved for the taking of wildlife. As with the pistols noted in HB 192, the Department has determined that the specific firearms listed are not of concern under our laws, as they are consistent in their capabilities with the currently allowed firearms. The same concern arises for confusion, because RSA 207:3, II limits the rifles approved in RSA 207:3, I to 5 cartridges. One can imagine the confusion for a hunter who would be allowed to hunt with a pistol carrying 6 rounds, while on the same day also carrying a rifle limited to 5 cartridges.

For this reason, in the event the Committee determines that a change to allow lever-action carbines should be recommended, the Department respectfully suggests that the Committee also make a decision as to whether RSA 207:3, II should read 5 rounds or 6 six cartridges. The Department has no position on this decision.

In summary, in the event these two bills are to be recommended for passage, we request that the policy decision be made as to whether 5 rounds or cartridges, or 6 rounds or cartridges shall become the standard in these two statutes, and further that the sections affected by these two bills be reviewed together by the committee in an effort to maintain consistency and reduce confusion for hunters. We also note that the relevant statutes only apply in the municipalities named in RSA 208:3 through RSA 208:3-c. The Department has not notified those municipalities of the content of these bills, and takes no position as to the potential for impact upon those communities. This committee may wish to consider whether these proposals should be referred to the House Municipal and County Government committee for additional review and comment.

The below handgun ballistics chart will give true caliber and diameter of handgun cartridge bullet weight measured in grains, velocity measured in feet per second, energy measured in foot pounds—which also is a good indicator of handgun stopping power, and bullet trajectory measured in inches for the more popular handgun cartridges, (factory ammunition).

This handgun ballistics chart gives a good, reliable comparison of handgun cartridge ballistics. We have recently updated it to be more friendly on different size screens, and have added a search feature so you can more quickly find the calibers you're looking for. For example, if you type in 40 S&W, a few different options will show.

Same thing with all the other calibers. We plan to add to this ballistics chart as necessary.

Also, any links on any of the calibers themselves (inside the chart) should take you to a more in-depth summary of that caliber. This will be getting updated more as I have time. It's our goal to provide as much detail as possible.

The information in this chart itself is just meant to be used as a comparison.

Hello Mr. Macduff,

The regulations outlining what calibers can be used for deer hunting in towns with special rules is in state statute (i.e. state law), not in the Department's administrative rules. This means that to add new calibers, it would have to be done through the state legislature and can't be done by the Department. That said if a bill was proposed by the state legislature to add .45acp to the list of allowable calibers, I don't foresee the Department having any objections to that. I'm not sure why specific calibers were included or left out when the law was written other than they likely just included whatever the most popular hunting rounds were at the time.

208:3-d Pistols Permitted. – Pistols permitted under RSA 208:3, 3-a, 3-b, and 3-c shall include a .357 Magnum, 10mm Automatic, .41 Remington, .44 Magnum, .45 Long Colt, .480 Ruger, and .50 Magnum, provided that a pistol used for taking deer under this section shall be loaded with no more than 5 rounds of ammunition at any time.

208:3 Taking; Mode. –

Wild deer shall not be taken by the use of a firearm, other than a pistol as permitted in RSA 208:3-d, a shotgun loaded with a single ball or loose buckshot, muzzle-loading rifle, bow and arrow, or crossbow as provided in RSA 208:7-a, in the towns of the following counties as follows:

I. Belknap County: Laconia; Meredith Neck-that part from the Meredith Center Harbor line to Pleasant Street south and east of state route 25.

Pistol shooting deer and hunting altogether I vehemently oppose. I believe hunters and their beliefs do not outweigh the population opposed.

Hunting might have been necessary for human survival in prehistoric times, but today most hunters stalk and kill animals merely for the thrill of it, not out of necessity. This unnecessary, violent form of "entertainment" rips animal families apart and leaves countless animals orphaned or badly injured when hunters miss their targets.

A British study of deer hunting found that 11 percent of deer killed by hunters died only after being shot two or more times and that some wounded deer suffered for more than 15 minutes before dying.

Hunting also disrupts migration and hibernation patterns and destroys families. For animals such as wolves and geese, who mate for life and live in close-knit family units, hunting can devastate entire communities.

The fear and the inescapable, earsplitting noises from the gunfire and other commotion that hunters create cause hunted animals to suffer tremendous stress. This severely compromises their routine and their eating habits, making it hard for them to store the fat and energy that they need to survive the winter. Loud noises can also disrupt mating rituals and can cause parent animals to flee their dens and nests, leaving their young vulnerable to natural predators.

Contrary to what hunters often say in defense of their cruel pastime, hunting has nothing to do with "conservation" or "population control." In fact, animals are often specially bred and raised for hunters to kill.

If left unaltered by humans, the delicate balance of nature's ecosystems ensures the survival of most species. Natural predators help maintain this balance by killing only the sickest and weakest individuals.

Even when unusual natural occurrences cause overpopulation, natural processes work to stabilize the group. Starvation and disease are tragic, but they are nature's way of ensuring that healthy, strong animals survive and maintain the strength of their herd or group. After hunters kill the largest members of a population, the offspring of weak adults

have difficulty finding food and gaining the strength needed to survive extreme weather; therefore, hunting can actually cause starvation rather than prevent it.

1 Deer; Pistols Permitted. Amend RSA 208:3-d to read as follows:

Pistols permitted under RSA 208:3, 3-a, 3-b, and 3-c shall include a .357 Magnum, 10mm Automatic, .41 Remington, .44 Magnum, .45 Long Colt, .480 Ruger, [and] .50 Magnum, .45 ACP (Automatic Colt Pistol), .460 Rowland, .45 Super, .50 AE (Action Express), .357 SIG Sauer, .327 Federal Magnum, and .400 Corbon, provided that a pistol used for taking deer under this section shall be loaded with no more than [5] 6 rounds of ammunition at any time.

2 Effective Date. This act shall take effect 60 days after its passage.
