# STATEMENT OF INTENT

This bill updates the current statute (RSA 437:1) to allow for animal shelters to be housed in leased facilities. It also requires dogs, cats and ferrets transferred out of shelters to have a means of identification and to be vaccinated against rabies. It also stipulates that when dogs, cats or ferrets are brought into a shelter which have been abandoned or unclaimed, (as defined in RSA 437:18), that within 72 hours, every means of contacting the previous owner(s) is made in order for the animal to be reclaimed. Lastly, the bill requires that any dog, cat or ferret received from outside of the state of New Hampshire be required to have an official health certificate and meet quarantine requirements before being transferred to any person.

# **RE:** American Kennel Club Supports HB 247 Relative to Animal Shelter Facilities.

Dear Chairman Pearl and Members of the House Committee on Environment and Agriculture:

Founded in 1884, the American Kennel Club (AKC) is a recognized and trusted expert in canine health, breeding, and training. We represent over 5,100 dog clubs nationally, including 22 in New Hampshire, which represent thousands of responsible dog owners.

HB 247 makes clear that before re-homing any dog imported from outside New Hampshire, an animal shelter must provide an official health certificate, ensure the rabies vaccination is up to date, and comply with the state's quarantine requirements. The AKC strongly supports these provisions, as well as the bill's procedure for identifying and notifying the rightful owner of animals admitted to a shelter in a timely manner.

The inability to verify documentation has resulted in numerous incidents in which certifications of dogs imported into the country have been found by the United States' Centers for Disease Control and Prevention to be invalid or fraudulent. While the importation of dogs helps meet the demand for personal pets and working dogs, incidents involving sick dogs entering the country are alarming public health officials. They include well-documented cases of rabies, distemper, influenza, brucellosis, parasites, and other health threats, many of which can be passed to humans and other animals and many of which had been virtually eliminated in the United States.

Several recent incidents highlight these dangers. In 2019, a dog imported from Egypt and ending up at a Kansas rescue was determined to have rabies, but not before all 25 of its companions had been placed into foster care or adopted.<sup>1</sup> United States officials suspect that the Egyptian vaccination certificates were forged. Because it was the third incident of its type in recent years, the CDC responded by imposing a ban on all imports of dogs from Egypt.<sup>2</sup> In 2018, scientists at Cornell University's Animal Health Diagnostic Center identified a strain of Asian canine distemper virus never before reported in North America, which likely travelled with a dog

obtained at a Korean meat market.<sup>3</sup> A year before that, an epidemic of canine influenza was also traced to Asia.

In partnership with national experts such as the American Veterinary Medical Association, AKC has worked to file and pass the federal Healthy Dog Importation Act, which would streamline the federal oversight of canine imports to better protect animal and public health.

Chairman Howard Pearl and Members of the House Environment & Agriculture Committee -

I am writing on behalf of Dog Owners of the Granite State (D.O.G.S.) to thank you for your consideration of HB 249, *relative to animal shelter facilities*. On behalf of our membership of responsible local pet owners and breeders, D.O.G.S. offers full **support** of this bill.

Current law requires all animal shelter facilities to own the building and surrounding area where they house animals. We believe there is no reason that these facilities could not be leased and shelters allowed to operate their business.

HB 249 also writes into law that registered owners or agents will be contacted if an animal is found by an animal shelter facility. If the primary owner is unable to be reached, the secondary owner listed on a microchip must be contacted. This helps ensure that all owners of an animal are contacted so they can reclaim the animal. Most breeders of dogs and cats have microchips registered that include primary and secondary owners information. This helps prevent any animals they produce from being rehomed by a shelter or rescue, as they take great pride in each animal they produce and want to know where it is for its full life and ensure that home is appropriate.

Current law does not require animal shelter facilities to obtain health certificates on dogs, cats, or ferrets. This puts New Hampshire residents and their animals at risk of highly contagious diseases, especially with the increase in these animals coming from southern states and other countries where these diseases are more prevalent and may not have requirements for vaccination. The adjustment in HB 249 to require health certificates ensures that animals being imported into NH for resale have had a health exam by a veterinarian who is licensed to issue a health certificate. While this won't guarantee health, it is a step in the right direction.

Again, thank you for your consideration of HB 249. We hope that you will vote to **pass** this bill.

## ~House Environment and Agriculture Committee

I am writing in support of HB 249, particularly in reference to the additional protections added in Section 437:8 V. I am a hobby breeder with 40 years of experience, and the advent of the microchip as a form of positive identification has been an invaluable tool for the identification and recovery of any dog that may become lost. It is only logical that a shelter would want to provide that same protection for dogs being transferred out of their facility so that they may be easily rehomed with their adoptive family and not be returned as a burden to the shelter. Likewise, it is prudent public health policy to require that a shelter, as a vendor transferring dogs to the public, provide a dog that is properly vaccinated against rabies. I suspect that you may hear cries of "this is too expensive for us" that I suggest you ignore, as this is a part of their doing business. I maintain that the "adoption fees" that they collect on any transfer are adequate to fund their operation and provide a safely vaccinated animal.

The addition of a requirement to timely attempt to contact the owner of a dog that may be identified by its microchip is also in the best interest of both the owner of the lost dog and the shelter itself. Making a swift contact with the owner will reduce the time, and therefore expense, that a shelter would incur with a stray in their facility, and will be greatly appreciated by the owner stressing over the whereabouts of their lost dog. A win-win situation.

Finally, I strongly support the provisions included in 437:8 V. (f) regarding health certificates. Too many dogs are being imported into New Hampshire from the southern states, bringing with them diseases that are uncommon in our native dog population. Heartworm, parvovirus, leptospirosis and brucellosis are but a few of the known diseases that have been imported. Again it is sound public policy to require that the shelters respect the quarantine requirement, which at 48 hours is still too short, and that they be willing to attest to the health of a dog that they are transferring to the public by providing the new owner with a health certificate, same as is required to be provided by a private hobby breeder. Dear House Environment and Agriculture Committee Members,

Please support each bill I named in the "Subject of this email."

HB 250 is important because it helps reputable breeders to sell purebred and working dogs which are important to so many people. I feel the number really should be more, but 35 is a minimum. I feel requiring pet vendor licenses is yet another way the highly paid Humane Society lobbyists are chipping away at people's ability to buy a purebred dog whose personality is known due to their genetics. They should stop spending money in the legislature and instead, start supporting shelters to spay and neuter the dogs and cats that come in.

HB 249 should be supported because it states exemptions to NH's current requirements that health certificates accompany dogs to shelters within the state. Retired greyhounds are already up to date on shots and are healthy before entering the state. Also, Galgoes from Spain are carefully vetted by those adoption groups before flying them across the ocean. However none of these exemptions should involve so-called "rescues" coming in from Asian and Middle Eastern countries. Many of these dogs do carry disease, and we really shouldn't be transporting actual "meat dogs" of unknown temperament anyway. That said, a lot of these "meat trade dogs" are really purebreds, born in foreign puppy mills.... something the HSUS wants shut down here!

I am writing in support of HB 249, particularly in reference to the additional protections added in Section 437:8 V. I am a hobby breeder with 40 years of experience, and the advent of the microchip as a form of positive identification has been an invaluable tool for the identification and recovery of any dog that may become lost. It is only logical that a shelter would want to provide that same protection for dogs being transferred out of their facility so that they may be easily rehomed with their adoptive family and not be returned as a burden to the shelter. Likewise, it is prudent public health policy to require that a shelter, as a vendor transferring dogs to the public, provide a dog that is properly vaccinated against rabies. I suspect that you may hear cries of "this is too expensive for us" that I suggest you ignore, as this is a part of their doing business. I maintain that the "adoption fees" that they collect on any transfer are adequate to fund their operation and provide a safely vaccinated animal.

The addition of a requirement to timely attempt to contact the owner of a dog that may be identified by its microchip is also in the best interest of both the owner of the lost dog and the shelter itself. Making a swift contact with the owner will reduce the time, and therefore expense, that a shelter would incur with a stray in their facility, and will be greatly appreciated by the owner stressing over the whereabouts of their lost dog. A win-win situation.

Finally, I strongly support the provisions included in 437:8 V. (f) regarding health certificates. Too many dogs are being imported into New Hampshire from the southern states, bringing with them diseases that are uncommon in our native dog population. Heartworm, parvovirus, leptospirosis and brucellosis are but a few of the known diseases that have been imported. Again it is sound public policy to require that the shelters respect the quarantine requirement, which at 48 hours is still too short, and that they be willing to attest to the health of a dog that they are transferring to the public by providing the new owner with a health certificate, same as is required to be provided by a private hobby breeder. Speaking for public pounds (municipal housing of strays) this puts a monetary burden on the town to pay for the vaccine, not to mention the time constraints of setting up the appointment and transporting the animal. Pounds do not have veterinarians on site.

Also, this seems to contradict NH RSA 436:107 which states "complying with the rabies vaccination requirement of this subdivision within 72 hours of release." This places the responsibility and the payment on the owner.

# **RE:** American Kennel Club Supports HB 247 Relative to Animal Shelter Facilities.

Dear Chairman Pearl and Members of the House Committee on Environment and Agriculture:

Founded in 1884, the American Kennel Club (AKC) is a recognized and trusted expert in canine health, breeding, and training. We represent over 5,100 dog clubs nationally, including 22 in New Hampshire, which represent thousands of responsible dog owners.

HB 247 makes clear that before re-homing any dog imported from outside New Hampshire, an animal shelter must provide an official health certificate, ensure the rabies vaccination is up to date, and comply with the state's quarantine requirements. The AKC strongly supports these provisions, as well as the bill's procedure for identifying and notifying the rightful owner of animals admitted to a shelter in a timely manner.

The inability to verify documentation has resulted in numerous incidents in which certifications of dogs imported into the country have been found by the United States' Centers for Disease Control and Prevention to be invalid or fraudulent. While the importation of dogs helps meet the demand for personal pets and working dogs, incidents involving sick dogs entering the country are alarming public health officials. They include well-documented cases of rabies, distemper, influenza, brucellosis, parasites, and other health threats, many of which can be passed to humans and other animals and many of which had been virtually eliminated in the United States.

Several recent incidents highlight these dangers. In 2019, a dog imported from Egypt and ending up at a Kansas rescue was determined to have rabies, but not before all 25 of its companions had been placed into foster care or adopted.<sup>1</sup> United States officials suspect that the Egyptian vaccination certificates were forged. Because it was the third incident of its type in recent years, the CDC responded by imposing a ban on all imports of dogs from Egypt.<sup>2</sup> In 2018, scientists at Cornell University's Animal Health Diagnostic Center identified a strain of Asian canine distemper virus never before reported in North America, which likely travelled with a dog

obtained at a Korean meat market.<sup>3</sup> A year before that, an epidemic of canine influenza was also traced to Asia.

In partnership with national experts such as the American Veterinary Medical Association, AKC has worked to file and pass the federal Healthy Dog Importation Act, which would streamline the federal oversight of canine imports to better protect animal and public health.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 Definitions; Animal Shelter Facility. Amend RSA 437:1, I to read as follows:

I. "Animal shelter facility" means a facility, including the building and the immediate surrounding area, which is used to house or contain animals and which is owned *or leased*, operated and maintained by a duly incorporated humane society, animal welfare society, society for the prevention of cruelty to animals, or other nonprofit organization devoted to the welfare, protection and humane treatment of animals, and also a public pound for the housing of strays or a pound operated by any person, excluding veterinarians, who contracts with a municipality to serve that function.

9 2 Health Certificates for Dogs, Cats, and Ferrets; Animal Shelters. Amend RSA 437:8, V to read

10 as follows:

V. Animal shelter facilities, as defined in RSA 437:1, I, are exempt from the requirements of
 this section relative to transferring dogs, cats, and ferrets except that:

(a) All dogs, cats, or ferrets transferred out of an animal shelter facility shall
have a form of positive identification, including, but not limited to a tattoo, collar,
microchip, ear tag, or any other permanent form of identification approved by the
commissioner.

(b) All dogs, cats, or ferrets 3 months of age or older shall be vaccinated against
rabies in accordance with RSA 436:100 before transfer, if proof of rabies vaccination is not
available.

20 [(a)] (c) All animal shelter facilities shall have on premises a microchip scanner and 21 shall maintain a file of recognized pet retrieval agencies, including but not limited to national tattoo 22 or microchip registries.

[(b)] (d) Where an owner is not known, all animal shelter facilities shall inspect for tattoos, ear tags, or other permanent forms of positive identification and shall scan for a microchip upon admission of an unclaimed or abandoned animal as defined in RSA 437:18, IV and prior to transferring ownership of an unclaimed or abandoned animal. *Registered owners or agents shall be contacted as soon as possible, not to exceed 72 hours, and alerted that the animal has been taken in and is available to be reclaimed.* 

(e) If listed owners or agents cannot be located or refuse to reclaim possession of
 the animal, every effort shall be made to contact the secondary owner listed by microchip
 registries as soon as possible, not to exceed 72 hours.
