### STATEMENT OF INTENT

This bill proposes to modify the procedure for maintenance of an accurate vote checklist. It codifies what should be a regular process of removing invalid voters on the list such as deceased voters, duplicate names and people who have moved. The bill does this by directing the Secretary of State to inform town or city election officials about incomplete and partial voter records received by the Division of Vital Records when a voter dies. This will enable local officials to investigate and further ascertain if those names should be removed from the local checklist. It also directs the Division of Motor Vehicles, when they receive an address change from a licensed driver, to inform the election officials in that community of both the previous address and new address to facilitate maintenance of the checklist. Finally, this bill also directs the Secretary of State to maintain records in accordance with United States Postal Service standardized address system, aiding in the accuracy of records throughout all databases and reducing duplications. The majority of the committee believes this will help maintain checklist records on a regular basis and avoid a lot of maintenance that occurs on election day.

It directs the Secretary of State to inform town or city election officials about incomplete and partial voter records received by the division of vital records when a voter dies, enabling the local officials to investigate and further ascertain if those names should be removed from the local checklist. It directs the Division of Motor Vehicles to inform the election officials in a community of a both a voter's previous address and new address when an address change is made with the DMV.

This bill also directs the Secretary of State to maintain records in accordance with United States Postal Service standardization, aiding in the accuracy of records throughout all databases and reducing duplications.

Following are the minority reports for HB98 and HB 285. Representative Cote has reviewed and approved these reports. Thank you.

HB 285, relative to verification of voter checklists. Representative Paul R. Bergeron for the Minority.

HB 285 requires the secretary of state to notify city and town clerks of possible voter registration duplications and requires that the clerks conduct an undefined "investigation" to determine if an individual voted more than once in any election. City and town clerks do not have access to another community's voter history data. The secretary of state would be able to 1) identify possible voter registration duplication, and 2) determine if that individual voted more than once in any election, but that is not what HB285 proposes to do. HB 285 will come with a cost. It requires that the voter registration database maintain addresses in accordance with USPS Pub. 28. That publication requires the use of Postal Service ZIP+4 and will necessitate changes to the database to provide ZIP+4 search-and-populate field capabilities. The bill also directs DMV to notify city and town clerks of all address changes received for all NH citizens. HB285 does not include a fiscal note estimating costs that will be incurred by the secretary of state, the department of safety, or city and town clerks.

Good morning Madam Chair and Committee members.

My name is Representative David Love and I represent Rockingham County, district 6 I'm writing in support of HB285.

HB 285 is a step forward in the fight to insure voter integrity.

Three years ago, after the passing of my mother, I went to the Derry town hall ,death certificate in hand with the intention of quickly having my mother's name removed from the voting list.

I went to the Town Clerks window and proceeded to ask that she be removed.

I was told that they didn't do that ,nor did State law require them to do so .The women told me that my mothers name would have to "rotate out" and that after not voting in three consecutive elections, her name would be automatically removed.

I found this to be unacceptable.

I called the Secretary of State office and explained my dilemma.

They more or less told me that current law was vague and being misinterpreted.

HB 285 will clear up ,and specify the solution to this problem.

Thank you Madame Chairman. And thank you honorable members of the House Election Law Committee.

For the record I am Representative Erica Layon, Rockingham District 6, Derry, and I am the prime sponsor of HB285.

How many dead people are still on the checklist in your town? The Derry Supervisors of the Checklist removed over 40 dead voters this fall that weren't caught by the current system. How many slip through the cracks in your town or city?

This isn't through lack of effort from our Supervisors, just a culture of following the minimum prescription in the law. And I understand the WHY. But these good intentions lead to a bloated checklist – one with costs both in dollar figures and in the right to cast one whole vote.

HB 285 will step up that minimum standard, bringing it in line with towns like Londonderry which take a more proactive approach and actively use the notification system.

Voter disenfranchisement is a serious issue.

Our checklist protects the right of each inhabitant in the state to have an equal right to vote in any election, which is spelled out in the New Hampshire Constitution, Article 11 Part 1. Allowing duplicate or out of date names on the checklist violates this right because this dilutes the equality of each valid vote.

Many towns and cities follow the minimum requirements, concerned about the risk of potentially removing a valid voter. That is understandable, but that misses a larger point.

Leaving invalid voters on the checklist means that there is a honeypot for dishonest people, ..., and if this leads to fraud it will deny equal representation to the qualified voters!

This too is disenfranchisement.

HB285 provides the checks needed to protect this sacred right for each voter to cast one whole vote.

As you look through this bill, the cost of annually running the list through the National Change of Address system will come to mind. I'm sure the cost of more mailings will too.

I believe that we can and should invest in free and fair elections, however I believe that fixing our bloated checklists will save money too. As you are well aware, many voting procedures like the count of voting booths is proscribed based upon the number of voters on the checklist.

The 4,000 residents flagged as permanently moved from Derry in my check of 24,000 names on the checklist represents one sixth of the list! That is a lot of extra capacity at elections which comes at a real cost. Cleaning the checklist every 10 years is a safety valve, not a solution.

HB285 presents a solution to drive ongoing maintenance of the checklist, add standardization of addresses which is needed, and to check the list annually for permanent moves.

The cost of HB285 should be neutral.

The cost of NOT passing HB285 could mean that your vote only counts as <u>5/6<sup>th</sup></u> of a vote. I urge you to vote Ought to Pass.

Good Morning and thank you, Chair Griffin and committee members, for giving me opportunity to testify in support of HB285.

It is my strong belief that having an accurate voter registration list is necessary and critical to ensuring confidence with the voting public that only those who can legally vote in our state and federal elections do so.

This bill deals with the process of keeping the voter list up to date on a regular basis. Rep Layon has already provided the details so I just wanted to add some background information.

The committee should know that Londonderry's Town Clerk and the Supervisor of the Checklist work very well together to upkeep the voter list. Rep Layon and I met with Ms. Kirsten Hildonen, Londonderry's Supervisor of the Checklist and discussed the practices used. HB285 reflects the best practices from that discussion and others that I feel can be codified for statewide use.

I do not know what processes other towns use and to be sure, this is not a panacea, but I believe these modest additions to the current law will form a solid foundation from which even more improvements can develop.

I know that Londonderry's bipartisan voter checklist team works diligently and frequently with our town clerk to update the list. They are in full support of this bill. It is my hope the committee finds this bill as a positive step for others to follow and votes Ought to Pass.

### STATE OF NEW HAMPSHIRE

AN ACT

relative to verification of voter checklists.

Be it Enacted by the Senate and House of Representatives in General Court convened:

- 1 Vital Records Administration; Secretary of State; Duties. Amend RSA 5-C:4, IV to read as follows:
- IV. The secretary of state shall compare information contained on each death record received by the division of vital records with information contained in the statewide centralized voter registration database and submit to the state registrar a list of every city or town that has a registered voter matching the decedent's information. Where there is not a full match of name, date of birth, and residence, the secretary of state shall provide information of partial matches for further investigation by the town or city pursuant to paragraph V.
- 2 Division of Motor Vehicles; Change of Address; Notification. Amend RSA 261:55, I to read as follows:
- I. Whenever any person after making application for or obtaining the registration of a vehicle shall move from the address or change the postal address named in the application or shown on a registration certificate or certificate of title, such person shall within 30 days thereafter notify the division in writing of his or her old and new address. The division shall then inform both the clerk in the town or city in which the new address is located and the clerk in the town or city in which the previous address was located of the change to facilitate periodic maintenance and verification of checklists pursuant to RSA 654:36-b.
- 3 Periodic Maintenance and Verification of Checklists; Reports of Death. Amend RSA 654:37 to read as follows:

654:37 Reports of Death. Whenever there is filed in the office of the clerk an official notice of the death of any person or persons of the age of 18 years or over or the clerk receives notice of a death record of such person or persons under RSA 5-C:4, V with a full match, the town or city clerk shall notify the supervisors of the checklist of said deaths by submitting a notice of same to the supervisors at their next regular meeting. For reports under RSA 5-C:4, V with a possible match, the city or town clerk shall look for an official notice of death and if available shall proceed as described in this section. If there is no official verification, the city or town clerk shall follow the procedures in RSA 654:37-a. Upon receipt of such notice, the supervisors shall examine the checklist; and, if the name of said deceased person appears thereon, it shall be removed. The notice shall be retained in accordance with RSA 33-A:3-a. Any supervisor who shall neglect or refuse to erase the name of such deceased voter from the checklist after receiving such notice from the town or city clerk shall be guilty of a violation.

4 Centralized Voter Registration Database; Address Maintenance. Amend RSA 654:45, I to read as follows:

- I.(a) The secretary of state is authorized to plan, develop, equip, establish, site, and maintain a statewide centralized voter registration database and communications system, hereinafter referred to as the voter database, connecting users throughout the state. The voter database shall include the current information on the voter registration forms, the accepted absentee ballot applications, the voter checklists, and voter actions as recorded on the marked checklist maintained by each city, ward, and town in the state. The database shall maintain addresses in accordance with United States Postal Service standardized addresses as described in the current USPS Publication 28.
- (b) The secretary of state shall provide for verification that voters sharing a place and date of birth, along with a substantially similar name to include nicknames or likely maiden/married name changes, are unique voters. Should any voter appear to be a duplicate registration, information shall be forwarded to the clerk of the city or town where registered for investigation. Such clerks shall notify the secretary of state of the result of such investigation, and should the investigation show that a single individual voted more than once in any election such information shall be forwarded to the attorney general for further investigation or prosecution.
- 5 New Subparagraph; Centralized Voter Registration Database; Address Verification. Amend RSA 654:45, IV by inserting after subparagraph (c) the following new subparagraph:
- (d) Beginning July 1, 2022, the secretary of state shall annually cause voter records to be checked with the United States Postal Service for changes of address. All records identified as moving shall be provided to the city or town clerk for verification pursuant to RSA 654:39, III.
- 6 New Paragraph; Inventory of Property Transfers. Amend RSA 74:18 by inserting after paragraph V the following new paragraph:
- VI. Municipalities receiving inventories pursuant to this section shall forward the buyer's and seller's names and post transaction addresses to the supervisor of the checklist in such municipalities to facilitate periodic maintenance of the voter checklist.
  - 7 Effective Date. This act shall take effect 60 days after its passage.
